SHORT BIOGRAPHY

Professor Belinda Bozzoli completed her undergraduate education in Johannesburg and continued with her MA and DPhil in African Studies at the University of Sussex. She worked at first as a teacher and journalist, but later started her academic career as a junior lecturer at the University of the Witwatersrand, where she became a Professor in the Department of Sociology. Professor Bozzoli is the author of three single-authored, internationally published books and editor or co-editor of a further four. She also published 26 articles. In 2006 she was awarded an A-rating from the National Research Foundation, making her first sociologist to be honored in this way. She became Deputy Vice-Chancellor of the University of the Witwatersrand in 2002 and was also Senior Adviser to the Vice-Chancellor working on a major research development project for the University. At present Professor Belinda Bozzoli is the DA Shadow Minister for Higher Education and Training.
