Abstract:	The National Medical and Dental Association (NAMDA), an organised body of health care professionals, was established in 1982 to directly counter the effects of apartheid policies on the provision of health care services in South Africa. Records from affiliated or associated groups are also included in the collection, including: the Organisation for Appropriate Social Services in Southern Africa (OASSSA), the Health Workers' Association (HWA), the National Emergency Services Group (NESG), the National Progressive Primary Health Care Network (NPPHCN), the South African Health and Social Services Organisation (SAHSSO), the National Health and Unity Forum (NHUF), the National Education, Health and Allied Workers' Union (NEHAWU), and the South African Health Workers' Congress (SAHWCO).

Introduction

National Medical and Dental Association (NAMDA)

Health care in South Africa during the apartheid years was characterised by the subordination of medical and human rights commitments to racial and political ideologies. This subordination was effected by the compliance of professional health organisations to apartheid policies, as evidenced, for example, by segregated facilities, inequitable treatment and, in some cases, direct involvement in human rights abuses. Chief amongst these professional health care bodies were the various Departments of Health and the Medical Association of South Africa (MASA).

While many health care professionals opposed apartheid on a personal level, it was not until December 1982 that an organised body of health care professionals was established to directly counter the effects of apartheid policies on the provision of health care services in South Africa. On 5 December 1982, 52 physicians formed the National Medical and Dental Association (NAMDA). In the decade to follow, NAMDA members faced substantial opposition from the structures they opposed. Members were harassed, arrested, and detained without trial by security police; their homes were bombed and their offices raided. Many received death threats. Throughout its existence, NAMDA was denigrated and denounced by MASA and other medical organisations.

Amongst the factors that led to the establishment of this new Association were the failure of MASA (for example, MASA's failure to act against doctors implicated in the death of Steve Biko in 1977), the need for a forum for progressive health care practitioners to discuss wider issues relating to health, the commitment to work for democratic change in health care structures, services and education, the necessity to take up people's health issues and finally, to document and expose the effects of apartheid policies on health both locally and abroad.

Throughout its history, NAMDA worked closely with other progressive health and human rights organisations. NAMDA focused its efforts on the following:

Care of former political prisoners and detainees and their families

Provision of emergency medical care for victims of state-orchestrated violence

Documentation of torture and ill-treatment of detainees via standardised interviews with recently released detainees
Research and dissemination of information and initiatives relating to health issues and health policy
International campaigns highlighting human rights abuses in the health sector and other social arenas in South Africa
Campaigns to exclude MASA and other professional bodies from participating in international medical associations
Special programmes such as attending to the health needs of returning exiles
In 1992 NAMDA merged with other progressive health organisations to form the South African Health and Social Services Organisation (SAHSSO). NAMDA's decade of work is an important resource in the on-going restructuring of health care in post-apartheid South Africa.
