What you need to do is to come to a
meeting at ~~the~~ Mathale hall No 6, Annadale
Sophiatown Johannesburg. On Sunday 13th
May 1951. at 9 O'clock in the morning
before the Minister call upon you to
surrender your Title Deeds

in Order to ~~enable~~ enable him to sell
 your property to a European for the profit,
 and these profits shall buy your neighbour's
 property. ~~The~~ The practice of this game
 shall continue until all the African
 owned properties are bought out by Euro-
 peans, and that shall be the end of
 the black spots in the Union of South
 Africa.

Therefore come all ye Africans,
 come and lodge your objections against
 the removal of ~~all~~ all so called Black
 spots in the Union.
 For the peace and happiness of the people
 irrespective of colour Race or Creed in
 the Union. Speakers shall be delegates
 from various parts of the Union inclu-
 ding B. A. B. J. Union.
