Moretele and Maloka said the province is at the present been administered by the working committee and the committee should share the paying of the rent. Mr. Thema said the question of payment could only be discussed only when we know what money Province has.

## OFFICE CLERK

The President mentioned that there was no man in office as yet, and he went on to say he had someone in mind, but the man he had in mind might only be known to, whereas, it would be better if we could get someone who is known to us all. Mr. Thema referring to the suggestions made previously said we spoke of a clerk only and not clerk and organiser. Mr. Chuene spoke of advertising the post. The president said in the office we need someone who can give some information and take complaints from the people. He further stated that he could be paid £8.0.0. per month. The Committee felt that it would be in the interest of the Congress to have a man who would act as clerk and organiser. This question was postponed for further discussion, for Monday the 3rd January 1944. The meeting adjourned at 5.45 p.m.

MR. Maloka refunded the sum of £2.5.0. money paid to him as delegates to the conference. He also reported that he was unable to go as he was sick.
