Please treat this matter urgently so that our arrangements can be finalized before the next cricket season which starts on the 1st October 1988.



and

THE TRANSVAAL CRICKET BOARD

(hereinater referred to as "the Board")

represented herein by Manager Istaic Manager in his capacity as I RESIDENT he being duly authorised hereto by virtue of a resolution taken by the Board at Tohannesses, on 30 Manager 1976 a certified copy of which is attached hereto.

AND WHEREAS the Council has agreed to let to the Board and the Cricket Board has agreed to hire from the City Council the Lenasia Cricket Stadium and the Varachia clubhouse situated on a portion of Erf 2606, Lenasia Ext. 1 (hereinafter referred to as "the Property").

WITNESS:

1.

The Council hereby lets to the Board which hires from the Council in terms of Section 79(10) of the Local Government Ordinance, 1939, as amended, the use of the Property during cricket season from 1 September to 31 March each year during the currency of this agreement.

Notwithstanding the date of signature hereof, this lease shall be deemed to have commenced on 1 September 1987 and shall continue for a period of 5 (five) years.

3.

The control, administration and organisation of the amenities and facilities comprising the Property shall be vested in the Board.

4.

The Board shall pay to the Council:

- (a) A rental of R3600 per annum escalating by 12,5% per annum, compounded, payable yearly in advance without deduction on or before each anniversary of this lease; the first payment to be made on signature hereof.
- (b) An annual maintenance charge of 1,5% (one and a half per cent) of the value, as determined by the City Valuer from time to time, of the buildings and other improvements on the Property provided by the Council or the Board, payable in two equal instalments, each payable half yearly in advance. The first payment to be made within 30 (thirty) days of submission of an account to the Board.
- (c) The Council's tariff fees and charges for all water, electricity, sanitation, refuse removal and other services which the Council may render from time to time to the Property.

The Board shall pay the rent and charges referred to in Class then due, to the Council at the office of the City Treasurer (Land Branch), 3rd Floor, Civic Centre, Braamfontein, Johannesburg as the City Treasurer may appoint time to time, free of exchange and other deductions.

6.

The Property is let to the Board solely for the purpose of a cricketing, sports and social centre, and the Board shall not use any portion of the Property for any other purpose without the prior consent of the Council.

7.

The Board shall not make any improvements, alterations or additions to the Property or any of the immovable improvements forming part of the Property without the prior written consent of the Council nor make any improvements, alterations or additions to the sportsfields or any gardens or pathways without the prior consent of the Council's Director of Housing ("the Director"), which consent shall not be unreasonably withheld.

8.

(a) The Board shall:

(i) keep the Property in a clean and tidy condition to the satisfaction of the Director or his authorised representative and
be responsible for the marking of the sportsgrounds on the
Property;

- (ii) effect repairs or make good any damage caused by any of the Board's employees, members, guests or other persons whom it has permitted to use the Property or any portion thereof or caused by the unlawful, or forcible entry of any person whatsoever;
- (iii) maintain in good order and repair all keys, locks, glass, window panes, water taps, wash basins, electrical and other equipment, and sanitary and other fittings and effect repairs thereto as and where necessary and replace and reinstall any items which may be stolen, missing or broken;
- (iv) maintain the drains and water pipes free from obstruction;
- (v) undertake all other repairs of the Property necessitated by the negligent or wilful action of any person.
- (b) Subject to the provisions of (a) above, the Council shall maintain the Property insofar as finances permit.

9.

In the event of the non-payment of the rent and maintenance charges, or in the event of the Board committing a breach of the terms and conditions of this lease, then notwithstanding the fact that the Council may have overlooked any breach by the Board on one or more previous occasions, the Council shall have the right, after having given the 21 (twenty one) days written notice requiring the Board to effect payment and/or to remedy the breach and the Board failing to do so within the notice period, to cancel this lease.

10.

The Board hereby indemnifies and holds the Council harmless in respect of all loss, costs and damage that may in any way be incurred by the

Council, and in respect of all claims which may be made against the Council by third parties, by reason of or in any way connected with or arising out of this lease or the exercise by the Board of its rights under this lease, as also in respect of legal or other expenses on the attorney and client scale that may be incurred by the Council in examining, resisting or settling any such claims.

11.

The Board shall advise the Director from time to time of the names and addresses of its Chairman and Secretary.

12.

The Board shall not keep or do or permit to be kept or done on the Property anything which, in terms of any of the conditions of any fire or other insurance policy or cover held from time to time by the Council in respect of the Property, may not be kept or done thereon or which will or may increase the rate of premium payable in respect of any such fire or other insurance policy, without the Council's prior written consent.

13.

The Board :

- (a) may apply for a liquor licence in its own name and if granted, operate as a holder of a liquor licence only for the purposes of a sport and social club in accordance with the provisions of the Liquor Act, 1977, as amended.
- THE // (b) shall be entitled to allow advertising around the inside of the sports stadium on the Property on condition that the Board shall

pay the Council 50% (fifty per cent) of the total revenue accruing directly, or indirectly through sponsorship, to the Board from the granting of advertising rights to third parties sub-letting of the advertising rights after the deduction of any advertising commission payable to advertising agencies in respect of such advertising. The Board shall, together with the payment provide the Council with a detailed schedule and documentary proof to the satisfaction of the Council's City Treasurer indicating what advertising rights were sub-let or granted to third parties, the income derived therefrom and the advertising commission paid to an The Council shall be entitled to advertising agency, if any. obtain from the Board the name of the advertising agency concerned and of the client to whom advertising rights are sub-let or granted to satisfy itself that the correct amount is being determined and paid.

- (c) shall not cede, transfer or assign any of its rights under this lease whether in whole or in part or sublet the Property or any portion thereof without the prior consent of the Council.
- (d) shall not do or permit to be done on the Property anything which is or may become injurious to public health or which may be or become a nuisance to any owner or occupier of property in the neighbourhood of the Property;
- (e) shall comply with the provisions of the Council's by-laws and town planning scheme, the National Building Regulations and the conditions of title under which the Property is held by the Council, and the Board acknowledges that the Property is let subject to such conditions of title.

- (a) The Council shall at all times be entitled to use the Property or portion thereof for any municipal purposes or any other purpose incidental thereto without payment of any compensation whatsoever: Provided however, that the Council shall not by so doing interfere with the reasonable enjoyment by the Board of the Property for the purposes contemplated hereunder except where such interference is reasonably necessary for construction, laying or maintenance of any gas or electric main, water or sewerage pipes or drains or any other type of service rendered by the Council.
- (b) The Council shall retain the right to grant the use of the Property to Welfare or Religious organisations approved by the Director on such days as agreed upon by the Director and the Board; provided that the number of days on which the use is so granted shall not exceed two (2) days per year and that the Board shall not be entitled to any compensation for the use thereof.

On 1 July 1983 the Management Committee requested the Director, Housing Department, to negotiate with the Johannesburg Cricket Council and creditors on the possibility of the Council making a grant-in-aid of R55 000 to the Johannesburg Cricket Council on condition that the amount is paid to the creditors concerned. The creditors would also be required to accept the suggested amounts payable in January 1984.

The Johannesburg Cricket Council would, in addition, be required to pay to the Council an annual maintenance contribution of 1,5% of the value of the building as well as 5% of all receipts for the hiring of the stadium facilities.

All creditors have subsequently been interviewed by the Director, Housing Department, and the City Treasurer and have accepted the suggested payment payable in January 1984.

The Johannesburg Cricket Council has confirmed in writing that it will be prepared to sign an agreement accepting the conditions as set out above and that Messrs M.S. Mayet, E. Minty and L.A. Nosarka will sign the amended lease on behalf of the Johannesburg Cricket Council.

IT IS RECOMMENDED

- 1 That in terms of Section 79(16)(a)(iv) of the Local Government Ordinance, 1939, a grant-in-aid of R55 000 be made to the Johannesburg Cricket Council on the conditions as set out in this item.
- 2 That, subject to the adoption of paragraph 1 above, the City Treasure be authorised to effect payment of the grant-in-aid by paying creditors of the Johannesburg Cricket Council, on the latter's behalf, up to the amount of the grant-in-aid, and by paying any balance of such amount remaining after the creditors have been satisfied, to the said Cricket Council.

As we have been denied the use of the Lenasia Stadium for our interprovincial fixtures. We have decided that the Newlands One ground is the only other alternative. Our first interprovincial match against Natal takes place on the 26,27, and 28th November,1977. In this regard we request the following:

1) The dressing room facilities (eg showers) be in good condition.

- 2) A groundsman be present throughout the 3 days to ensure the rolling of the pitch, marking of the crease and the boundry at regular intervals.
- 3) Covers be provided.
- 4) A scoreboard be erected.
- 5) Seating facilities provided.
- 6) The grass be cut and pitch prepared on the 25th November, 1977. The above is essential because of the status of the match and because the Newlands One ground is devoid of all essential facilities.

At the same time I wish to inform you that our other interprovincial matches will be played at the same venue on December 26, 27, 28 and March 4, 5 and 6th.

REQUEST FOR A CRICKET FIELD: TRANSVAAL CRICKET COUNCIL

As you are aware this Department and the Transvaal Cricket Council have repeatedly requested your Board to indicate whether it will be possible to allocate a cricket field in the Coloured suburbs to the Transvaal Cricket Council, but unfortunately your Board has not officially responded to these appeals.

This Department has in the interim undertaken an investigation of your fixtures and the number of matches which have in fact taken place at the various venues appearing on your fixture lists.

This investigation has clearly revealed that the cricket fields are not being exploited to the full potential and, in the circumstances, it is felt that your Board will not be prejudiced if a cricket field is made available to the Transvaal Cricket Council.

As discussed with Mr Peffer on 23 January 1979 it is considered that the Newlands No. 2 gravel field previously used by the Transvaal Cricket Council, should be made available to the latter body again with effect from 1 February 1979.

However, if your Board would prefer a field other than Newlands No. 2 to be made available to the Transvaal Cricket Council, it would be appreciated if you will advise me immediately.

I have taken the above decision after careful perusal of your fixtures and I am sure that your Board will not be inconvenienced in this regard.

I would however re-iterate that my door is always open for discussions in the event of special arrangements for inter-provincial tournaments, etc.

Your co-operation in this matter will be greatly appreciated.

In connection with your letter dated 23,1.79 I wish to relpy as follows; A letter (copy enclosed) was sent to your department, turning down the Transvaal Cricket Council's request for a ground in the "coloured suburbs".

The grounds are not exploited to the full potential because:

- 1. Overnight rain makes grounds unavailiable and unplayable especially Bosmont Turf and Western Oval.
- 2. Because local teams are compelled to fulfill "away" fixtures a ground is normally vacant on few Sundays.
- 3. Mis-information furnished from the Union Stadium ground staff has resulted in games being cancelled.

As early as the 21 January 1979 we wish to quote the following example:
Our team from Rustenburg were fixtured to play Protea at Bosmont Gravel. Due
to heavy rain on Friday and Saturday the Rustenburg team phoned Mr Ritsons
residence on Saturday (20.1.79) evening to enquire if the ground was playable.
A Mr. Hendrickse answered and informed them that all the grounds were unplayable due to rain.

Rustenburg inturn contacted our record clerk Mr. A. Hassan. to convey the message, who inturn phoned Mr, Ritsons residence and was also told the same by Mr. Hendrickse. Mr Hassan requested Mr. Hendrickse to ask Mr Ritson to urgently phone him. After 45minutes Mr Hendrickse phoned back to say that he had just met Mr. Ritson who confirmed that all the grounds were unplayable.

Mr. A. Hassan thereafter informed our "outside" teams i.e. Ermelo, Azads, Azads"A", Potchefstroom and Rustenburg not to journey to Johannesburg on Sumday 21 January 1979. Mr Hassan could not contact Vaal United, Vaal United "B", Crescents and Zulfikaars that night.

The next morning i.e. Sunday 21 January 1979 at 6.30am Mr Hassan after seeing bright sunshine once again phoned Mr. Ritsons residence and spoke to Mr. Lewis. Mr. Lewis informed Mr. Hassan that they were on their way to prepare the grounds for play. Mr Hassan explained Mr. Lewis of what had transpired the Saturday night(20.1.79). Mr. Hassan then asked Mr. Lewis to prepare only the Newlands Turf and Newlands Gravel because the other teams were asked not to travel to Johannesburg. This example speaks for itself.

- 4. Whenever Transvaal is engaged to play an inter-provicial fixture at home no club fixtures are drawn. This policy of the board was explained at the ground allocations meeting.
- 5. Whenever Transveal in engaged in an away Inter-Frovincial fixture clubs that have Three or more players representing Transvaal, the club is automatically excluded from fixtures for that particular Sunday, not withstanding what the fixture list shows.

We therefore whish to advise you that all grounds are and will be needed by our Board.

It would be regretted if your department unilaterally decide to take away any ground allocated to us by the Johannesburg Coloured Management Committee.

Our next inter-provicial fixture will be against Eastern Province at Newlands Turf on 17/18/19 February 1979 and all our requests as per our letter dated 23/10/78 applies. Please take note that on March 17/18/19 Transvaal play Western Province at Potchefstroom.

I refer to your letter dated 23rd. January 1979 to which a reply was sent on Friday 2nd. February. Certain developments which took place on Sunday 4th. February 1979 led to a discussion at our council meeting held on Monday night the 5th. of February and I have been instructed to write a further reply to your letter as follows:

- l. Without waiting for a reply to the letter of the 23rd. January already referred to, your department allocated Newlands No. 2 gravel field to the Transvaal Cricket Council and as a result two teams from the Cricket Council as well as two teams from our Board turned up for their fixtures. Our two clubs were Protea and Lichtenburg. There was a heated argument and violence was narrowly averted. Your department must shoulder the blame for the unpleasantness which could so easily have led to bloodshed. Eventually the two teams from the Cricket Council were allowed to make use of the pitch. But this by no means signifies that we have now granted them the use of the field.
 - 2. I now refer to the enclosed copy of a letter received from our affiliate, Protea, in which they accuse us of maladministration and claim an amount of R40.00 for lunches which they prepared for the visiting Lichtenburg team. We informed the club of the circumstances and they agreed that the claim should be sent to your division which we are, in fact, now doing. We are awaiting a claim for travelling expenses from Lichtenburg and this will also be sent on to you.
 - 3. We have previously alleged that the Coloured and Asian Division gave the impression of acting as agents of the Transvaal Cricket Council(see enclosed copy of letter) Events now seem to indicate that there was some truth in our charge.
 - 4. I now refer to the enclosed copy of a letter received from our club, Crescents. The letter refers to the "atrocious" condition of the Riverlea pitch. We have instructed the club to report back to us as regards medical expense and loss of salary, etc. This claim will in turn be submitted to you. We wish to point out that we would not make this ground if your information re ground usage was correct.

We have been refused permission to make use of the Lenasia Stadium for our inter-provincial matches on the grounds that the stadium had already been allocated to the Cricket Council but our grounds are re-allocated in mid-season.

We shall continue drawing fixtures for all the grounds allocated to us in spite of your division's action in unilaterally granting use of the pitch to the Cricket Council.
