Dear Mr. Hepple,

With reference to your letter of 12 February 1970, in which you inquired about the payment of the fee due you as a consultant on the Southern Africa report, may I say, first of all, how sorry I was to learn of the inconvenience you have been caused by the bank's late payment to your account.

As you noted, the United Nations had authorized the payment to be made on 16 December 1969, and at our end there was no reason to expect that it would not go through promptly. Upon receipt of your letter, however, our Controller's Office was asked to pursue the matter with the First National City Bank in New York. This they did, and after considerable investigation on its part, the bank reported yesterday that the transfer of funds from New York was effected on 12 January, and that it nevertheless took another month for the money to be credited to your account with Barclays.

I trust you have received notice of the completed transaction by this time, as it would appear that the amount was actually credited by 11 February. Appropriate representations have been made to the First National City Bank, and I can only express regret at the long delay.
