I hesitate at the moment to give my full attention to Mr. Muthwa whose papers I return. Wouldn't Nadine give him a hand? She doesn't do anything but write, does she? I cannot tell from the enclosures whether Mr. Muthwa's stuff is good or not.

There is only one way in which an established writer can help a beginner, assuming, that is, that he is not able to <u>teach</u> the beginner or to give him more than the most general advice. This way is to write to his publisher and say, "will you read this fellow's stuff and give him an opinion?" My publisher always does it and I think Nadine's would do it too.

Glad to hear of the success of the Lang drive. This is our first effort of this magnitude.

I am trying to write but I shall have to go away in the end. Confidentially, Pat has put us in another crisis; he refused to place a COD advert in CONTACT, advertising a Treason Trial meeting. He completely fails to see that this strikes at the very heart of the Multiracial Conference, and at the Party policy of cooperation on agreed objectives. What will he say at Accra? Launch a full-scale attack on Communists in Africa, and on all ANC's for being duped by them?
