XVII. The travelling, board and lodging expenses incurred by the following Officers - President, Senior Vice President, General Secretary, Organising Secretary, Treasurer in connection with their attending the Annual General Conference shall be paid from the General Fund of the Organistion.

DUTY OF GENERAL EXECUTIVE.

XVIII. The General Executive Shall:

(a) Attend to the collection and disbursement of all moneys under control.

(b) Hold supervision over all Branches and subordinate Commit,

(c) Call Conference together annually, and before its

dissolution appoint the venue for its next meeting.

(d) Upon the written request of the majority of the Branches the General Executive shall call an extraordinary conference within thirty days.

The General Executive shall grant permission for the

formation of new Branches.

(f) It shall also attend to the general advancement of the Organisation.

XIX. Each Branch shall render annually a Report of its transactions to the General Executive two months before the Annual General Conference, failing which a fine of two shillings and six pence shall be imposed.

REPRESENTATION AT CONFERENCE.

Branches shall be entitled to representation at General
Conference on the following basis:-

EXPULSION OF MEMBERS.

XX1. (a) If the General Conference is of opinion that any Officer or member has succumbed to influences detrimental or hostile to the general welfare of the Organisation, it may be resolution suspend or discharge such Officer from office, or entirely deprive such member or Officer from the privileges of membership.

(b) Any member dealt with under the above clause has the right of appeal as laid down in clause X11.

XXII. Branch shall have the right to give concerts, etc for the purpose of raising funds, provided that a certified statement of all receipts and expenditure be submitted to the General Executive.

XXIII. That each Branch may give a concert, tea-meeting, social or other function during the month of February in each year and that the proceeds of such functions be donated to the General Fund of the Organisation.

SPECIAL FUNDS/.....

- 6 -SPECIAL FUNDS.

That an amount equivalent to 15% be deducted from the gross amounts raised in connection with any special fund. Such a percentage to be credited to the General Fund for administrative

PURCHASING OF LANDED PROPERTY.

Branches are hereby empowered to purchase and hold XXV. (a) landed property in their names.

That all properties shall be vested in the name of not

more than three (3) Trustees.

- No Branch shall be permitted to purchase any landed property without the sanction of the General Executive at Headquarters or of the Conference.
- (d) No landed property owned by any Branch shall be mortgaged or sold or in any way alienated without the consent of the General Executive at Headquarters or of the Conference.
- (e) In the event of a Branch ceasing to exist for a period of twelve months, the property shall become the property of the A African Peoples' Organisation in general, and its final disposal & shall be left in the hands of Conference.
 - (f) Whenever any Branch disposes of its property, the proceeds of such a sale shall be handed to the National Executive who shall hold same in trust for the Branch, and such proceeds shall be utilised for the purpose of another property or such other purpose as agreed upon by the General , Conference.

FINANCE.

- XXVI. (a) That all moneys received be banked in the name of the African Peoples' Organisation. The names of the President, Treasurer and one Trustee should always appear on cheques.

 (b) On no account may moneys be spent without the consent of

the General Executive.

- No moneys exceeding £5 shall be in possession of the Treasurer for more than 48 hours.
- A bond of fidelity to be taken out by the Treasurer. The Treasurer shall be required to present an Annual (d) (e) Balance Sheet duly audited at the Annual General Conference.

ECONOMIC DEVELOPMENT.

The A.P.O. is committed to a policy of promoting the economic development of the Coloured people by:-

Economic thrift and business enterprise.

(a) (b) Sponsoring the establishment of Building Societies, Insurance Companies, Co-operative Societies, etc.,
(c) A fund shall be established for these purposes.

ARREARS. XXVIII. Any member failing to pay his Annual Subscription etc., in accordance with the Bye Laws of & his Branch, shall not be permitted to join any other Branch, until he has financially cleared himself with the Branch he is leaving.

RESOLUTIONS/....

RESOLUTIONS.

xxix. All Resolutions for consideration of the General Conference shall be forwared at least thirty days before Conference assembles, and it shall be the duty of the General Secretary to frame and Agenda paper, and send same to all Branches a fortnight before Conference assembles.

AMENDMENTS TO CONSTITUTION.

xxx. Any Amendments or Alterations to this Constitution shall be submitted in writing to the General Secretary, at least one month before the date of the General Conference, who on receipt of Such notice shall send copies to all Branches for consideration.
