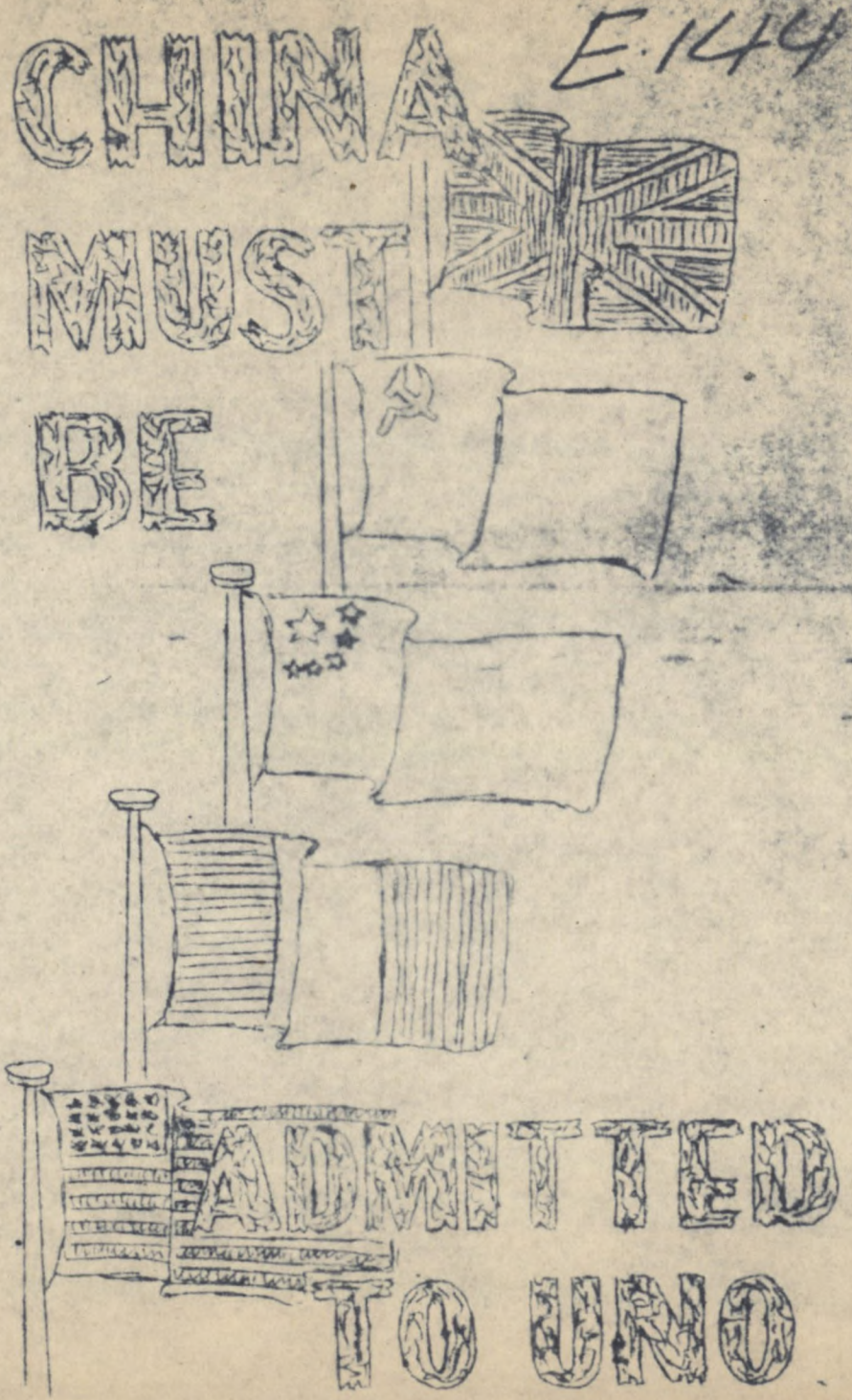

According to the new census, there are over six hundred million people in China today.

To these people the existance of their country and their present Government is real enough.

Yet this populous country, occupying an important position in world affairs, is not 'recognised' by the United Nations Organisation, which refuses admission to China.

The kind of Government a country has obviously should not affect the issue of admission to the United Nations. After all, America and the Soviet Union, with widely different systems of Government and economies, are both - and rightly - members of the United Nations.

But there are additional, very potent reasons, why China should be admitted to UNO - and admitted now!

Firstly - UNO cannot be effective. China is a major power, (with one of the biggest populations in the world) and holds a significant position in the world today. For its own sake, to be an effective working body, UNO must admit China.

Secondly - the outstanding problems must be settled by UNO in the near

future all involve China. They are the question of peace in Korea, of security in Asia, of disarmament and of banning of weapons of mass destruction; and the question of relaxation of world tension. EACH OF THESE QUESTIONS INVOLVE A SETTLEMENT BETWEEN THE MAJOR POWERS - including China.

Fourthly - the recognition and admission of China would pave the way to a Pact of Peace between the five major Powers - ardently desired and urgently needed by the world.

Fifthly - the cause of peace, of security and of the right of self-determination of nations will be furthered by the admission of China.

The Geneva Conference has shown the effect that China can have on peaceful negotiations.

Add your voice now to those throughout the world demanding the admission of the Peoples' Republic of China to the United Nations.
