



MY dear Quintin,

I hope that in my capacity as Vice President you do not mind my referring matters to you from time to time .

It is more than probabale that this has already been done but I should be most grateful to you if you could kindly place before the Action Committee my suggestion that an immediateletter be written to the Minister of Bantu Administration and Development.

It hink we should use this chance of expressing our appreciation to him for postponing the date upon which the carry ing of passes by African women will become obligatory - and also indicate that we believe that the reasons given will be appreciated.

But at the same time I think we should put before him once again the strong views of both African men and women - the dangers from constantly being confronted by the police, the potential danger to which it exposes all girls and women, etc etc. in flux Control ck.

I need not elaborate the points- they are sufficiently well known . $B^U t$ to leave this important concession without either appreciating it or indicating the potential difft ulties and dangers of the situation would be extremely unwise .

I have just drafted a long and careful letter (In my capacity as Adviser on African Affairs) which I am sending to the N.C.W. Board of Officers and I do hope that they will send the letter to the Minister.

It was with real appreciation that we in the Institute read of your decision to postpone from December 1st, 1960, the date from which African women must carry reference books and to make it coincide with the date on which White persons must be in possession of identity cards. This will do much to relieve the tension which December 1st might have unduly created, and we are grateful.

On previous occasions we have suggested to you some of the administrative and other difficulties which the police and others will meet in the administration of passes for women, and how inflammable hard application of the law could make the racial situation. I would respectfully draw your attention to my letter of November 11th, 1958.

We note that you speak of "reference books". Would it be possible for your Department to consider the issue of "identity cards" only and not "reference books". Cards similar to those carried by Europeans would take some of the sting out of the idea of carrying a pass and should be administratively feasible considering that African women have not carried an identification document in the past. We shall be grateful if you would consider this.

We have also noted with thankfulness references to what has been named a "new deal" for Non-Europeans, and to the completion by your own Department of a revision of legislation affecting Africans in White areas.

I realise that it has not been the practice of your government to circulate for comment draft legislation, at least to the Institute, before tabling in Parliament, but we would be grateful if you would consider doing so for unpublished comment to be submitted by the Institute to your Department before the introduction of the bill or bills.

I believe that a great many people both here and overseas are awaiting with anxious expectation the new developments which various ministerial speeches have indicated and we all most sincerely hope that the republic will be ushered in with major positive steps which will build faith and hope and positive response throughout the country.


