All Non-Europeans will be welcome at the various demonstrations and meetings set out on the programme.

A special appeal is made to you to publicise this programme amongst all members of the Eurafrican community.

No charges will be made except for Europeans, who will only be admitted to the Central Exhibition on payment of 1/- each.

# MINUTES OF A MEETING OF THE EXECUTIVE COMMITTEE OF THE NON-EUROPEAN HEALTH WEEK, HELD AT THE OFFICES OF THE NON-EUROPEAN & NATIVE AFFAIRS AT 3 P.M. ON WEDNESDAY, 4th JANUARY, DEPARTMENT 1939.

Present :

Mr. G. Ballenden (in the Chair). Dr. and Mrs. G. D. Laing. Dr. and Mrs. Scott Miller. Mr. F. Handel Thompson. Mrs. Ray E. Phillips. Mr. L. I. Venables.

#### PRIZES FOR ESSAY COMPETITION.

It was recalled that Mr. Handel Thompson had offered a donation of £5 towards the first and second prizes for the Bantu, Asiatic and Coloured sections, of a guinea and half a guinea respectively. Mr. Karlton C. Johnson had offered to provide suitable books on health subjects for each of the winners, in addition to the cash prizes.

Dr. Scott Miller reported that although there was a gratifying response from the Bantu people, the entries in the Coloured and Asiatic sections were insufficient to admit of more than one prize being given in each of these sections. In the circumstances, Mr. Handel Thompson proposed that, in view of the fact that there would only be one prize in each of the Coloured and Asiatic sections, a third and fourth prize of 7/6 and 5/- respectively be added to the native section. This was unanimously adopted. This was unanimously adopted.

Dr. Scott Miller then reported the prize winners to be as follows :-

Dr. Scott Miller stated that he had satisfied himself that all the prize winners were adults.

At this stage the Committee recorded a vote of thanks to Mr. Handel Thompson and Mr. Karlton Johnson for their generous donation of prizes.

It was resolved that the prizes be termed "The Handel Thompson Prizes" and that Mr. Handel Thompson distribute them.

Mr. Ballenden undertook to communicate with Mr. Karlton C. Johnson at an early date in regard to his offer of books as additional prizes. It was suggested that these books be suitably inscribed.

# DISTRIBUTION OF PRIZES.

Dr. Scott Miller suggested that it would be preferable to distribute the prizes at some function - say at the Bantu Men's Social Centre - rather than to make a special occasion for the purpose.

Mrs. Ray Phillips informed the meeting that a "Guest Night" is held at the Bantu Men's Social Centre once a month on a Friday evening, and in her opinion this would be a most suitable occasion for the distribution of prizes. She also suggested that if this course is agreed to Mr. Radebe be requested to publicise the fact on his programme.

Mr. G. Ballenden undertook to get in touch with Mr. Radebe, arrange a suitable night, and thereafter communicate with Mr. Handel Thompson.

# DISPOSAL OF SURPLUS FUNDS.

Mr. Ballenden reported that a sum of £77.17. 9. less a small amount for bank charges was available, and he called for suggestions for its disposal.

(A statement of Income and Expenditure was laid on the table.)

Mr. Handel Thompson proposed that a sum of £25. be awarded to the native section of "Our Children's Day" (of which he is the Secretary). This was agreed to and the Chairman called for further suggestions for the disposal of the balance.

Mr. L. I. Venables suggested that the balance be donated to the Bantu Children's Holiday Fund. The function of this body was the sending of convalescent children to the seaside, and they had in view the formation of a home on the lines of that of the Star Seaside Fund.

A proposal was made that donations be sent to certain of the Native Hospitals, but it was pointed out that these were all fairly sound financially.

Dr. Jean Laing inquired whether it would not be advisable to set aside a portion of the money for the purpose of the next Health Week. Mr. Ballenden, however, was of opinion that any future Health Weeks should be undertaken by the Public Health and Native Affairs Committees.

Mr. Ballenden suggested that portion of the money be awarded to the Children's Aid Society on the understanding that it be specifically earmarked for Bantu Creches. He pointed out that it would be as well not to neglect the Coloured and Asiatic sections of the community, and inquired whether there were any institutions under these heads which would merit a donation.

Mrs. Ray Phillips stated that Mrs. Hoskins School Clinic for Coloured children was a most deserving cause and was doing excellent work.

It was finally resolved that the sum of £52.17.9., less an amount to be deducted for bank charges, be divided into five equal parts, and that two parts be awarded to the Bantu Children's Holiday Fund, two parts to the Bantu Creches, and the remaining part to some coloured institution to be decided by the Manager of the Non-European and Native Affairs Department in consultation with the Medical Officer of Health.

# LETTERS OF THANKS.

Mr. Ballenden proposed that letters of thanks be sent by the Committee to lecturers, demonstrators, and all others who assisted in making Health Week a success, special mention to be made in the letter of how the surplus funds are disposed of.

Dr. Scott Miller moved a vote of thanks to the Social Welfare Officers of the Non-European and Native Affairs Department, and the Health Visitors and Inspectors of the Public Health Department, for the wonderful work which they had performed during Health Week.

#### LECTURES.

Dr. Scott Miller stated that in the recent Health Week it had been a mistake to concentrate all lectures into one week. In a campaign of this sort lectures should be arranged over a period of at least a month. Mr. Ballenden agreed with this view and stated that in his opinion lectures should be held once a month in each location throughout the year, finishing up with the Central Exhibition.

Dr. G. D. Laing pointed out that it would be a function of the new medical service to arrange lectures on the lines indicated.

The meeting closed with a vote of thanks to the Chairman.
