Minutes of the thirteenth Conference held at Mafeking from 16th - 19th December, 1950. Not the sum of 1.10 war in hand

17th December, 1950.

Conference opened at 3.30 p.m. Minutes of the previous day were read and adopted as correct.

Report of sale of M.M.S. Fund copies of the Constitution: Mrs. Maphanzela reported £1. 1. 6 but asked to be allowed to give a full report the following day, as she still had a few copies over. Agreed.

Secretary's Report: The report revealed four new branches and the revival of the Korsten P.E. branch.

Miss Soga who was delegated by the council to the conference of the S.A.

N.C.W. at Pietermaritzburg, addressed the two meetings there; one of the N.C.A.W. and one of the Daughters of Africa. She also interviewed the Chief Inspector of Native Education in connection with the (1/-) shilling drive.

The secretary also reported that the following branches sent contribution raised in May, for the purpose of organising new branches and reviving old ones that had died. Marabastad, Pretoria £4; Langa Capetown £5; Queenstown 10/-, Mafeking stad 12/6; Mafeking location £1. 5. Hackney 18/6; Beaconsfield £1.

Representatives to Conferences:- Miss Soga was elected to represent N.C.A.W. of the S.A.I.R.R. conference, Capetown. Mrs Nkomo of Capetown to represent N.C.A.W. at the Child Welfare Conference, Johannesburg but failed to attend. Mrs Mqubuli to be representative of N.C.A.W on the M.M.S. fund committee. Report sent by Rev. Mpitso.

Minutes: Minutes of the 1949 conference were taken as read and adopted as correct, after the correction of the president's remarks to the African National Congress.

Business: Arising from minutes of the previous conference: News letter. After a lengthy discussion Conference agreed that three members of the Mafeking location branch be responsible for the editing and publishing of the N.C.A.W. News letter. Miss. Tsengiwe to be convenor. News to be sent to Miss. Tsengiwe twice a year. 1. In March to be published in April. In September to be published in October. It was also agreed that the news be printed in English and that the branches be responsible for the transalation into languages used in their areas.

It was also agreed that the very poorest branches should ask for help from headquaters for the purpose of stecilling news into the vernacular. News to be sold at 3d per copy. Nurse Hlahle asked the conference to increase the fee paid to the S.A.I.R.R. to 10 pounds. Conference agreed.

Mrs. Old John's wreath: The Mafeking Stad Branch donated £1 towards the buying of a wreath for Mrs Oldjohn. The total amounted to £2. 11. 8. It was agred to buy an artificial wreath. Mesdames M. Matthews and V. Moleme were elected to go and purchase the wreath by conference. Conference adjourned at 6.30 p.m.

18th December 1950.

9 a.m. Devotions by Rev. Molope.
9.30 a.m. Presidential Address: In her address the President said:
When thou prayest, enter the chamber; when thou hast entered shut the door. Likewise when we come to Conference we must close the door to various personal interests and concentrate on Conference.
Business. The presidential address is not given to expose brilliancy and thus advertise self. It is given to inspire the delegates to a deeper and more consistent study of the problems confronting us; and as much as possible should reach all classes of people at Conference literate or illiterate. South Africa is a sick country and the temperature has gone high. We have a gigantic task to undertake but we must have certain qualifications namely reliability. Dependability and Absolute Selfelessness. God first, Others next and I last. Let hope be your banner. Do not be ruled or swayed by emotions. Never do things for God. Do thing with him.

Mrs. Mareka proposed a vote of thanks and was seconded by Mrs Mamane.

11.30 a.m. Address by Rev Nye.

Rev. Nye spoke on Red Cross Work. He explained to the conference how Red Cross work started. He said that the Red Cross was a body that worked for all irrespective of Race, Greed, or colour. The Red Cross did more work in peace time than in War time. There were first aid posts, Lone depots, blood Transfusion. Junior Red Cross in Schools. He ended by saying that the Red Cross does not ask if we are human beings but the Red Cross is there to help. Mrs. Msezane (1) A letter drafted by Mesdames Mrusi and Mareka to the Siyo Family was read and adopted. Nurse Hlahle reported that Lady Selbourne had paid in 7/6 towards Miss. Soga's traveling expenses to Pietermaritzburg. She further suggested that branches that had still to pay the 7/6 should do so to Headquaters in order to issue receipts. Agreed. Mrs. Matthews reported that the wreath cost £2. 8. 6. and that there was a balance of 3 shillings. The Conference agreed that the 3 shillings be put in the Council's Treasury. Dr. Molenasnr. promised to give the Conference fresh flowers to put on Mrs. Oldjohns grave. Telegrams were read from the 1st Vice President Kimberley regretting her inability to attend and from Pretoria. Conference adjourned for lunch.

2.30 p.m. Business.

Minutes of the previous day were read and adopted as correct.

Secretary's Report continued. Kilnerton Pretoria had invited Conference for 1951. It was agreed that the president give the report of the S.A.N.C.W. the following day. A discussion followed on the number of branches in the Council. The Secretary reported that there were 56 branches and that 6 of these were inactive. It was agreed that branches that have paid their affiliation fee should be sent to the conference minutes even if they were not represented at conference. A discussion followed on the affiliation fees of dead branches. The Secretary said that it was agreed in one of the conferences that branches should not be kept in arrears when they started again. Conference adjourned at 4.30 p.m. for sight seeing.

9 p.m. Treasurers Report: The treasurers report revealed a Balance of £16.5s.8d. After a lengthy discussion Conference agreed that all the mony be sent through the treasurer and that the books be audited. Telegrams were read from Vryburg and small farms. Conference adjourned at 10.45 p.m.

19th December, 1950.

9.a.m. Devotions by Rev. Mocumi.

Business. Minutes of the previous day were read and adopted as correct.

Branch Reports. The secretary read reports from the following branches:-Port Alfred, Sharpeville, Vereeniging

10 a.m. Address by Mr. Eaton Native Commissioner for Mafeking: -

Mr. Eaton welcomed the delegates by using the word "Pula". He hoped the delegates would be drenched with water as well as wisdom. He spoke of the spirit of co-operation - mutual feeling one to the other. He said as leaders of the community we should be shining lights. He spoke of 1. Education. He said the mother's duty is to see that her children are educated. Children of today are people of tomorrow.

Everything can be taken away from a person but not education. Education dies with a man. He quoted. Small pox in Mafeking and the N.C.A.W. can help their own people by encouraging vaccination and attending clinics. 3. Co-operation. He said if people worked together they did wonders. He added that one must always try to understand the person's point of view He said that everywhere there must be superiors in life. Children today were different from the past. He made an appeal to the delegates that as mothers they should teach their children to obey their elders. He quoted the fifth law of the ten commandments. He ended by saying If one has a problem to solve one should think how to solve the problem in the right way. Short temper never solved a problem in the right way. Short temper never solved a problem. Sister Afrika passed a vote of thanks. 11.30 a.m. Address by Miss. Postumus Homecraft Organiser Bech. Protector-Miss. Posthumus spoke of the advantages of homecraft.

She dealt with the practical side of the course. She gave an outlay of the work she was doing in the Protectorate and not only in schools but amongst Adults. A full copy of Miss. Posthumus's lecture will be sent to all branches. A vote of thanks passed by Mrs Mareka.

Branch reports continued. The secretary read reports from Tsome and Pietermaritzburg.
Telegrams Vryburg from Mr. Mokogosi D.V.T.
Report M.M.S. Fund sale of copies of constitution. The total amounted to £1. 4. This amount was handed to Mrs. B. Mkwanazi to hand to Rev. Mpitso. Conference adjourned for lunch.

pm. The president introduced Dr. Modiri S. Moleme. In welcoming the delegates he said welcome and godspeed. Dr. Nkome passed a vote of thanks.

Conference agreed that headquater officials be elected Resolutions. Conference agamually and from any area.

Queenstown. In view of the fact that African doctors are not allowed to give instruction to European sisters, this conference resolves that there should be hospitals fully staffed by africans (sisters and nurses) under the supervision of African Postors. the supervision of African Boctors

2. That this body is greatly peturbed by the decision arrived at by the decision Department to employ less male teachers in the Primary schools.

East London. This branch resolves that Parent Associations should be formed in areas where there are boarding schools or institutions. These parent Associations to help in times of strikes especially and to keep and interest in the welfare of the students.

Branch Reports. The following branches gave reports: Kilnerton, Atteridgeville, Lady Selbourne, Bantulie, Potchefstroom, Dundee, Durban Mooiplas, Marabastad, Bloemhof, Klerksdorp, Alice, Queenstown, Taungs Langa Regional and Branch reports; Bloemfontein, Vryburg, Kingwilliamstown, Mafeking Location, and Mafeking Stad and Transvaal Regional. It was agreed that the President should make a tour of all places where there were branches for the purpose of reviving branches and settling disputes amongst Branch, members and branches. The President to be given money for this purpose from the Organisation Fund.

Conference also agreed not to pay affilliation fee to N.C.W.

Minutes of the 13th Annual General Conference.

16th December, 1950.

Conference business commenced at 4.30 p.m. The President reminded Conference of Mrs Maphanzela's suggestion at the Durban Conference, that the Council should buy Nurse Hlahle a present as a token of appreciation for her meritorious 12 years continuous service to the Council as its secretary. The president reported that Mrs Maphanzela had brought the present amounting to £5. 11. 6. The president therefore suggested that each branch should contribute the sum of 4/- towards the cost. The Conference agreed.

Mrs Ngcobo proposed that the present should be presented formally during the reception by Mrs Maphanxela. Conference agreed. Mrs. Sililo suggested that one of the older members should accompany Mrs. Maphanzela in the presentation. Conference agreed. Miss. Tsengiwe suggested Mrs Gasebui, a member of the Mafeking Branch. Agreed.

The President reported on her visit to Capetown; that the Langa and Nyanga branches offered to pay expenses to Capetown as neither the Council nor the S.A.I.R.R. could afford to finance the trip. Whilst the president, now and again, attended the S.A.I.R.R. sessions, she attended the Cape Peninsula Regional Conference and helped the Individual Branches in various matters. i.e. seeing the Secretary of Native Affairs on Old Age Pension Fund as well as Teacher's Pension Funds; and consolidating the Nyanga branch, and attending to vital issues there.

Mendi Memorial Scholarship Fund: A letter from Rev. Mpitso was read to the Conference reporting on the activities of the M.M.S. Fund and appealing for co-operation from the N.C.A.W. A few copies of the constitution of the Fund that had been sent with the letter were sold at 6d a copy, Mrs Maphanzela being in charge.

Resolutions: The president suggested that the resolutions be dealt with earlier than as tabled in the Agenda.

Nurse Hlahle proposed that resolutions be dealt with on Monday 18th and not on Tuesday 19th. Conference agreed.

Conference adjourned at 5.30 p.m.

ANNUAL CONFERENCE, 25th - 29th APRIL, 1960.

MINUTES

MONDAY, 25th. April.

10 a.m. CHURCH SERVICE was held in St. George's Church, Knysna - The Address was given by the Right Revd. Bishop T.W. Stainton, Rector of Knysna.

11.30 a.m. OPENING OF CONFERENCE.

The Mayor, Councillor E.A. Meyer with Mrs. Meyer were present. The Mayor extended a warm welcome to delegates and visitors to Knysna and then delivered a brilliant address on Women's Powers to Maintain Morality.

The National President thanked the Mayor for his speech and his good wishes and expressed pleasure at being able to hold Conference in the beautiful surroundings of Knysna.

Mrs. G. Logie, President of Knysna Branch welcomed the delegates and visitors to Knysna.

Presidential Address.

Mrs. I. Newton gave her address as National President - the subject being "The Woman and the Family in a Changing World". It was stressed that many young married women took paid employment, and she urged that this be part time work so that the mothers could be at home when children returned from schools. The need for more Creches, especially for African children was very important and the way this affected the later years of a child's life and subsequent juvenile difficulties. The honoured place in the home need not be given up by the modern young woman - she was capable and had much to offer to the cultural and technical progress of the modern and changing world.

Conference then adjourned until Tuesday morning.

2 p.m. Pre-Conference Meeting for members of the National Executive.

TUESDAY, 26th. April.

9 a.m. WELCOME.

Delegates and Visitors to the Conference were welcomed by the First Vice-President, Advocate Hester Steyn, in the absence of the National President, Mrs. I.M. Newton, who had gone to George to meet the International President, Madame Marie-Helene Lefaucheux.

A special welcome was extended to delegates of the Middelburg Branch to their first Conference.

Notice Convening Conference. The Recording Secretary read the Notice Convening Conference as set out in Conference Circular No.1 of 13th. January, 1960.

<u>Platform.</u> The motto and objects of N.C.W.S.A. were read in English by Mrs. A.I. Mackenzie, President of Bloemfontein Branch, and in Afrikaans by Mrs. H.R. Keyter, I.S.C. Member (National Convener) for Home Economics.

Obituaries. Mrs. N.B. Spilhaus, Life Vice-President, spoke on the voluntary and devoted service of the late Miss Delbridge, and gave a short account of her work and interests which led up to her long and efficient convenership of the Parliamentary Committee of N.C.W.S.A. Members stood in silent tribute to Miss Delbridge and others who had passed on.

Roll-Call, Apologies, Proxies, Appointment of Scrutineers.

The Recording Secretary called the Roll. Apologies were noted and Proxies accepted. Mrs. A. Vowles, Mrs. M.F. Julyan, Mrs. E. Bent and Miss N. Hogsett were appointed as Scrutineers.

Voting Strength of Council. The Honorary Treasurer announced that a quorum was present and the total voting strength was 727 plus 34 Executive Members = 761. Two-thirds of this i.e. 507 would be required for the adoption of any Resolution.

On the proposal of Mrs. van der Westhuizen, President Pretoria Branch, seconded by Dr. D.M. Brodie, President Pietermaritzburg Branch, the Minutes were confirmed for signature by the National President.

Matters arising from the Minutes.

1. Publicity Leaflet.

Mrs. van der Westhuizen, President Pretoria Branch, called attention to the last page of the Publicity Leaflet and suggested that item 6 "Enfranchisement of Non-European Women" be altered to read:

"Enfranchisement of all Women"

She also recommended that the pamphlet should be recalled and reprinted. Mrs. White, Honorary Treasurer, suggested that any unnecessary wording in the pamphlet be blocked out and the alteration be made in a subsequent issue. After discussion, Mrs. van der Westhuizen moved, seconded by Mrs. Lipschitz, President Oudtshoorn Branch, that item 6 on Page 4 of the Publicity Leaflet be altered to read: - "Enfranchisement of all Women"in the printing of all subsequent issues. Mrs. D.H. Peddie, President Germiston Branch spoke in support of this, and it was carried by 532 votes.

At this stage the International President, Madame Marie-Helene Lefaucheux arrived and was warmly welcomed by Conference. She addressed the delegates and visitors and said she was very touched with her reception and looked forward to attending the Sessions.

2. Ratification of the recommendations of the Executive Committee.

The following Resolutions were recommended for acceptance by the Pre-Conference Executive Meeting:-

a. Nationally Organised Bodies.

"THAT THE DIRECTIVE ADOPTED AT THE 1955 INTERIM EXECUTIVE COMMITTEE MEETING BE AMENDED TO READ:"N.C.W.S.A. SHALL NOT TAKE ACTION IN MATTERS DIRECTLY CONCERNING OTHER NATIONALLY ORGANISED BODIES UNLESS ASKED TO DO SO OR UNLESS EXCEPTIONAL CIRCUMSTANCES EXIST WHICH, IN THE OPINION OF THE NATIONAL EXECUTIVE COMMITTEE, JUSTIFY SUCH ACTION".

b. Education Resolution as set out in Annual Conference Circular No.11. of 12th. April, 1960.

The National President asked that discussion of this Resolution be left until the afternoon session, and this was agreed to.

- c. Miss H. Pollak, National Adviser for African Affairs, moved an Emergency Resolution which was amended and accepted as follows:-
 - "N.C.W.S.A.

 1. URGES THE RESPONSIBLE AUTHORITIES ON COMPASSIONATE AND HUMANITARIAN GROUNDS TO ENSURE THAT MAINTENANCE GRANTS BE MADE IMMEDIATELY AVAILABLE FOR THE DEPENDENTS OF PERSONS DETAINED UNDER THE EMERGENCY REGULATIONS.

- 2. THAT DETAINED MOTHERS OF CHILDREN UNDER 12 YEARS OF AGE
 AS WELL AS PERSONS OVER 65 YEARS OF AGE BE RELEASED FROM
 DETENTION UNDER CONDITIONS SPECIFIED IN EACH CASE BY THE
 AUTHORITIES".
- d. Emergency Resolution submitted by the Board of Officers Re: Secretariat.

This was deferred for discussion when the amendments to the Constitution were considered.

. Printing of Annual Report - Honorary Editor N.C.W. News.

"THAT COUNCIL REVERTS TO THE METHOD OF PUBLISHING THE ANNUAL REPORT AS WAS DONE BEFORE 1959 BEFORE CONFERENCE ON PRINTER'S "PULLS" AND THAT THE CORRECTED REPORT BE PUBLISHED IN THE N.C.W. NEWS AFTER CONFERENCE. THE EDITORIAL BOARD OF THE NEWS TO UNDERTAKE THE DISTRIBUTION OF THE REPORT BEFORE CONFERENCE".

Natal University Jubilee Conference on Education.

At the National President's invitation, Mrs. W.A.D. Russell, Honorary Life-President, gave information about the Conference to be held by the University of Natal in July 1960.

Report of the National Secretary.

The National President moved the adoption of the Report prepared by the Honorary Assistant Secretary, Mrs. Anne Mackenzie, on page 19 of the N.C.W. News. This was seconded by Mrs. Logie, President Knysna Branch and accepted.

Report of the Honorary Treasurer.

Referring Council to pages 24 and 25 in the Annual Report, the Treasurer, Mrs. E.A. White, called attention to the pleasing fact of the increase of 19 members and 20 affiliated societies during 1959. She welcomed the new branch - Middelburg, Cape - and regretted the closing of the Greytown Outpost.

In presenting the Balance Sheet for signature, Mrs. White asked for special thanks to go to Messrs. McDowell, Caradoc Davies & Company,

Chartered Accountants, for auditing our books.

Speaking to the Budget for 1960, the Treasurer explained that the surplus of income over expenditure at the end of 1959 was due to the fact that International Standing Committee Members, by not applying for the grant to which they were entitled, had again made a valuable voluntary contribution to Council's funds; and that although the National President had visited many Branches far afield during the year, her travelling expenses had amounted to only £85.

Mrs. White moved the adoption of her Report, which was seconded by Mrs. N. Charton, President Graaff-Reinet Branch, and accepted. Mrs. Charton also paid tribute to Mrs. White for her most efficient services as Treasurer.

Report of the Convener of the Parliamentary Committee.

An apology for absence was received from Advocate de Villiers, and her proxy, Mrs. V.C. Davie, President Cape Town Branch, presented the Report which dealt with the Sessions of the latter part of 1959 and early part of 1960. 50 Bills were studied and a full list would be issued. The following received attention:

Recommendations were made to the Board of Officers for action to be taken in connection with the following Bills:-

On the subject of the Citizenship Amendment Bill, a letter was written to the Minister of the Interior and his reply is awaited.

The National President paid tribute to Advocate de Villiers, and recorded warm appreciation of the work she had done.

Miss H. Pollak, National Adviser for African Affairs, added her tribute to the Convener and members of the Parliamentary Committee, and said that this was one of the Committees which really enhanced the status of N.C.W.S.A.

Mrs. Brown, President Kimberley Branch apologised for the absence of Mrs. Sesedi who had hoped to come to Conference but had been prevented. She then asked if Council could not make information regarding legislation affecting them available to African Women. She also requested that copies of letters to the National Council of African Women be sent to the Kimberley Branch to enable them to keep in closer touch with N.C.A.W.

Mrs. Davie moved the adoption of the Report, which was accepted.

N.C.W. NEWS.

1. Report of the Honorary Editor.

This was read by Mrs. E.D.W. Borcherds, proxy for Mrs. J.M. Grieve, Honorary Editor, adoption moved by Mrs. Bradnum, seconded by Mrs. H.R. Keyter, I.S.C. Member (National Convener) for Home Economics, and accepted.

The National President expressed the appreciation of Council to the Editorial Board for their excellent publications.

Mrs. N. Kewley, Sub-Convener for Press: English, complimented the Editorial Board on the attractive cover of the "News".

2. Report of Honorary Treasurer.

Mrs. N.B. Spilhaus presented the Financial Statement. She said that the audited statement on the N.C.W. "News" accounts for 1959 was a very disappointing document showing a deficit of £180. 14. 8. on the year's working, more than twice the deficit of 1958.

Mrs. Spilhaus then moved, seconded by Mrs. White :-

"THAT THE COST OF THE NEWS BE INCREASED FROM 4/6 TO 5/PER COPY PER MEMBER PER ANNUM FROM THE BEGINNING OF
THE NEXT FINANCIAL YEAR OF THE BRANCHES, NAMELY 1st.
OCTOBER, 1960".

Different forms of advertising in the "News" were discussed, and the Resolution was passed unanimously.

Report of the Honorary Archivist.

Mrs. E.E. Monro, Honorary Archivist, in presenting her Report said that this year she had hoped to visit more branches and show them some exhibitions of the Archive Collection. However, circumstances had prevented her from doing this, but she hoped that matters would improve and she would be able to do so at a later date.

Joint Exhibition at Jubilee Conference.

Mrs. Monro stated that at the last Pre-Conference Meeting she gave notice of motion to amend Item 11 paragraph (c) on Page 3 of the Post-Conference Minutes accepted 1958, to read:

"That although Branch Councils and Outposts could retain their own Archive Material, Council had the right to call upon it should the necessity arise".

and asked that this be placed on the Agenda of the 1961 Pre-Conference Executive Meeting. She moved the adoption of her Report, which was seconded by Dr. T. Gutsche, Immediate Past President, and accepted.

2 - 2.45 p.m. Meetings of the following Sectional Committees were held :-

Arts and Letters Child Welfare
Home Economics African Affairs and
International Relations and Peace

Report of the I.S.C. Member (National Convener) for Education.

The I.S.C. Member for Education, Miss E.M. Tilley, opened the Education Session by reading the Findings of the Conference "Education To-day - a Challenge for the Future" convened by N.C.W.S.A. at Pietermaritzburg in 1958. She emphasised the fundamental points brought out i.e. humanism, defined as "the sum of spiritual values, which the community of civilised beings consider as characteristic of man", and specialisation, and explained that the Findings could be either accepted or rejected but not altered. She moved:

That this Conference of N.C.W.S.A. considers that the principles underlying the Findings of the National Conference on "Education To-day - a Challenge for the Future" are in agreement with its stated aims and objects, and records its formal acceptance.

Passed unanimously.

Dr. T. Gutsche gave a Progress Report of the work of the Continuation Committee, and referred to the proposed Union Education Advisory Council Bill. A central Education policy which would interfere with provincial autonomy, was not acceptable. The proposed measure needed very careful consideration. She expressed the view that the attitude of N.C.W.S.A. should be made known to the Government.

The President of Johannesburg Branch, Mrs. E.E. Monro, spoke on the need of putting forward a clear-cut policy as a basis for action, and submitted a detailed statement for discussion.

Mrs. S.R. Sloman, Second Vice-President, pointed out that although the Bill had just been published, its provisions were not available to Conference, and suggested that they should be obtained from the Convener of the Parliamentary Committee by telephone to Cape Town, and further discussion be deferred until Miss Tilley and a small sub-committee had an opportunity of studying the text. This was agreed to.

WEDNESDAY, 27th. April.

9 a.m. CONSTITUTION.

The Constitution was amended and accepted as detailed in accompanying draft.

2 p.m. Meetings of the following Sectional Committees were held :-

Report of the I.S.C. Member (National Convener) for Arts and Letters.

Mrs. A.I. Mackenzie, proxy for the I.S.C. Member (National Convener) for Arts and Letters, moved the adoption of the Reports on Arts and Letters and Music as prepared by Mrs. Rhodes Harrison, and published on Pages 34 and 35 of the N.C.W. News. She drew attention to the ommission in the Report under the heading "The establishing of new Art Societies" and asked that "and Graaff-Reinet" be inserted after Kroonstad.

The Reports were seconded by Miss Pollak and accepted.

The appointment of Mrs. A. Davidson, 6 Whites Road, Bloemfontein, as Sub-Convener for Music, nominated by Mrs. Rhodes Harrison and Bloemfontein Branch, and circulated to Council, was confirmed.

Report of the Sub-Convener for Letters.

Mrs. W. Eybers, Sub-Convener for Letters, reported that she had discovered last year when requested to give information on South African Women Writers, that there was no accepted bibliography of Authors. The International President had urged us to see that we got our bibliography up to date, and after much correspondence and two annual requests to schools of Librarianship urging them to encourage a student to undertake a bibliography of the work of Women Writers, a student at the University of the Witwatersrand was now busy with this work which would therefore be professionally done, and since this project was inspired by the N.C.W.S.A., we shall be given a copy of the complete bibliography which may subsequently be referred to with pride.

She mentioned the Control of Publications and Cinema Entertainment Bill, The Exhibition of Books by Women Writers - 1910 to 1960 - and

The Thesis on Women Writers in South Africa.

Dr. Eder Memorial Prize. Mrs. Eybers stated that Miss Mary Morrison Webster had judged the English books, and the results had been sent to Paris by Airmail.

The Report was seconded by Mrs. E.V. Wroughton, I.S.C. Member (National Convener) for Cinema, and accepted.

The National President recorded great gratification by Council of the work Mrs. Eybers had done in staging the Exhibition of Books by Women Writers.

Report of the I.S.C. Member (National Convener) for Child Welfare.

Miss L.M. Mackenzie, I.S.C. Member (National Convener) for Child Welfare, stated that Mrs. E. Reyneke was prepared to undertake the N.C.W. Convenership for Child Welfare if Council accepted her. Miss Mackenzie then reported on the I.C.W. Meeting at Vienna where the name of the Standing Committee had been changed from Child Welfare to The Child and the Family, the theme for study for the current year on which the Committee would report at Istanbul. As the subject was one which touched on Health, Education, Moral Welfare and Cinema, a joint meeting of these different committees was held under the Chairmanship of Lady

Reading.

On the National level Miss Mackenzie said that during the present year nine branches forwarded Reports on Child Welfare activities in their areas - these ranged from such practical matters as provision of meals for Asians and Coloureds, and other school feeding schemes. She stated that the Children's Act Bill second reading 7th. April, and gazetted on the 14th. April, had just come into her hands - she would prepare a summary and this would be circularised to all branches very shortly.

Miss Mackenzie moved the adoption of her Report, which was seconded by Mrs. M. Overbeek, and accepted.

The appointment of Mrs. Reyneke as I.S.C. Member (National Convener) for Child Welfare (The Child and the Family), was confirmed, and the National President thanked Miss Mackenzie for helping to fill the vacancy.

Resolution 3.

Mrs. V.C. Davie, President Cape Town Branch, moved Resolution 3.

"THE N.C.W.S.A. CONSIDERS THAT THE CANING OF JUVENILES CONVICTED OF OFFENCES IS NOT A CONSTRUCTIVE FORM OF PUNISHMENT AND DOES NOT HELP TO REHABILITATE DELINQUENTS IT THEREFORE SUGGESTS THAT A COMPREHENSIVE AND SCIENTIFIC INVESTIGATION BE UNDERTAKEN IN ORDER TO ASSESS THE EFFECT AND VALUE OF THIS FORM OF PUNISHMENT IN RELATION TO ALTERNATIVE FORMS OF PUNISHMENT".

Mrs. Davie said that the circumstances which led to the request for an enquiry into the caning of juveniles, were that there appeared in the local press reports of one or two incidents of very severe caning, in some instances severe enough to cause bleeding.

In seconding the Resolution Advocate Steyn pointed out that caning was very frequently resorted to in the case of boys although it was not allowed in the case of girls, and there was an obvious need for a thorough investigation into the effects of caning as a punishment.

Mrs. W. Wiley, I.S.C. Member (National Convener) for Radio and Television, moved an amendment which was lost, and the Resolution 3 as put forward by Mrs. Davie was passed by a majority of 715 votes.

Resolution 2. PLACES OF SAFETY.

"THAT THE NATIONAL COUNCIL OF WOMEN CONCERNED ABOUT THE LACK
OF ADEQUATE ACCOMMODATION AND STAFFING IN CERTAIN PLACES OF
SAFETY AND DETENTION SUPPORTS THE REQUEST OF THE SOUTH AFRICAN
NATIONAL COUNCIL FOR CHILD WELFARE THAT PROVISION BE MADE IN
THE PROPOSED AMENDMENTS TO THE CHILDREN'S ACT TO LEGALISE THE
APPOINTMENT OF ADVISORY BOARDS TO PLACES OF SAFETY AND DETENTION
ESTABLISHED BY THE STATE AND THAT THE DEPARTMENT OF SOCIAL
WELFARE BE ASKED, AS SOON AS POSSIBLE AFTER THE PASSING OF SUCH
LEGISLATION, TO MAKE PROVISION FOR THE APPOINTMENT OF SUCH BOARDS;
FURTHER.

THAT THE DEPARTMENT BE EARNESTLY REQUESTED TO EXPEDITE THE PLANS FOR IMPROVED ACCOMMODATION AND STAFFING IN THE EXISTING PLACES OF SAFETY AND DETENTION WHERE THE NEED FOR THIS HAS BEEN ESTABLISHED."

Dr. D.M. Brodie, President Pietermaritzburg Branch, thanked the Board of Officers and Miss Mackenzie for their prompt action in putting forward a summary of the Resolution in their memorandum on the Children's Act when it came before Parliament before Conference met. Pietermaritzburg Branch would also like to thank the twenty other branches who had replied to their circulars, and to explain the reason for their action. In 1958 the Edendale Welfare Society sent them a memo on the state of the Non-European Place of Safety at Bisley, and asked the Pietermaritzburg Branch to help. Members of the Executive then visited Bisley. The children were housed in a disused ammunition dump, the rooms huge, dark, windowless and cold. There was no safe playground for the smaller children, but the

older boys were playing football under the eyes of two Indians armed with sticks. There was one European man in charge of everything - the care of the children and all the administration and clerical work, and the numbers varied from 23 to 70 children of all ages - infants to boys and girls of 15 or 16. There were two African women to supervise the cooking etc., but the older children had charge of the small ones. The branch was shocked to find that such conditions could exist without being known to responsible citizens, and felt that the essential step towards real reform would be the appointment of expert Advisory Committees for all Places of Safety - only by such Boards could public opinion be reliably informed of the needs and conditions of such places.

Mrs. M.B. Lavoipierre, President Durban Branch, supported the demand for Advisory Boards, and pointed out that when these Places of Safety were run by the Child Welfare Society, many of the problems that have arisen in Pietermaritzburg did not exist.

Miss Mackenzie stated that the Minister in the course of a long interview had carefully listened to our plea but stated that he must discuss the matter further with his department, and the outcome so far has been negative.

THURSDAY, 28th. April.

9 a.m. The National President reported to Conference that news of the death of the Administrator of the Cape, Dr. Otto du Plessis, had been received, and IT WAS AGREED to send a telegram to his widow and family expressing sympathy.

Report of the I.S.C. Member (National Convener) for Cinema.

Mrs. E.V. Wroughton, I.S.C. Member (National Convener) for Cinema, referred to the memorandum on the importation of Children's films into the Union. A reply from the Secretary to the Minister of Finance had been received stating that a change in the method of taxation of cinematograph films would be made shortly, the tax being based on the number and prices of admission tickets. It was hoped that this change would make it feasible to import Children's films, and the major Importing and Exhibiting Companies had been contacted in this connection.

Mrs. Wroughton moved the adoption of the Report, which was seconded by Mrs. N. Richardson, I.S.C. Member (National Convener) for Press and Publicity, and accepted.

Report of the I.S.C. Member for Finance (National Treasurer).

Mrs. E.A. White, National Treasurer, in presenting her Report on National Finance, asked Conference delegates if they would try to increase their number of subscribers, and to do their best to get advertisements for the Quarterly Review. Advice had been received that the cost of this publication would now be \$1.50 cents - roughly 10/8 and equivalent to 1 Rand $7\frac{1}{2}$ cents, whereas in the past we had paid 7/6 per annum for the bulletin.

Dr. Eder Memorial Fund. Mrs. White pointed out that at the Jubilee Conference it was agreed in principle to support the Dr. Eder Memorial Fund and stated that we did wish to send our contribution in remembrance of the late Past International President of whom many had very pleasant memories, especially those who had met her at International Conferences.

After discussion IT WAS AGREED to donate £20. from general funds to the Dr. Eder Memorial Fund, and a collection from delegates and branches be made and added to this amount to be presented by the President at the International Triennial Conference. The suggestion that a collection be
