

Professor Phillip V. Tobias, B.Sc. 1964, B.Sc. Hons., 1947, M.B., B.Ch. 1950, Ph. D. 1953, Head of Department of Anatomy at the University, has been chosen as one of Junior Chamber South Africa's four outstanding young men of 1966.

Earlier this year he received the Simon Biesheuvel Medal for 1966 for his contribution to the knowledge of man in Africa, in the fields of palaeontology, anthropology, genetics and evolution. The medal is awarded by the S.A. Association for the Advancement of Science.

Professor Tobias spent several months this year studying ancient man-like fossils excavated by Dr. L. S. B. Leakey from the Olduvai Gorge, Tanzania. He received a grant from the National Science Foundation of Washington, D.C. to undertake this research.

In September Professor Tobias represented South Africa at the annual conference of the British Association for the Advancement of Science at Nottingham. He also studied fossil hominids from three continents in museums in France, Holland, England, Greece and Hungary.

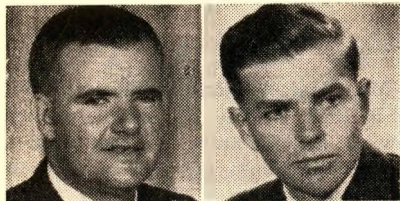

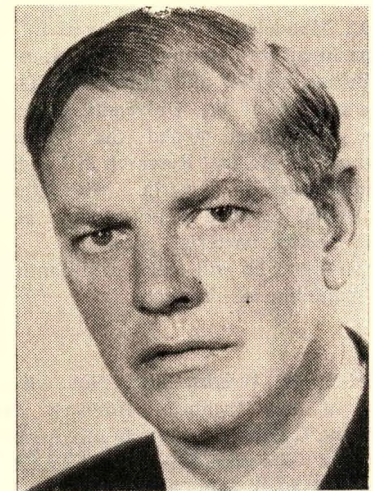

OBITUARY

Professor J. M. Edelstein, one of South Africa's leading orthopaedic surgeons and a former Professor of Orthopaedic Surgery at the University, died in Johannesburg on August 18, aged 69.

Professor Edelstein held the Chair of Orthopaedic Surgery from its establishment in 1962 until his retirement in 1964. His association with the University began before it was proclaimed in 1922. He was the first Lecturer and Demonstrator in Anatomy at the Medical School (inaugurated in 1921).

For many years he was head of the Orthopaedic Department at the Johannesburg General Hospital and he was also consultant surgeon to the Chamber of Mines.

Professor Edelstein graduated from Edinburgh University in 1918 and received his F.R.C.S. (Edin.) in 1931 and his Master of Surgery, Orthopaedics, at Liverpool in 1933.

In South Africa, as a specialist surgeon, he pioneered orthopaedics, devoting much of his time and energy to improving the lot of crippled children.

For many years he served the Hope Convalescent Home, the Hope Training Home for Crippled Children and the Cripple Care Association.

From 1942 to 1946 Professor Edelstein was orthopaedic specialist to the Union Defence Force. He founded the Orthopaedic Association of South Africa, of which he was made Hon. Life President.

He leaves two daughters.

Mr. John James Smith, B.A. 1934, Rector of the Transvaal College of Education for Asiatics, died at his home in Johannesburg recently, aged 56. Mr. Smith taught at several schools before being appointed Rector of the college in 1961. He leaves a wife and son.

Dr. Ralph Metlitzky, B.Sc. 1960, M.B., B.Ch. 1963, who was pediatric registrar at Baragwanath Hospital, Johannesburg, died in a motor accident on August 7.

Dr. Max Joffe, M.B., B.Ch. 1930, died on June 29 in London, where he had practised as a psychologist since qualifying in 1952.

Dr. A. W. Rowe, B.Sc. (Eng.) 1923, M.Sc. (Eng.) 1937, former Director of the Witwatersrand Technical College in Johannesburg, died in Durban in October, aged 64.

After graduating, Dr. Rowe worked on the Railways and then spent two years at the University of London, where he did research into diesel fuel-injection phenomena and the development of a cathode ray pressure indicator. For this work he received an M.Sc. from Wits and a Ph.D. from the University of London.

On his return to South Africa in 1937 he was appointed Headmaster of the Technical Day School of the Natal Technical College and later of the Maritzburg Technical College.

He played a leading part in the development of the Witwatersrand Technical College, and retired in June last year after 20 years as Director.

Mr. Harry Colman, B.A. 1936, LL.B. 1938, a Johannesburg advocate and a part-time lecturer in civil procedure in the Department of Law at Wits since 1956, died after a heart attack on July 6, aged 52.

He practised for some years as an attorney before joining the Johannesburg Bar in 1945. There he built up a large practice.

Mr. Colman was recognised as an expert on court procedure, and contributed considerably behind the scenes to its improvement. He was always deeply interested in the welfare of the University and of the Faculty of Law in particular.

He leaves a widow, **Mrs. Pearl Colman**, B.Com. 1937, B.A. 1959, B.A. Hons. 1960, M.A. 1963, Assistant Student Counsellor at Wits and three sons, one of whom, **Dr. Martin Colman**, is also a graduate of Wits (M.B., B.Ch. 1964).

Mr. F. R. Chamberlain, B.A. 1935, Principal of the John Orr Technical High School from 1958 till his retirement in April, died of a heart attack on September 9.

Mr. Chamberlain was President of the S.R.C. at Wits in 1933 and 1934 and also of the S.R.C. at the Johannesburg Teachers' Training College in 1933.

Mr. Noel G. Garson, B.A. 1952, B.A. Hons. 1953, M.A. 1956, Senior Lecturer in history at the University, has been appointed to the Chair of History from January next year.

He succeeds **Professor J. S. Marais**, the eminent South African historian, who is retiring after 22 years at the University.

Mr. Garson, who is 34, obtained his B.A. with several first-class passes, and his B.A. Hons. degree in history in the first class. As the holder of the Herbert Ainsworth Scholarship in Modern History, he had the degree of Master of Arts conferred upon him with distinction.

From 1955 to 1956 Mr. Garson read history at Cambridge where he obtained the degree of Bachelor of Arts with a first-class in Part II of the Historical Tripos. In 1957 he returned to Wits, where he lectured in history and economic history before being appointed to the permanent staff of the Department of History in 1960. He was appointed Senior Lecturer in 1964.

From 1962 to 1964 Mr. Garson continued his researches in England as the holder of a Nuffield Dominion Travelling Fellowship.

The author of several publications, he is working on a study of party politics in South Africa from 1910 to 1924.

He is vice-chairman of the University's Academic Staff Association.

Dr. Robert W. Charlton, B.Sc. 1948, M.B., B.Ch. 1952, Tutorial Physician in the Department of Medicine at the University has been appointed to the Chair of Experimental and Clinical Pharmacology from January next year.

Dr. Charlton, 36, who holds the degree of Doctor of Medicine, is the author of many publications, several of them dealing with iron metabolism. His work has attracted considerable attention overseas, and in August he attended an international congress of pharmacology in Sydney.

After qualifying at Wits, Dr. Charlton served for a year as a senior house

physician at the Transvaal Memorial Hospital for Children. He then spent two years as a medical officer on the staff of the Chamber of Mines.

In 1957 he was admitted to membership of the Royal College of Physicians of Edinburgh after attending post-graduate courses in medicine in Britain. He then returned to South Africa where he was appointed a medical registrar at the Johannesburg General Hospital. He was registered as a specialist physician in 1961 and was appointed to his present post at the University in the same year.

Mr. Philip Segal, Senior Lecturer at the University of Cape Town, has been appointed to one of two professorships in the Department of English from next January.

The vacancy has been caused by the retirement of **Professor A. C. Partridge** after 12 years' service. **Professor A. G. Woodward**, who is already in the department, will succeed Professor Partridge as its head.

Mr. Segal, who holds the degrees of Master of Arts of the University of Cape Town and the University College, London, has had 25 years' experience of lecturing. His main field of research is in 16th-century English literature and he has lectured on a variety of topics, in particular on Shakespeare and Elizabethan drama, on modern poetry and the modern novel and on history of criticism.

He has acted in productions in Cape Town's Little Theatre, and been chairman of the Cape Literary Society, the English Association of Cape Town and the Friends of Italy. He is fluent in French, German and Italian and has a close knowledge of their literature.

The author of several publications, he is a foundation member of the editorial board of *Contrast*, a South African quarterly.

Dr. Derek S. Henderson, Director of the Computer Centre of the University of the Witwatersrand, has been appointed Professor of Computer Science in the Department of Electrical Engineering from January 1.

This is the first Chair in computer science to be established in Africa.

The University has led the way in computer science in this country. It became the first university in the country to own an instrument in 1962 and a second more powerful one was installed in 1964.

Dr. Henderson holds degrees from the Universities of Oxford, Cambridge, Harvard and Rhodes and has attended several international conferences on computers in America. He has also visited Britain, the Continent and Australia to study computer developments.

From 1960 to 1962 he was one of a small American team responsible for the architecture of a computer, which changed the entire concept of computers by introducing the idea of a family of compatible and open-ended machines.

Dr. Henderson graduated in science from Rhodes University in 1949, and then went to Lincoln College, Oxford, as a Rhodes Scholar. He gained a first in the Honours School of Mathematics in 1951. He then spent two years at St. John's College, Cambridge, where he read for the Logic Section of the Moral Sciences Tripos.

After a brief period of lecturing in mathematics at Wits he went to Harvard and in 1960 he received the degree of Doctor of Philosophy. He spent two years as a systems planner with a computer corporation at Poughkeepsie, in the United States.

In 1962 he was appointed Senior Lecturer in the Department of Electrical Engineering at Wits. He was appointed Director of its Computer Centre in 1964.

Dr. Henderson's wife, **Mrs. Thelma Henderson**, who is a graduate of Wits (B.A. Hons. 1957), is Dean of the Women's Residence.

POSTGRADUATE DIPLOMA COURSES 1967**

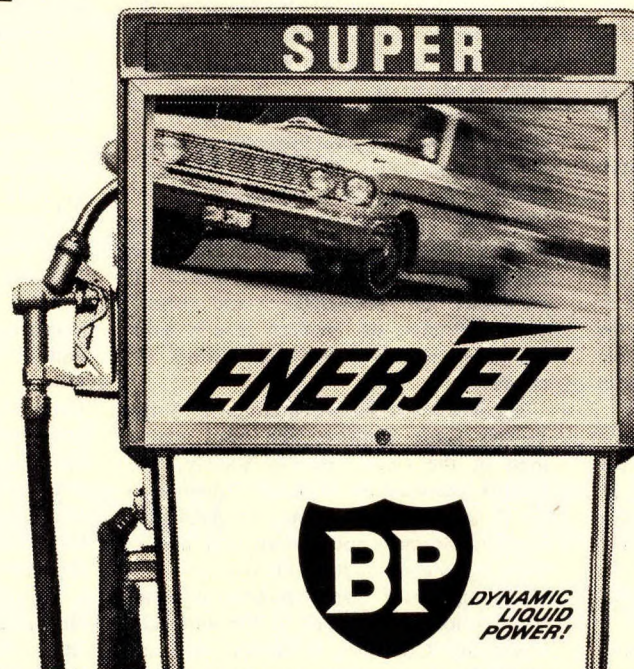
Postgraduate courses leading to the Graduate Diploma in Engineering (G.D.E.) are being offered in the Faculty of Engineering, commencing February 1967.

Two new Associate Professors

Mr. J. W. Brommert, Senior Lecturer in the Department of Physics, has been appointed an Associate Professor from January 1967, in recognition of his long and meritorious service on the staff of the University. There are seven other holders of the title at Wits.

Mr. Brommert, who has been a member of the staff since 1945, was born in Holland and came to South Africa in 1933. After matriculating at Grey College, Bloemfontein, he received his B.Sc. degree at the University College of the Orange Free State in 1941. He then came to Wits, where the degree of B.Sc. Hons. was conferred upon him in 1944.

Appointed a graduate assistant in the following year, Mr. Brommert was made a temporary full-time lecturer in 1946 and was appointed to the permanent staff a year later. In 1951 Mr. Brommert went to Cambridge, where he worked in the Cavendish Laboratory.

Mr. Brommert was appointed Senior Lecturer in 1957 and in 1964 and 1965 he was seconded to the S.A. Institute of Physics to write a textbook on physics for high schools.

Professor F. Sebba, Professor of Physical and Inorganic Chemistry and Head of the Department of Chemistry, including Biochemistry, visited Australia, the United States and Iceland in August. He lectured in Melbourne and took part in a research conference in New Hampshire. After lecturing in several institutions in America he flew to Iceland to discuss ion flotation there.

Professor G. L. Isaacs, Head of the Department of Mathematics at Wits since 1960, leaves the University in January for an 18-month appointment as Visiting Professor in Mathematics at the State University of New York. He joined the staff of Wits in 1952.

Dr. S. Shippel, M.B. B.Ch. 1940, M.D. 1956, Senior Lecturer in the Department of Pathology and Microbiology, has been appointed an Associate Professor from January 1, in recognition of his long and meritorious service on the staff of the University.

After qualifying in medicine Dr. Shippel joined the Department of Obstetrics and Gynaecology as a lecturer. He was appointed Assistant Obstetrician and Gynaecologist on the joint staff of the Johannesburg General Hospital and the University in 1961. In that year, however, Dr. Shippel, who had decided to obtain a specialist qualification in pathology, was appointed Senior Lecturer in the Department of Pathology and Microbiology at the University.

Dr. Shippel was awarded the degree of M.D. by the University for a thesis on "The ovarian theca cell."

Professor Karl Tober, Head of the Department of German, has helped to found the South African Association of German Studies (Südafrikanische Germanistenverband — S.A.G.V.). The constitution has been signed by members of all the German Departments of the South African universities and university colleges — with the exception of Rhodes University — and a representative committee has been elected.

It is proposed to establish the first periodical in Africa for German Studies. Prof. Tober will be the editor, assisted by Prof. J. Rosteutscher (U.C.T.), Prof. W. Boeddinghaus (O.F.S) and Dr. Haller (Stellenbosch).

Professor B. J. S. Wimble, Dean of the Faculty of Commerce and Head of the Department of Accounting, has been given an award by the Port Elizabeth Chartered Accountants (S.A.) Students' Society. In the society's opinion, he contributed most to the profession of accountancy in this country in 1965.

The society said the award was made for his contribution to the profession both in published articles and through the high standard of the training which the Department of Accounting at the University offers prospective accountants.

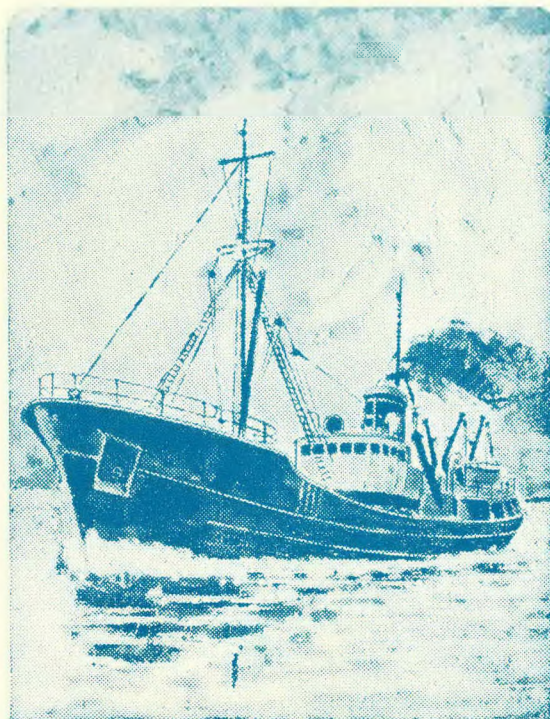
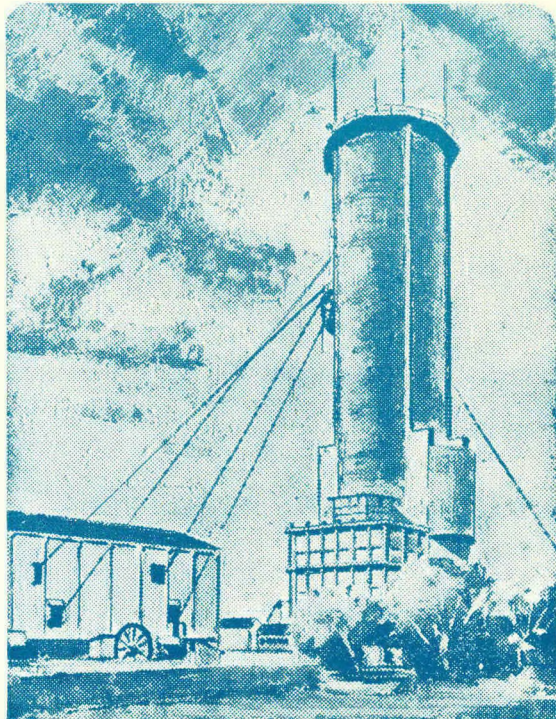
