

#### HOSTELS PARTLY FENCED OFF

#### 1. TOKOZA

Fenced off on the front only, ie., the side facing the main road. Not fenced at the back.

#### ALEXANDRA (MADALA)

Fenced off with mesh wire with barbed wire on top. This hostel was fenced off by the Council ages ago, before the violence. However, the fence is not effective because big holes were opened by the hostel inmates at various sections of the fence around the hostel.

#### B. SOUTHERN NATAL REGION

All the hostels in this region are not fenced off and are the main sources of violence. They are : -

- 2. UNIT 17 UMLAZI
- 3. UNIT T O UMLAZI
- 4. GLEBBELANDS

#### NORTHERN NATAL (EMPANGENI)

Hostel in this region are ANC supporting and are also not fenced off. They are -

#### NATAL MIDLANDS

BRUNTVILLE HOSTEL

This hostel is the main source of violence in the region and not fenced off.

# C. TOWNSHIPS FENCED OFF DURING STATE OF EMERGENCY (1984 - 1986)

#### EASTERN CAPE

- 1. NEW BRIGHTON
- KWAZAKHELE

These two townships were cordoned off by means of barbed wire during 1984 - 1986. Security Police blocked all the entrances and exit points 24 hours a day. Scores of activists were arrested during this period.

#### WESTERN CAPE

#### 1. KTC Squatter Camp

The above squatter camp was cordoned off by barbed wire during 1984 - 1986. Scores of ANC supporting activists were detained. Vigilantes were allowed by the Security Police to attack the community. Police kept heavy presence 24 hours a day.

#### AREAS PRESENTLY FENCED OFF

#### 1. PHOLA PARK - TOKOZA

Barbed wire surrounds the township. A chemical substance was poured over the wire to prevent members of the community from coming near it. Security police block all entrances and exit points from the township 24 hours a day. Security forces patrol Phola Park on a 24 hours basis.

# REPORT TO ALLIANCE OPERATIONS COMMITTEE TO BE HELD ON 13 FEBRUARY 1992

NB This report is not exhaustive but is intended merely to prepare delegates to the Operations Committee. It will be supplemented at the meeting with verbal and/or written inputs.

#### 1. GOLDSTONE COMMISSION

#### 1.1 SADF investigation

This Commission has started already. It has broadened its terms of reference to include the activities of the SADF prior to July 1991, provided it can be linked to violence currently taking place. Evidence is already being heard. However, it does appear that there are difficulties being experienced to gather together decisive evidence. Much more work is required to co-ordinate information and investigations on our side. The strategic importance of this Commission needs to be stressed as success will establish what we have been saying as accurate while failure will severely damage our credibility.

#### 1.2 Mass demonstrations

This Commission will deal with marches, demonstrations, gathering and is likely to produce recommendations which will be the basis of future legislation. Draft submissions have been prepared on behalf of the Alliance and we need to provide comment and feedback to enable this to be handed to the Commission.

#### 1.3 Taxi wars and train massacres

At this stage, the Commission plans to focus its inquiry on the Western Cape taxi situation. It has not yet started.

#### 1.4 Thokoza

This Commission is well under way and appears to be making satisfactory progress. A verbal report will be presented.

#### 1.5 Other Commissions

Judge Goldtone has raised with me, on a confidential basis, a view from his Commission. A verbal report will be presented. A fuller meeting between members of the Alliance and the Commission is planned and we need to prepare for it.

#### 2. NPC

#### 2.1 DISPUTE OVER "PRIVATE ARMIES"

The IFP has raised a dispute of MK being a private army. The Alliance is to respond by 10 February 1992. Thereafter, it is

expected that the dispute will probably not be resolved and will go to arbitration. The implications of this are obviously quite considerable and we need to consider appropriate preparations.

#### 2.2 <u>Dispute over dangerous weapons</u>

We have initiated steps to declare a dispute over dangerous weapons. The government has until 14 February to provide us with the text of its draft proclamation on dangerous weapons for us to consider. It has attempted, unsuccessfully, to link their obligation on this matter to the issue of MK.

#### 2.3 SADF Code of Conduct

Progress has been made in this regard. The government has not formally tabled a position with regard to mechanisms and there are informal report of serious tensions in their ranks. The IFP has stopped participating in this committee because of their dispute regarding MK. However, they attend as observers. We need to consider the progress made, as well as the relation between our work here and that to be done in CODESA.

#### 2.4 Police Board

The SADF Code of Conduct committee has ultimately been given responsibility to finalise the NPC nominations for the Police Board. It will have altogether 22 members of which 11 are to be nominated by the NPC. Altogether 47 nominations have been received from various parties, which includes 9 from the alliance. This matter is to be considered on 10 February.

As a related matter, a "think-tank" of police specialists has been convened to provide research and inputs which would assist with further work regarding policing.

#### 2.5 Proposed Bill on "internal peace institutions"

The government has made available a draft bill on this matter. There appears to be many problems with this Bill and a memorandum has been written pointing out its problems. The NPS failed in an attempt to amend it by consensus. This is an urgent matter and requires detailed input. The NPC has circulated copies of the draft Bill for comment.

#### 2.6 <u>Socio-economic sub-committee</u>

This committee has not made any significant progress and our representatives were both absent in the last meeting. Serious decisions are required to stimulate action here.

At a regional level, there are very interesting developments, particularly in Border/Ciskei, Natal and Western Transvaal. These will be discussed under regional reports.

#### 2.7 Publicity

The two advertising agencies appointed have had some difficulties in getting things off the ground. In addition the sub-committee

itself has been slow in producing the translations, proper versions of the Accord etc.

A discussion of its difficulties are required as well as advice to our delegates in this committee. In addition cde Sakie requests us to consider whether the ANC DIP draft of the media charter should be taken up entirely at CODESA or whether part of it could be taken up through the NPC. The item "media charter" is still on the committee's agenda as a result of our discussion prior to the signing of the Accord.

#### 3. NPS

#### 3.1 Alliance JWCs

JWCs now exist in Natal, W Tvl, Wits/Vaal and Border. The ANC organising department is conducting an intensive programme of visits around the country and more JWCs are to be established shortly.

#### 3.2 RDRCs and LDRCs

Contrary to inaccurate press reports, RDRCs exist in Natal/KwaZulu, Border/Ciskei, W Cape with Wits/Natal to launch on 7 February.

LDRCs exist in Cathcart, Mooi River, Umlazi, Soweto, Thokoza, Germiston. Processes are underway from the NPS to establish further RDRCs in N Tvl, E Tvl, W Tvl and OFS by middle March. LDRCs in progress are Innersdale, Phalaborwa and Zebediele.

Further progress in this regard is also being made at RDRC level.

#### 3.3 Infrastructure

The department of Justice is proving to be a very problematic source of fund. To date they have not provided any financial resources to regions or for facilitators or indeed to pay legitimate expenses.

They have now proposed that rather than set up offices with full-time secretarial support in RDRCs, that the SA Communications Services (formerly Dept of Information) should be used. This is crippling to progress and has serious implications and needs careful consideration.

#### 3.4 Training Strategies

The NPS has established a Training Project Committee, convened by Jayendra Naidoo with Peter Gastrow (DP) and Deon Rudman (Justice) as members. Its brief is to formulate a training strategy, interview available training group and to table detailed recommendations.

A plan has been drawn up providing for negotiations training, facilitator training and research. In addition, an education component for socio-economic development is being considered.

Feedback is required on the framework of this plan and suitable training groups - particularly for regions.

We also need to consider the suitability of certain funding sources which we have been offered.

#### 3.5 Taxi Wars

The NPS is considering a mediation initiative to bring together authorities, communities and the taxi industry to formulate ways of reducing the potential for violence associated with this industry. Discussions are in progress with the Goldstone Commission to co-ordinate efforts.

#### 3.6 Initiatives with AZAPO, PAC, NACTU, CP and AWB

As none of these groups are participating in the Accord, invitations for meetings between these groups and the NPS have been sent out.

Bennie Alexander of PAC is participating in the discussions in Ennerdale. The NPS will be meeting with CP/AWB members in a meeting in Phalaborwa on 8 February to discuss local matters.

#### 4. FUNDING

#### 4.1 JWCs

As JWCs are set up, the need for funding emerges more strongly. We have received budgets. However, we do not have direct access to funds.

#### 4.2 Complaints office

We have developed a proposal for a complaints office network. Progress on this has stopped as funds are not forthcoming.

#### 4.3 Commission

We have received a request for funding for special investigation purposes to enable our legal representatives to get evidence for, in particular, the SADF Commission. Here again, the sad song remains the same.

It is vital that we get access to funds urgently. There are certain avenues which we could explore, in particular the funding provided by the US Congress for infrastructure could meet the needs of JWCs and the complaints office. However, this needs approval from senior ANC leadership.

#### 5. PEACE ACCORD HANDBOOK

A draft handbook has been drafted for use by ANC/COSATU/SACP activists. It needs to be considered in an appropriate forum. We need to discuss its future.

#### 6. RELATIONSHIP WITH CODESA

The functions being conducted by the Operations Committee, arising out of the Peace Accord, overlaps with the brief of CODESA with respect to at least two CODESA working groups, viz. working group 1 dealing with climate and working group 3 dealing with interim government. With working group 1 the overlap is particularly sharp as a result of that group's brief to ensure the "successful implementation of the Peace Accord".

It is obviously that there needs to be a relationship between the activities of the Operations Committee and ANC/SACP delegates to the relevant working groups.

#### 7. CO-ORDINATION

There is a need to review our structure of co-ordination. It has been difficult for the Operations Committee to meet regularly particularly because of the busy work schedules of various members as a result of CODESA and other tasks.

There is a need for a smaller executive structure that can operate formally on a more regular basis.

In addition, the establishment of regional JWCs and the RDRCs has created a new demand for regular advice, consultation and coordination. We need, therefore, to make appropriate changes to our structure to suit the circumstances.
