

MEMORANDUM

TO: All Regional Secretaries

DATE: 23 October 1984

RE: NATIONAL EXEUCTIVE ASSESSMENT AND REDEFINITION OF OBJECTIVES

The following categories are suggested as guidelines for an assessment process within the National Executive Committee and a redefinition of objectives.

Broadly 3 categories:

- 1) Administrative
- 2) Organisational
- 3) Political
