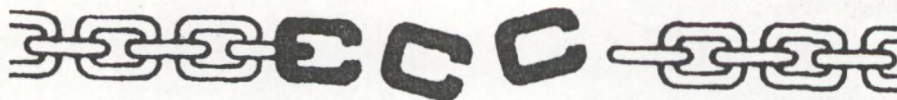

The END CONSCRIPTION CAMPAIGN, formed in November 1983, is leading the white South African community in anti-military and anti-apartheid work. Largely because of ECC activities, the number of young men refusing service in the South African Defense Force has increased from

1,500 in 1984 to over 7,500 in 1985.

The ECC has initiated "Stop the Call-Up" and "Troops Out of the Townships" campaigns, involving thousands of participants. As a result of ECC's anti-apartheid activism, ECC leaders were detained by the South African police last September.

*GAVIN EVANS, 25, is a white South African journalist and law student who has publicly refused to serve in the South African Defense Force. He is on the Executive Committee of the ECC in Johannesburg and wrote for the Rand Daily Mail before it was banned by the South African government last year. Gavin is the son of Bishop Evans of Port Elizabeth, South Africa.*

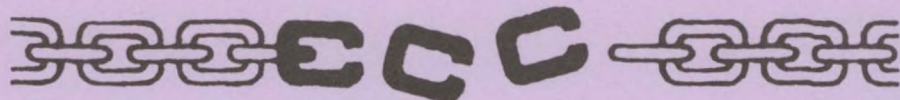
