

Dear Dr. Paton,

I believe that when you were in Cape Town you talked to Miss Spilhaus of the Cape Town Defence and Aid about an emergency loan which NUSAS recently made to Mr. George Mbele's wife, on the understanding that Cape Town Defence and Aid which in due course repay NUAS for the money which we have advanced to Mrs Mbele.

I expect you already know most of the details of this particular case. Mr. Mbele was a student at the university of Natal and was detained under the "90 Days Plus Clause" of the 1963 G.L.A. Act. His wife who is a professional nurse applied through the courts on a writ of habeus corpus for his release. Her case failed and she had to pay costs. Fellow students of Mr Mbele tried to assist by raising funds and when they found they could not raise enough to meet the court costs applied to NUSAS urgently for assistance. I advised the Durban students to apply to Natal Defence & Aid at which stage they phoned me and informed me that Defence and Aid does not exist in Natal, I then went to Miss Spilhaus and she did not deny that the Durban Defence & Aid did not exist. Because it would take some time for Cape Town Defence & Aid to assist Mrs Mbele I suggested that we should give the money to Mrs Mbele ourselves and then apply to Cape Town Defence& Aid for a refund.

However Miss Spilhaus then wrote to me to tell me that the Durban Defence & Aid did exist and that this committee was the one which should be dealing with Mr Mbele's case. I am therefore approaching you to find out if it would not be possible for the Durban Defence & Aid Fund to refund NUSAS the R40 which it sent to Mrs Mbele.

ACADEMIC FREEDOM

I attach to this letter two photostats sent to me by Mr. W.T. Mhlambiso who acted as the contact between NUSAS and Mrs. Mbele. From these you will see that Messrs. Arenstein and Fehle were the attonneys who handled the case. I think that if you were to contact them they would be able to give you more of the financial details of the case.

I look forward to hearing from you about this.

At the same time, since you are an honorary Vice-President of NUSAS, I hope you will not consider it an impertinence if I suggest to you that it might be well worthwhile to bring a couple of Natal students on to yourDefence and Aid Committee in Durban. Adrian Leftwhci, Peter Horwitz and I all work for the Defence and Aid Committee down here and whatever the value of this has been to the Defence and Aid committee it has been of value to NUSAS particularly as far as assistance to Fort Hare students is concerned. Since Natal students are at the moment taking quite a beating for political offences I do think it would be very useful from our point of view to have someone working on your committee. Possibly your committee might find the students themselves of some use; they are quite often able to to work which other people arent so willing to do.

The people I would recommend as possibilities to serve on the committee are as follows:

- 1. Darkie Sepopedi, President of the SRC at UN.NE a fourthyear medical student with a Bsc. from Fort Hare.
- 2. Thami Mhlambiso, former president of the SRC of UN.NE and a former Vice-President of NUSAS. I am not sureiif Thami is still a student but I think you know him already as an able an intelligent person.
- 3. Bala Mudaly, a UN.NE student with a B.A. and a U.Ed. who is Director of Studies on the NUSAS executive.
- 4. Tony Levy, former President of the SRC at NN.D., at present Director of Training College affairs in NUSAS, and probably destined for a high position in NUSAS.
