FEDTRAW RESOLUTIONS PASSED AT FIRST CONFERENCE DECEMBER 1984

BLACK CHRISTMAS

Fedtraw supports the call for a Black Christmas. We call on members to remember the suffering of our people during this time. We remember those detained, those killed those who have lost their jobs, those who are being removed, those harrassed by soldiers in townships.

We ask our members not to fill the pockets of the shop owners who use Christmas to exploit us. We ask them to celebrate Christmas with love and commitment towards their neighbours and their community.

RESOLUTION 2 COST OF LIVING

WE the women gathered here at the first conference of the Federation Of Transvaal Women,

NOTING THAT

RESOLUTION 1

- 1. Women in the townships have the burden of high food prices, and high rents
- 2. While the prices of rent and food increases daily, wages remain low

HEREBY RESOLVE TO

1. campaign against and organise around high rents, high food prices, bus fare increases and GST. 2 unite in action against community councils and all puupet bodies.

RESOLUTION 3 EDUCATION

We the women gathered here on this historic day of the launching conference of Fedtraw recognize that our daughters are victims of sexual harassment at schools and are forced to drop out of school as a result of unwanted pregnancies and further noting that some of our people have been deprived of an education and our children are engaged in a just struggle against an inferior and irrelevant education.

Herby resolve to actively support:

- their demands for democratic SRC's
- total elimination of the age limit
- -the fight against sexual harass ment and sexist attitudes in our society

-creation of literacy programmes where they are necessary

We further resolve to actively engage ourselves in the education chater campaign for a democratic and relevan education for all

RESOLUTION 4

FORCED REMOVALS

We at this first conference of FEDTRAW have seen that

1. many of our women throughout South Africa are fighting bitter struggles to prevent forced temovals

- 2. that they refuse to move because they know that there is only poverty and marvation in the bantustans and that there is much repression in these areas.
- 3. that if they move into the hantustans they will like their South African citizenship

WE, The Transvaal women noting the activity of the SADF in the townships, and noting the new conscription laws for so called Coloured and Indian men, and further noting that our men will be forced to defend and oppressive and unjust sugstemreject any participation by our men in the SADF's + brutality.

RESOLUTION 6 WOMENS CHARTER

We at the conference have recognized the value of the WOMEN'S CHARTER for us in these times, just as the women of the 1950's experienced great hardship, so do we today.

Although some things have changed since the Charter was adopted, such as, forced remobals, independent homelands the spirit of the charter lives on in the hearts of our women.

The charter represents our history, and remains the basis of our position on the organisation of women

We therefor propose that his conference adopts the WOMES'S CHARTER
