Resolutions for consideration at Conference should reach the Secretary not later than the 19th. February, 1955 to allow of circulation to participant unions.

- (b) in order to provide funds to meet the costs of this Conference, to forward to the Secretary a delegation fee of 10/- for each delegate attending. This fee will cover refreshments and a light luncheon on both days of the Conference. It will be appreciated if this fee may be forwarded as early as possible.
