And at that stage were there a number of men in your immediate vicinity at the car? --- Yes, there were students all round me as far as I could see, but I did not look behind me. I did not have a chance to look behind me.

You see what I am suggesting to you is that at that stage, if they had really intended you any serious injury. they had an opportunity of preventing you from driving, by just keeping your arms from the steering-wheel, is that not right? —— They would have had to stretch in quite far to get my left hand, my left arm.

Look, I don't want to make a mountain out of a molehill unnecessarily, if I just ask you to cast yourself back to that day, you say that someone managed to grab your arm?

——— Grabbed my shoulder.

And the window was down? --- Yes.

Now what I suggest to you is this, if there was any serious intent to injure you, at the very least the person who was grabbing you or holding your shoulder could have held your body and prevented you from driving off if he wished to? —— I do not think that would have been easy, they did injure me 20 they struck me on the eye and on the lip.

You see, you said that you thought that you might be killed, that was your evidence? --- Yes, I said I could have been killed .. (Mr. Allaway intervenes)

What I am suggesting - sorry, I interrupted you, I beg your pardon - what I am suggesting to you is this, in the circumstances that you describe, if there had been any such real intention on their part to cause you serious injury, they were in a position to inflict it but did not do so, do you agree with that suggestion? --- Yes, I agree that they could 30 have possibly even turned the car over, there were enough of

them / ...

them to do that.

Yes, and what was the nature of the injury to your eye? --- They struck me on the side of the eyeball, and the ..(Mr. Allaway intervenes)

When you say they, I am sorry, was it one person or more than one person? —— I do not know, there were several students ..(Mr. Allaway intervenes)

Was it one blow? --- Yes, it was one blow. That blow struck me on the side of the eyeball, and I could not see, there were black - my vision .. (Mr. Allaway intervenes)

Your vision was impaired? --- Yes.

Momentarily I take it? --- No, it was for about a week.

I take it that you would regard that as a fairly serious injury, something that impairs your vision for a week? —— I did not think it was serious amough to go to a doctor.

I see, you see I am just wondering, the State made certain allegations about this particular campus, in relation to the holding of a rally there, and it says in the Further Particulars (on page 17): Ad paragraph 4(q) - It is alleged that the commission of the said acts had the result at 20 Turfloop of causing serious bodily injury to a Mr. Waterman and a Constable Franssen (?), but you are not mentioned. Did you in your police statement suggest that you had been injured? --- Yes, I told them that I had been injured and they saw the injuries.

When did you make your police statement in relation to the day that you were injured? --- About half an hour, possibly three-quarters of an hour later. It might even have been an hour later.

Tell me, did you see any policemen at all at the stage 30 when you say you were being attacked? --- No.

As far as your power to observe was concerned, did you at any stage look across towards the direction of the soccer field at that stage? -- Not specifically, not knowingly.

So your evidence today, I take it, this happened a long time ago so one may be taxing your memory unnecessarily, but your evidence today is that you were conscious of a group of about say at the most 80 persons in your immediate environment?

—— There were other students along the side of the road, scattered around.

Did you observe anything about their activities at all? 10 --- No, they were just standing - they gave me the impression of just standing and watching.

Yes, but the ones that gave you any difficulty, and the only persons who gave you any difficulty, were the persons in the group that you have described? --- The ones that were sitting on the road.

Now, you do say though that there were other persons in the neighbourhood I take it who could have taken part in the attentions that were being directed to you if they wished to?

—— Yes.

But did not? --- I don't know, you see I could not see if any other students came running along.

Well you do not say that because you did not see it?
--- No, I did not see it.

Did you at any stage go back after leaving the place where you had been assaulted, did you go back to the campus? --- Yes, when I reversed the car, I went round through the gate that I had come from, and then I went in again through the other gate.

which is about 100 to 200 yards from the main road, which goes

from Pietersburg to .. (Mr. Allaway intervenes)

Now we understand from some other witnesses that basically there is only one gate to the campus, some witnesses have talked about another gate, may we take it that these are the only two gates by which one can get access to this campus? --- Yes.

By vehicle? --- Yes.

And please tell the Court, about how long did it take you to get from the place where you reversed after you were assaulted, to the other gate where you entered the campus 10 premises? —— It must have taken me a matter of under five minutes.

And when you got there, did you see any police officers at that stage? --- No.

Did you see any students at that stage? --- No. Did you see any problems at that stage? --- No. All was quiet? --- Yes.

And we have heard from other witnesses - well I do not know, I do not want you to possibly guess at this - were you at the campus at all that morning up until lunch time? --- I 20 went straight from my house to Turfloop dam, and then I came back at lunch time just to have lunch, went straight back.

So you were not participating in any lectures or things in the morning? ---- No.

So you cannot speak to the activities that were going on then? --- No.

COURT: Do you reside at Pietersburg or on the campus? --- No, I reside halfway between Pietersburg and the campus on a small piece of ground.

MR. ALLAWAY: So all you can say of the events of that

30
afternoon as they affected you is that you were assaulted in the

manner as you have told the Court, and this caused you to have certain apprehensions, you went in at the other entrance and everything was quiet and orderly? --- At the other entrance, yes.

After entering that other entrance, did you go anywhere else on the campus in order to see whether there were any problems? --- I did not go anywhere to see if there were problems, I went to the office of the groundsman.

And is that where you remained? --- That is where I remained, and a little later, after the police had arrived. 10

What time did you first become aware that there were police on the campus? --- I should say it must have been after 5 p.m.

And you had arrived there, forgive me, I will look at my notes, but can you help the Court, you had arrived there I think you said at 4.35? —— Approximately 4.35, I left the dam at half past four, so it is not far, it must have been about that.

But when you saw the police on the campus, where did you see them, where precisely were they? --- I saw them first 20 at the office of Mr. Klopper, the groundsman.

How many policemen were there? --- I cannot remember if it was one or two.

And did they come along there in a police vehicle I take it, not a Saracen or anything like that? --- No.

And as far as they were concerned - did the policemen have any dogs with them? --- Not those policemen that I saw there.

How long did you remain there after that? --- I suppose about three-quarters of an hour, possibly half an hour - no, 30 it must have been longer than half an hour, because the police wanted / ...

wanted to take a statement from me.

By what time had you left the premises? --- I should say at a guess 6 o'clock.

And forgive me for asking you this, where did you as it were remain after you had got to the groundsman's premises or office, until the time that you finished your statement and left the campus? --- I - after I had spoken to the police at the office of Mr. Klopper, then I walked down to the site where I had been attacked by the students with the police to see if I could recognise any of the attackers.

And just the two policemen and yourself went there? --- No, there were other policemen there.

Already there? --- Already there.

How many policemen at the most did you see on the campus that afternoon whilst you were there? —— I would just have to guess at that.

Yes? --- Possibly ten, I don't know.

Did you see any of them with firearms in their hands?

Did you see any of them doing anything with dogs - by 20 anything I do not mean just holding them on a short lead or something of that sort, but putting dogs onto people or anything of that kind? --- No. The dogs were on leashes.

As far as what you observed of the police behaviour whilst you were there, things had taken a turn of events that did not require them to have to take any assertive action against the students? --- No.

COURT ADJOURNS

COURT RESUMES

CARL DUVAL STRAUB, still under oath.

CROSS-EXAMINATION BY MR ALLAWAY: (Continued)

Mr. Straub, I said before the luncheon adjournment that will we produce a plan. It is not scale but it might assist in following the events at Turfloop. My Lord, I have given my Learned Friend a copy. I am handing that My Lord with one for the witness.

BY THE COURT: Do you want it also made an exhibit?

MR ALLAWAY: Yes, My Lord, if he is able to identify it. 10

It will be made an exhibit. My Lord, if it could be held in such a way that the administration block is on the top right hand corner of the document. Have you got the plan that way? Do you see the administration block at the top right hand corner. -- Yes.

Have you got it. I would like you to look at this document first of all and orientate yourself with it. Is there a road running through the campus in the approximate position shown on the road that is marked the road from Pietersburg town. -- Yes, that is the road that I entered by.

I understand that this document shall be marked Rally B.53. Now looking at this exhibit Rally B.53 I just want to orientate you from the road which you have identified, is there in fact a gate which marks the entrance to the campus on the bottom left hand corner of this document in the direction of where the arrow is pointing. -- Yes, there is a gate, down there.

And could we establish approximately please the compass points on this document, would you say that the road 30 runs through the campus from south to north or east to west?

-- Approximately/...

-- Approximately that road comes in on the west and it runs up to the top right hand corner in an easterly direction, more or less.

So roughly speaking, the road is running from east to west? -- Roughly speaking, yes. It goes slightly south.

And the soccer ground would therefore be approximately in a northern direction? -- Yes.

Now is the soccer ground adjacent to this road as shown on this plan?

BY THE COURT: Have you got it correctly, the gate you say is on the eastern or western side? -- Western, the gates that I entered was on the west yes. On the bottom left hand corner.

Yes, thank you.

MR ALLAWAY: And is the soccer ground on the left, that is if you are driving in from the west, on your left hand side, as you pass along the road? -- Yes.

And is that also a ground which is used as an athletics ground? -- Yes.

And on the right as you come in from the western gate, are there men's hostels in the approximate position shown on this plan, EXHIBIT B.53? -- Yes.

And there are series which appear to be in blocks moving roughly from west to east. -- Yes.

In the right hand bottom corner of the plan, what does that designate? It has got M.Hostel which I am instructed stands for Men's Hostel and M.B.C. above it. Can you tell His Lordship what that means? -- I have no idea.

No idea. Right and the women's hostel are they to the left as you come in from the gate, that is to the north/...

north, roughly in the position which is indicated on this plan? -- Yes.

And are the tennis courts immediately adjacent to the soccer ground, more or less as shown on the plan?-Yes.

And then there is a tuck shop apparently. Do you see it just above the soccer grounds? -- Yes.

And of more importance with reference to the events of the day, do you see a building which is marked, there is printing next to it, Creat Hall? -- Yes.

Is that approximately the position of the Creat Hall? In relation to the soccer ground and athletics ground?-Approximately.

Yes. -- I think the angle of that soccer field is slightly off.

When you say off do you mean that what is shown here, is not as acute as it ought to be. -- I am just trying to make this out. The soccer field is actually further up towards the road, it is nearer to the road. In other words, it is to my right as I am looking at this now.

What you are saying is that the soccer ground is not as close to the Creat Hall as is shown on this plan? --No, the Creat Hall is not adjacent to the end of the soccer ground, it is more, nearer the centre.

I follow. In other words, it is more in the direction where the tuckshop is? -- Yes.

I understand. -- And the fields, in other words, should come up further over to the east.

To the east or to the right? -- Yes.

And this Creat Hall, how many people does it accommodate?

-- I don't know.

Do you think it would roughly accommodate 500 to 600 people? -- Yes.

And are there chairs in it? Normally? -- Well when I have been in there that is for graduation ceremonies, there are chairs, but normally it was used for the diningroom and then there are chairs and tables.

Then next to the Creat Hall, there appear to be some offices. What are they? In the top right hand corner of the Creat Hall? -- I see this is marked S.R.C. offices.

Is that roughly their position in relation to the Creat Hall? -- This plan is not correct because the Creat Hall is attached to the building behind it and that was the diningroom. I see it is marked here "cine hall". That was the diningroom and then there was - at least not a diningroom, that was the kitchen.

You say what is marked as the cinema hall was the kitchen? -- That was the kitchen, yes.

Is this at the time we are speaking about September 20 of last year? -- I am not sure, I am not quite sure when it came into use as a cinema hall and I think it is a Badminton hall. I haven't been there since the alterations. They might be separate buildings like they are now, but as I recall it when I last saw it, they were actually joined. I cannot recall separate offices there.

According to your recollection on the day when you were injured, what is shown as a cinema hall would have been continuous too. That is suturing the great hall? -- Yes, I think so but as I say, I am not sure of the date when those alterations were completed.

And then apparently there is the administration block which / ..

which is in the far, as it were, north-eastern corner of the campus. -- Yes.

And then there are various blocks which are marked men's hostel and things of that sort. I take it that there are buildings of that kind. Please, I don't think that they feature very importantly in what we are discussing here, there are buildings of that kind approximately in relation to this road that goes through the campus? ---I don't think that that is quite right there, that men's hostel.

Which one? There seems to be two. There is a larger one and a smaller one. There is one near the conference of several roads which is the larger one. There is another one lower down immediately next to a road which goes into the road from Pietersburg town. -- This map is very approximate.

Yes, it is only intended to be, not to scale. Alright, and what is the building which is marked H,C,F,E,D,B,C,A?

-- Those are the lecture halls and offices.

Now there has been evidence about another gate. It 20 is a gate which apparently if you enter it, it leads to the rector's office ultimately and it leads to buildings of that kind, it is near the administration block, is that gate to the right of the road which runs through the campus, in other words, the extremity, there is an extremity of this road through the campus, leads onto that gate is it?--Yes, if you enter that other gate you will come in along that road.

What is that gate called? Has it got a name, is it called the East gate or the south gate? -- No, it is the entrance gate to theological school and the White residential/...

residential area.

And the other gate you have spoken about, the one that leads you from the road from Pietersburg is that the western gate, has it got a name of that kind? -- I don't know it by a specific name.

Sometimes you have particular names for gates but this one doesn't appear to have one, is that so? -- Yes, I don't know.

Now where was it that you were assaulted approximately on this plan, could you indicate and then indicate with reference to some writing on it or an arrow on it and then we can make a mark on the official plan. -- It would have been approximately where I have drawn the circle, but as I say this map is very approximate.

BY THE COURT: There is more or less at the M.D. men's hostel? -- Yes, My Lord, but the scales, the positions are not quite right there, there is not all that open - amount of open space there.

Thank you.

MR ALLAWAY: And about how far would that have been from the entrance to the gate that you are coming into? -- At a rough guess, possibly in the vicinity of 300 to 400 yards.

Now I understand that you gave evidence at a Commission of Inquiry into the events of the day, which was held under the chairmanship of His Lordship, Mr. Justice Snyman. -- Yes.

Do you know whether any other university staff members gave evidence at that inquiry? -- I know that Professor Oliver gave evidence.

The rector? -- I believe the rector did, I only went there/...

there to give my evidence and I left again. I didn't attend any of the..

Who was the rector then? -- Professor Boshoff.

Do you know accused No. 6? He could stand up to be identified? -- Yes.

I understand that he was in your department for approximately four years, you were lecturing tohim? -- Yes, he was one of my students.

What sort of a student was he, was he quite a promising student or how did he fare? -- I found him keen, and a 10 good student.

I am not suggesting you should know this, but possibly you might, do you know whether he is a particularly religious man or not? -- No, I don't know.

You don't know about that and I am instructed that there was between you and him a very cordial and co-operative relationship? -- Yes.

As there was I understand with most of the students in your class? -- Yes. There was a very good relationship.

Cood relationship. -- Yes.

And as far as he was concerned, in the course of lecturing to him and that sort of thing, would it be fair to say that you have noticed nothing about his conduct to stigmatize him as being a agitator or a troublemaker or anything of that kind? ~- No.

Now on the afternoon, that you were assaulted, is it correct that the Department of Science apparently has practical classes on various afternoons of the week? -- Yes, the faculty of science has afternoon practical classes.

Right and basically was the curriculum at the

University at that time divided up this way that the mornings

until/...

until about lunchtime were spent in the various lecture halls or lecture classes. -- Yes.

And then in the afternoons, the students, they either play games or if they were required to do so, they went on the practical classes. -- Yes.

Can you say whether or not on the afternoon that you were assaulted, that classes in the faculty of science, these practical classes, were in fact conducted through out that afternoon during the trouble on the campus? -- I don't know, I wasn't there and I cannot remember what 10 the timetable was for that particular time.

I see. My Lord, hereto I don't envisage with respect having to trouble this witness again, but just for the sake of caution may the cross-examination of him be reserved in case it is necessary to recall him. No further questions.

CROSS-EXAMINATION BY MR PITMAN: Mr. Straub, did you actually see that your car window was broken by a rock? Did you actually see the rock? -- Yes.

When you went to Mr.Klopper's office, I am just not clear about this, were the police actually there? -- No.

They were not. They were called? -- Mr. Kloppers phoned them.

If he sent somebody, can you remember did he send a Mr. Wetterman or Witterman or some such person? -- No, Mr. Weterman was one of the people that was involved in the attacks. He was the one that got the stone injury on his face. I think Weideman.

Weideman is it yes. As far as I knew and in my presence Mr. Kloppers, Klopper phoned the Police from his office.

You mentioned something I think about Police dogs.

Did /..

Did you say you saw a Police dog? -- Yes.

And was there a number of dogs? -- I cannot remember how many there were, I think there were at least two. Maybe more, but at least two. There was somethingelse My Lord, that I mistakenly mentioned this morning. I was asked if any of the police had arms out of their holsters and at the time I was thinking of revolvers.

Yes. -- But during lunch hour I recalled that there was at least one policeman with a rifle.

You are talking about this time about 4,45? -- No, 10 that was after when I went down later on after the event to see if I could recognise anybody then there were police in the vicinity with the dogs, that is when I saw the dogs. and that is when I saw at least one policeman with a revolver.

What sort of time was that roughly? -- It must have been in the vicinity of after five sometime, it is difficult to say exactly how much time had passed. Possibly quarter past - half past five.

Thank you, My Lord.

RE-EXAMINATION BY MR REES: You were asked about accused

No. 6 being such a good student. From when to when did you

have dealings with him? -- I cannot remember My Lord when..

Was it for a period of a year or two, three years? -It was a number of years.

And was he at the University all the time or had there been a break in his.. -- I cannot recall, he wasn't in classes from the first year, the second year and the third year. Whether he was at the university all the time taking other subjects or during some of the years when he didn't take...

Was the position that you didn't have a continuous contact/..

30

contact with him, it was a contact from time to time?
-- Yes.

Thank you. You were asked about the rock that was thrown at your car. Would you describe it please? -- Well all I could see was a rock in a hand.

Big one, small one? -- No, I would say a rock that would fit comfortably in one's hand, possibly the size of three chicken eggs or something like that.

NO FURTHER CUESTIONS

ARTHUR MILLIE Duly Sworn States:

EXAMINATION BY MR REES: Mr. Millie, are you connected to the University of the North at Turfloop? -- Yes, I am.

In what capacity? -- I am an electronic technician.

On the afternoon of the 25th of September 1975, shortly before five o'clock, were you a passenger in a motorcar of a Mr. Wetterman? -- Yes, I was.

It is spelt We term an. Can you just tell the Court what happened on the campus that afternoon? -- We left work and drove back on the road that leads out from the campus, one of the two roads and while we were proceeding out we saw a group of people.

Would you just speak up loudly so that we can hear you in the back of the Court please. -- A group of people sitting and standing on either side of the road.

When you say a group of people, were they Blacks or Whites? -- They were Black people.

Yes? -- And when we got near them one of them walked out towards the middle of the road and started waving his hands trying to flag us down, but I said to Mr. Weterman keep going and we just carried on through and when we were into the crowd it was about 10, 15

yards/...

yards, then stones started to be thrown at the car, breaking some of the windows and we drove through and we passed through the first group of people and when we were coming out of the main campus gate there was a group of five or six students on the right hand side of the road who threw a stone which hit Mr. Weterman on the face.

Why did you consider it necessary to tell Mr. Weterman to keep moving as it were? -- Well I am afraid it is just a thing that I think is safest.

What were the circumstances there? -- Just people sitting around either side of the road and I just said, keep moving, I didn't think of it, I didn't know why they were trying -why this one person was shaking his hands at us.

Yes, and could you just describe the nature of the injury which Mr. Weterman sustained there? -- He had a very bad injury on the right side of his face, on the cheek.

And the car, was that damaged at all? -- Yes, the side windows were broken and there were several dents all around the car.

> Were both you and Mr. Weterman White persons? --Yes. Thank you, My Lord.

CROSS-EXAMINATION BY MR ALLAWAY: Mr. Millie, the road that you were travelling on, if you would please look at EXHIBIT Rally P53. It is not a document I think you have seen before. If you hold it in such a way please that the administration block is on the top right hand corner, do you have it that way? -- Yes.

. Now there is apparently a road shown on this - I am going to call it a plan, which runs through the campus. -- Yes.

Coming / ...

Coming from Pietersburg town? -- That is right.

Is that the road you were on? -- Yes.

And in relation - there is a gate apparently in the direction or near this part where the arrow was pointed to on the bottom left hand corner of this plan? -- Yes.

You had come into the campus through those gates had you not? -- No, we were going out from the campus.

Out from the campus. And was it approximately in the vicinity of that gate that the stone was thrown who injured your companion? -- Yes, that was the point.

About how far were you from the gate at that stage?
-- I would say 20 to 30 yards.

Still on the campus? -- Still on the campus.

Now the place where the earlier incident had happened, where a man had come onto the road in front of the vehicle and as it were, tried to flag you down, and the vehicle had gone on, where is that spot? -- That spot is shown where you've got a sort of a crossroad by the administration block.

I see, that is just to the - where these various roads lead to. -- It is the top right hand corner.

And what sort of vehicle was your companion, Mr. Weterman, driving then? -- He was driving a V8 500.

What sort of speed do you think you were doing when you approached this man who stood in the road? -- About 15, 20 miles an hour at the most.

Did he have to jump out of the way? -- No, we slowed down.

Did he have to get out of the way? -- No, he walked towards the road, but he didn't come to the left hand side of the road, he walked more towards the centre of

the road.

Was he in the path of the vehicle at any stage? --No, he wasn't.

Not? -- No.

It didn't occur to you that he might have misinterpreted your action? -- No, he was more or less in the middle
of the road and we had easy access to the left hand side.

No but was he on what you called the road, that is the path that the vehicle would have taken in the ordinary course of events? -- No, he wasn't.

How wide is this roadway through the campus at that point? -- Enough to take two cars.

Is it tarmac? -- It is tarmac.

Now was the man standing on tarmac as you approached him? -- Yes, he was on tarmac.

I see, and you say that he motioned to the vehicle, in what sort of way did he motion to it? -- Just waved his hands, I didn't take that much notice, at the time.

And what you say is this, there was sufficient room on the tarmac for the car to avoid him, but the car didn't 20 come to a stop? -- No, we just kept going. He was standing to the right hand side of the car, he didn't move right across in front of the car.

Alright. Did you say anything to anybody. I am not suggesting you did by putting this question, but you, did you say anything to any of these Black persons whom you saw on the campus whilst driving through? -- No.

Nothing at all? -- The windows were wound up of the car, anyway.

And did you see any policeman at all? -- No, I never saw.

At any stage? -- No, I never saw any policeman.

After Mr. Weterman had been injured, -- Yes?

Did you go with him? -- Yes.

To a place where he was probably attended to?-Yes, we drove outside the campus and an American who
is working at the university...

I don't want to interrupt you, but where were you taken? That is all I am interested in.-- We went to a doctor on the campus.

You went to a doctor on the campus. Who was the doctor? -- I think it is a Dr. Steyn. I am not sure.

And to do that, did you drive back along the road you came on, or did you go right around? -- We drove right around in the other road.

And I understand there is another entrance to the campus, some people have called it the main entrance, it is the entrance to the administration block. Is that the one you went in? -- It used to be the main entrance as far as I know.

Is that the one that Mr. Weterman drove in? -- Yes.

And he got attention I take it, somewhere in the vicinity - was it the administration block or where? -- No, it is the housing accommodation is off the, sort of on the right hand side...

That is where the Whites are accommodated? -- Yes.

And when you went along that section of the road, coming into what you call the main entrance to go to the White accommodation block, was there any trouble with any students or anything of that kind? -- No, there was nobody around.

It all seemed quiet in that section? -- Yes.

Please tell His Lordship what time was it, do you think that you would have been, have seen this man on the road?-- Well it must have been shortly after quarter to five. Because then it is when we actually left work.

And what had you been doing there that afternoon?
-- Well just ordinary work that is all.

Were you just doing ordinary work? -- In the instrument workshop.

Is that anywhere near the soccerground? -- No, in fact it is right at the sort of one end, one corner of the University.

Can you speak of any events at the campus earlier that afternoon? -- No, I cannot.

You know nothing about it? -- No.

From your personal knowledge? -- No.

So from what you know, does Mr. Weterman know anything about them from his personal knowledge? -- No, he was in the workshop with me.

Thank you very much.

CROSS-EXAMINATION BY MR SOCCOT: No questions.

CROSS-EXAMINATION BY MR PITMAN: Was there at any stage anybody in the road in front of your car? -- Yes, there was at one stage, as we passed through the groups, well I presume they were students, closed around the front of the car.
