Dear Objector community,

Since I received my first issue of The Objector in January, and while I have been planning to write you and subscribe, several earthquakes have occurred (and I am not referring to the several we have experienced last week in this part of California)! And the posture of resistance seems as relevant as ever.

President De Klerk's remarks of February 2 had to have been prepared for by many smaller, and some less visible, changes. For this type of change the incremental ones had to add up to both a weakening of the capacity to maintain the status quo and a strengthening of hope in all parties that something other than destructive deadlock was possible. I regard the work of the draft resistance movement as contributing to both sides of that account.

As I wrote the State President in the enclosed copy: "In my view their refusal has helped make the old military non-solutions untenable, and their forthrightness and courage have added to the growing confidence felt by many and expressed by you that a new cooperative order can be built in your country."

I was a draft refuser and prisoner myself, in the United States, 1968-71, and have tried to appreciate the connections of such refusal to political change. When I heard of Mr. De Klerk's remarks of February 2, I recalled the greeting that he had received from 800 young people in the draft resistance movement upon his inauguration. We can be confident that the clear stands taken by the refusers have played a part in the recent developments, though we will never know how much a part.

Dear Mr. State President,

Amidst the congratulations that are rightly being directed to you from many quarters, including from myself, for your recent inspiring words and deeds, I want to tell you that I also congratulate those who have risked and often served prison terms for refusing to participate in the armed forces of the R.S.A. They have refused to support the attempts to use military force to solve what it never can.

In my view their refusal has helped make the old military non-solutions untenable, and their forthrightness and courage have added to the growing confidence felt by many and expressed by you that a new cooperative order can be built in your country.

I have been told that a hearing was scheduled for the end of February in the case of David Bruce, and that four other refusers are to be tried shortly for these offenses.

Please consider whether or not the spirit you showed in releasing the ANC and other prisoners might also be extended to these, whose crimes, if their refusals are designated as such, are of non-violence. Recalling my own imprisonment in the United States for similar refusal, I believe that their work, whether in prison or out, will be for cooperation and peace in your land, but it seems both wise and gracious to let them choose freely where to give their service.

Dearest Jacques,

How are you doing? I am so sorry for the silence from this end. I have thought of you often and I get your news from Paul - and I've even thought of writing (big deal and thanks for nothing). Sorry, but life has been hectic and I have scarcely been holding the edges together.

I hope you are enjoying London and feeling glad to be there. It must have been great having Ali to hold your hand for this first month and I'm sure you will miss him.

Jacque I did fax some stuff through to COSAWR, inter alia, a memorandum that we wrote to the ANC on including objectors in their negotiations around the definition of political prisoners, an update on the process leading up to the relaunch of ECC and the Release Objector Campaign and an update on those objectors facing trial. I also asked Dave to try and contact Laurie about when he would be over and so I hope Dave got back to you on that. Richard and Anita are going to be over at the end of March and will be overseas for about 5 weeks.

Following the lifting of the restriction order on 2 February, we have managed to get ECC branches going in Cape Town, Johannesburg, Durban, Pietermaritzburg, Stellenbosch, East London and Grahamstown, and have started discussions about the feasibility of establishing branches in Pretoria, PE and Bloemfontein. We have also launched a Release Objector Campaign, which has already received a fair amount of publicity about the issue. In a weeks time we have our first national ECC meeting which will have reps from all the branches and then in May we are planning a national ECC conference. Both the national meetings will be crucial in charting the way ahead for ECC.

The Release Objector Campaign was launched with a candle light march in Durban attended by about 500 people. They went from the City Hall to Natal Command where they delivered some demands. The next night Jhb held a similar march from City Hall to the park opposite Wits Command. There were about 400 people on the march and we ended with a short meeting, addressed by Judy, Saul and Doug with Chris chairing. CT launched their campaign with a candle light vigil outside the Castle. They built a replica cell and had people in and around the cell throughout the night. Grahamstown had a picket and vigil to launch their campaign.

Jacque it is difficult committing ourselves to priorities and strategies at this stage. ROC has been our immediate priority and we saw it serving a dual role, namely raising the issue of objectors as well as helping ECC get off the ground, consolidate itself and so be able to look ahead beyond this campaign. Dave is currently travelling around the country running workshops on the way ahead, and the thinking from all those workshops will be pooled at our national meeting next week. So the thoughts and ideas I will give you now have not been confirmed as ECC policy on the way ahead.

Our immediate priority is making sure that objectors are included in negotiations around the definition of political prisoners. We argued in our memo to the ANC that a possible general amnesty towards political prisoners should include objectors. Our demands for this campaign are:

* the immediate release of jailed objectors

* the safe return of exiled objectors and whilst conscription still exists, the option of alternative service for them.

* a moratorium on all objector trials, pending the abolishing of conscription or the introduction of a system of alternative service.

We plan to put pressure on the government both through campaign work, and through lobbying work.

Re ANS: We thought that we do not want a call for ANS to become central. Our call is for the release of objectors. At the same time we need to be putting concrete form to our demands otherwise they will come across as just being rhetoric. We therefore need to point out that all the objectors have been willing to serve in non-military ways and as an interim call, we must call for a system of ANS.

Beyond the ROC, there is not a great deal of clarity. However the following thinking forms part of the workshop so might be of help. We need to analyse why ECC was so successful in the past. The cornerstones of the 1980's were militarisation, new apartheid (tricameral parliament, etc) and broad mass based opposition. ECC was able to link directly into these issues. Now however militarisation is no longer a very relevant issue to organise around and new apartheid is a thing of the past. The current issues are building the future, with a strong stress on reconstruction and policy formation. If we are to have any effect, we need to pick up on both these issues.

The form this might take, is a "10 point plan" for ending conscription and facilitating national consensus about conscription/civilian service in a post-apartheid SA. We need to be lobbying government with a step by step programme for ending conscription and we need to be facilitating discussions about future scenarios.

The consensus which seems to be emerging is that we should call for a professional army and a volunteer civilian service. To conscript the entire population would be a bureaucratic nightmare and would produce an army far too large for SA's needs. There will certainly be advantages in making young people serve the

country in some way, but the dangers involved in a coercive system probably outweigh this. However we should not just push for an end to conscription but should shift our emphasis to promoting a voluntary civilian service for reconstruction. One of the issues all organisations have to confront is how to become more non-racial and this kind of programme could facilitate this. It may be that ECC doesn't have a long life span, but it is important that we remain strong to provide continuity and to facilitate white involvement in this transition period.

In this process, ANS has effectively diminished as a priority. The current system of conscription is still based on the old nation, and the racial definition concept of white conscription makes the current system unacceptable, even if there is a system of ANS. With the possibility of exiles returning and with a number of trials coming up, we need to be stressing that the power dynamics in the country still remain and as long as they do so, people will continue having objections to service. if this is not stressed, the validity of objectors' stands will be weakened, because of the changed role of the SADF in the last year. ANS therefore becomes very much an interim demand to assist in the total phasing out of conscription. Our emphasis is therefore to provide a realistic programme for ending conscription, with ANS being merely one of the steps en route to that goal.

- 2 other issues that are relevant for an update are;
- the proposed trip to MK by military people, ECC reps and conscripts. The trip has been reformulated as military meets military as opposed to conscript meets soldier, so the delegation will include military personnel, Willem Steenkamp, etc. The visit is due to happen on 6 April.
- the hunger fast by political prisoners raises very difficult questions for us. We cannot call for the objectors to be treated as political prisoners and then shirk this issue. At the same time, the reality of David and Charles' positions needs to be taken into account. Neither are there as accountable activists, they are both in very hostile and isolated environments with no support base in working through the issue - but we still cannot remain silent. The consensus which seems to be emerging is that we cannot in any way pressurise them or the awaiting trial objectors to be part of the hunger strike. At the same time we need to be keeping them informed of developments and they need to be given the chance to respond themselves in some ways, so that we are not always just speaking on their behalf. The idea of a solidarity fast has come up (strongly pushed by Ivan!), but general feeling is that we should not do anything specific to objectors. Instead we should join wider actions planned by the Hunger strike committees and raise the issue of objectors as pp Hopefully David and Charlie's positions will be there. understood by them. Thus a solidarity fast would not focus on objectors in themselves but should be a broad support action for all political prisoners.

Jacqui, Dave has raised the issue of returning exiles in the different workshops he has been running and everywhere the idea has been met with great enthusiasm, with people wanting to support and work with COSAWR on any plans. The government is very much in a conflict resolution mode, seeming to anticipate conflict areas before they arise and alleviating problems before they become an ongoing source of embarrassment for the state. Thus although they are pursuing charges against objectors it is very feasible that a mass return would rattle their cage and may provide sufficient pressure to force a change. If they try to charge people it is entirely possible that local objectors could object on mass, so further forcing the issue. Another issue that has been raised is the possibility of an ANC objector facing trial. I am not sure that they would want the embarrassment of dealing with exiled objectors and so a public return might be a very expedient way of forcing the issue. When and if they decide to call up and prosecute exiled objectors, broader support actions are very much a possibility.

Jacque I hope some of this has been helpful. Some other priorities would be to incorporate the lessons of the past few months of assessment into the new direction that ECC takes. We don't want to be ECC as it was in 1988, but want to strive to be bilingual, positive focussed, etc. We need to make the shift from protest politics to negotiation politics. For us that means developing a realistic programme for ending conscription and encouraging dialogue about future policies. The area of reconstruction offers us the ability to be part of the concept of nation building, will help us move into a non-racial way of operating and will enable us to include whites in the process of transition.

If you would like more info or thoughts, please phone. I will ask Dave tonight about the workshops he has already run because those could provide more clarity. If you phone tomorrow I can give you that information.

Good luck and please send lots of love and solidarity to the COSAWR meeting. We received their fax re formal relations between the two groups and I will raise it at the national meeting, but I'm sure that from our side we would want whatever contact we can have with COSAWR.

Personal Statement - Nationality and Conscription Status

I was born in Cape Town in 1955, of British parents. I registered as a SA citizen at age 16, and was notified of my call-up for 1973. I deferred my call-up until 1978 by pursuing University aducation.

I decided to resist conscription because I refused to be associated with an army whose mission was to manage apartheid and subjugate the subcontinent. I received my call-up papers for 4/1.78. On 3/1.78 I left SA for Swaziland, using my SA passport. While in Swaziland I took a UK passport and then travelled to the UK in February 1978, using that. I have lived in the UK ever since.

I notified the Registering Officer of the SADF of my new address, and of my intention not to return for the forseeable future, in April 1978. I have not since written to them. I have received, yearly, notification of my liability for national service in the subsequent year.

My SA passport expired on 6/5/80 and I have not since renewed it.
My questions are:

- Can I renew my SA passport ?
 Or will I fall foul of the dual nationality rules ? I do certainly not wish to have my SA citizenship revoked.
- Will I be safe to make a visit to SA of 2 6 weeks duration ? If so will it be sensible to use my UK passport ? I assume I am still liable for conscription.
- Is there anything else I should know ?

been unbanned together with many other anti-apartheid

The film "Born on the Fourth of July" is currently on circuit and your presence here would generate considerable positive publicity and debate. "White" South Africa is having to come to terms with the fact that it fought a utterly unjustifiable and futile war at enormous cost to all the people of Southern Africa. And as peace and democracy at last seem attainable, our society as a whole has to begin addressing the bitter legacy of violence that has left so many combatants and civilians physically or psychologically disabled.

If you would consider coming to South Africa, please advise us at your earliest convenience and provide us with a list of




