AN APPLICATION by Mr. lobert Mangaliso Sobukwe, forper president of the banned Pan-Africanist Congress, to leave South Africa permanently on a one-way exit permit, has been approved.

# REFUSED

Mr. Sobukwe was released from Robben Island in May, 1969, after six years detention without trial. He had earlier served a three-year schence for incitement arising out of the 1960 anti-pass compaign.

Immediately after his release he was placed under house arrest, banned from meetings, and social gatherings and confined to Kimberley.


Mr. Sobukwe first applied for an exit permit after his application for a passport was refused in May last year.

In June, the Secretary for the Interior told him he needed the permission of the Minister of Justice to leave Kimberley and had to furnish proof that he would be permitted to enter the United States before his application would be considered.

# DEGREES

The Minister of Justice refused the permission. Mr. Sobukwe's lawyers then made representations to the Minister of the Interior.

Mr. Sobukwe who has three university degrees, has been given a research and lecturing fellowship in African linguisties at Wisconsio-University and two part-time fecturing
