## SPEAKERS NOTES FOR PEACE WORKERS ON POSTCARD CAMPAIGN:

TRANSVAAL

#### 1) PURPOSE OF CAMPAIGN:

- (a) The Postcard campaign is planned with a double purpose first to help bring pressure on UNO to achieve the points of the card, and to publicise them; secondly, to provide an opportunity of discussing these points with people in their homes, and of obtaining concrete support through getting them to sign the card.
- (b) Remember you have won a person over much more when you actually get them to sign something in support of our aims. That person then feels he has actually pledged his support.

### 2) HOW TO ORGANISE CAMPAIGN:

- (a) It is not intended that the postcards should be given out indiscriminately and left with people. The idea is that Peace workers will obtain signatures and 3d for each card, and attend to the posting of the cards himself.
- (b) All that is required on the card is a signature. You do not need to put the person's address as well.
- (c) Arrange to do your area with a group of friends, collecting the signatures and pennies as you go.
- (d) Take postcards to your Trade Union, National Organisation, or any other meeting you attend. Meetings are a good place to obtain a large number of signatures. Always have some on you.
- (e) Ask your organisation to invite a speaker from the Peace Council to its next meeting to speak about the Postcard campaign and the points on the card. We will provide a speaker for your organisation.
- (r) Use the posteards to break new ground in the areas near where you live.

# 3) KEEP A PROORD OF POSTCARDS SIGNED:

- (a) It is important for the Transvall Peace Council to know exactly how many cards have been sent off. Keep a record of the number you send, and report to your Peace Council branch, or direct to the Transvall Peace Council.
- (b) A prime will be awarded to the Peace worker who sends out most signed presente. Nork bard and you will be rewarded two wars by spreading the work for peace, and by getting a personal record for your efforts.
