I acknowledge with thanks your letter of the 7th June, 1971 and the forms and documents therewith enclosed.

Regarding the Medical Examination, I have been informed by [r. Amolis that he has instructions from Dr. Davids to complete these only when judgment has been given in my case and, consequently, he has made an appointment for the 35th June, and states he can't fit in my family on a date earlier than that.

As I said to you over the phone one of my sons is already here, another is arriving on the 19th June, and my daughter and the other twin son will be arriving on the 25th June.

I had thought of arranging for my wife and all the children to go to Johannesburg, soon after the arrival of the two arriving on the Zéth June, 1971 for the medical examination and all other matters regarding the vise application.

It will appear then that:-

- (a) I cannot forward the completed medical forwar till after the 29th June.
- (b) The photographs of the boys I can only forward when and as they arrive here. Those of Dedanizizes Ludumo I am forwarding with his Visa application form herein emolosed.

I am grateful for the documents and congratulate you on their meticulous preparation which, undoubtedly, enabled Coungel to present such a good case.

We're both of us aware, I believe, that the Government may adopt some other measure to prevent my leaving the country. Please dont' be anxious on my behalf. I oun take it!

However, my wife is sick and tired of this country and both of us would be glad to have our children grow up in a freer country.

As my wife has been offered a post at the General Hospital at Wiscomsin I should be pleased to know if she and the obildren could leave without me towards the end of July, should our government be reluctant to be separated from me.

I have written to the Consulate, too, asking them to clarify the point whether my family's entry into and residence in the States is conditional on my leaving with them.
