Shai proposed the name of Mr. Rawlings to take up the rank of Commissionership for Beksburg-Benoni. Agreed.

GENERAL: The Hon. Secretary presented the Consus figures as at 31st December, 1942. He pointed out that several districts had failed to make a return. The Chairman said that we were now back to our strength in the days of Pathfinding and progress was due to the Trainers and Officers. Fr. Lunniss reported that the District of Orlando was hoping

to have a rally towards the end of March, 1943. The Chief Scout's Pathfinder Commissioner expressed his deep regret that he had been unable to be present at the Council Meetings owing to the pressure of work.
