OPPERMAN ATTACKS SACOS, BUT.....

The recent attack on SACOS via a full page 'advert' in a Sunday paper proves conclusively the desperation of multi-national sports organizations in this country. It also proves that unlimited funds are available to these people (it costs R12,000 for a full page advert) and the influence they have with the liberal press.

WHO IS SANOC?

The South African National Olympic Committee (SANOC) invites SACOS to a meeting of all sports organizations in the country at the Wanderers (!) between 15th and 18th November 1982. The purpose of the meeting ostensibly will be to discuss the problem of SA sports, devise ways to fight international isolation, discuss the Human Sciences Research Council (HSRC) Report on sport and finally to present recommendations to the "Minister of Sport", Mr. Gerrit Viljoen for his consideration. In the very same advert, SACOS is attacked from every possible angle and accused of not being representative of sportspersons in this country. The HSRC recommendations include the disbanding of SACOS and a formation of a new Sports Council to govern sport in this country. Recently (Star 9/11/1982), Mr. Opperman has said that they are going to "get tough" to gain international competition for their affiliates.

WHO IS SANOC?

We consider SANOC to be a multinational organization working within the framework of government policy. Their membership (basically all "White") proves this. Members belonging to SANOC belong to political parties in the "White political framework" of South Africa, thus effectively giving the lie to the cry that White sportsmen have done everything possible to intergrate S.A. sport and now it is upto the politicians. The fact of the matter is that they are one and the same! They can never be part of our ranks because they ensure our continual oppression, and they need us only to get back into international sport.

We emphatically state:

- (1) The HSRC is an organ of the government and thus we reject its very existence, let alone the findings!
- (2) We do not recognise SANOC as being in the least representative of all sportspersons in the country.
- (3) That we do not have any common ground with SANOC to warrant a meeting, and we reject venues such as the Wanderers, anyway.
- (4) That we categorically refuse to disband in obedience to HSRC demands that we cease to strive for a just and non-racial society.
- (5) That we firmly believe that until South Africa is a just, democratic and non-racial society, tours to and from this country MUST NOT take place. This is in line with our policy moratorium on ALL sport and cultural tours.
- (6) That the lie that SACOS is not representative be buried once and for all. There are 28 sports organizations affiliated to SACOS, representing some 500,000 people. Externally we are recognised by the African Football Confederation. We have a representative at the United Nations; we have an organisation in London representing us (SANOC), which enjoys wide international support; we are associate members of the Supreme Council of Sport in Africa. Furthermore, many progressive countries firmly support SACOS and its stand.

YOUTH OF TODAY – LEADERS OF TOMORROW

The youth in ghetto areas lack the basic opportunities and facilities needed to develop their potential.

Drama, poetry, art and music are things they don't even hear of out of a school situation. There are no facilities for sport and libraries are non-existent. In circumstances like these, drinking, disco dancing, smoking and fighting takes over and

Community Youth Programme (CYP) is organizing a youth festival in Eldorado Park from the 8th December to the 15th December 1982. Through this festival CYP hopes to launch permanent youth organization in culture, sports etc.

misdirect and mislead the youth. It kills their true aspirations and blind their outlook of the stark realities of the South African situation.

The youth festival will concentrate on drama, art, tennis, netball, films, roller skating, volley ball, hiking etc.

CYP invites the youth from all "ghetto" areas to participate in the festival.

Let us, the youth, prepare ourselves to be the leaders of tomorrow.

Consistency, Clarity, Commitment.

CONSISTENCY, CLARITY, COMMITMENT.

It is the aim of this article to devote some attention on those aspects of SACOS policy which may create some confusing aspects which may be misunderstood and also on those people who deliberately create confusion for their own ends.

It is now common knowledge that we are faced with a total onslaught — socially, economically and politically. In this light it becomes imperative for us that:

- a) we know what we are fighting for, and
- b) who we are fighting against

We must be able to tell our genuine friends from our genuine enemies. We must have absolute clarity on the policy we are following.

We should decide whether we want to be reformist, revisionist or revolutionary. The reformist are those who abandon their original principles and also expect others to do the same. Revisionists mostly add to their original principles, modifying and changing them to suit their own selfish interest. The revolutionary is characterized by his sincerity and consistency to bring about a meaningful change.

We thus have elements from the enfranchised group who repeatedly enter the struggle at a leadership level, rather than at grass-roots level. There are still those who hope that Black and White workers will unite and fight, and dream of solidarity between them.

In terms of labour, the White enfranchised worker is a privileged class, a class above class—he benefits the most from the exploitation of black labour, he is the only one to have the franchise, and he has the right colour. He is also compelled by law to enter into unilitary service. Only when the White workers become aware of themselves as a class and realise that the wealth created on the labour of the Black majority should be shared among all, can his role in our struggle be directly related.

Presently, the only Whites who profess to want to join the Black workers are those who are economically not : the university students, professionals and a handful of intellectuals. We should guard against such attempts to dilute the struggle, and the deliberate attempts to create confusion and division among our ranks.

To pay lip-service to the struggle is not enough. To have one set of standards for sports and different standard for other aspects of our lives is illogical and contradictory. We need to question the commitment and sincerity of individuals who act in a manner contrary to the whole concept of non-racialism. Thus we can ask the question: who are the individuals who have objected most to the SACOS resolution which says that we should refrain from usury sporting facilities on ethnic campuses? Those whose motives for making such objection were questionable.

Who are the people opposed to the recent resolution which debar Black pupils who attend White private under a racial permit from participating in non-racial sport? Precisely those whose children in fact attend such schools.

It also therefore becomes contradictory to patronise places of entertainment such as Sun City and the use of so-called open international hotels, all forms of tokenism and concession must be totally rejected.

All these are attempts to create a strong Black middle-class who then will have a stake in the system. In an attempt to protect and save the future of the capitalist system, the White power system is not incapable of enslaving blacks in another form — by offering them the lure of middle-class status. Actually, there is no difference between Black and White capitalism — capitalism is the exploitation

of one group of people by another, regardless of colour.

It is therefore important that all affiliates of TRACOS be seen to be setting an example that in no way conflicts with policy. We must become consistent in our struggle, and relate every aspect, every action to the struggle at large. Any person who is inconsistent in his line of action is causing confusion and harm to the progress of the struggle.

Non - collaboration should become a way of life and we should thus be wary of working with the tools of the oppressor. Rejection of the dummy stooge councils (SAIC, President Council, etc.) is no longer enough. One can still promote baas-kap mentality by employing labour at exploitative prices and under deplorable conditions. There is no consistency in such acts.

Naturally, there are those who will choose to differ from us — it is their right to do so. However, democracy dictates that the will of the mass must override the will of the selfish individual whose outlook is reactionary and therefore, totally unacceptable. It is no use uniting with people who do not share our ideals. Our unity lies with the unfranchised Black masses.

SWIMMING ON THE MOVE!

The provincial wing of ASASA in the Transvaal, the Southern Transvaal Amateur Swimming Association has made tremendous strides since their formation at the end of last year. The formation of STASA (and consequently ASASA) came about from a burning desire to unite 'Black' swimmers under one banner in the country. The fact that the merger is so highly successful is a tremendous body blow to the White swimming organization in the country.

STASA, apparently is hastening the National ASASA championships in Johannesburg from the 28th February to 6th March. All preparations are well ahead of schedule and everything points to a most successful swim tourney!!

HEALTHY DISCUSSION WITH HEALTH WORKERS

At an informal meeting between TRACOS and the Health Workers Association, much discussion took place and common ground for working together was laid out. Both organizations have accepted in principle that there is much common ground for a basis of working together and that future meetings are definitely on the cards.

TRACOS will be trying to reach out to other community organizations in the near future to discuss ways of working together.

AZAPO CALLS FOR ELLIS PARK BOYCOTT

The Azanian Peoples Organisation have called upon all Black People to boycott the Ellis Park Stadium, slamming the NPSL teams for using such a venue. AZAPO in a press statement released at a press conference in Johannesburg recently, states inter alia:

'When Ellis Park was built, it was meant to be the haven for international rugby, tennis and boxing — the sporting events with predominantly White support. It was built to be the showpiece of the world — adorned and equipped with the best technology can provide. Knowing the Republic of South Africa for what it is, we know why it was built, for whom it was built. All the time they did not have the Black sportsman, musician and supporter on their minds. Boxing is a dying sport here, and the dreams of producing a White S. A. world champion have been shattered at last.

The White rugby bosses had to look for a saviour, to pay off massive debts. It is believed that the interest payments alone are running into hundreds of thousands of rands.

The money the soccer fans and music patrons pay at Ellis Park is not ploughed back into the communities; and neither is it used to develop the stadiums in our communities. The opening of Ellis Park is a political ploy and an economical fraud. S. A. sport has always been permeated by politics. Blacks must realize that apartheid in their daily lives is depriving them of a chance to exploit their sporting talents and that is only in a society which is free of discrimination that they will come into their right as sportsmen. Blacks must sacrifice present concessions for future rights. They must realize that after enjoying the lush playing facilities at Ellis Park they have to return to the barren group area townships with a lack of facilities.

Well lets tell them once and for all that we don't need tours, what we want is our FREEDOM !!

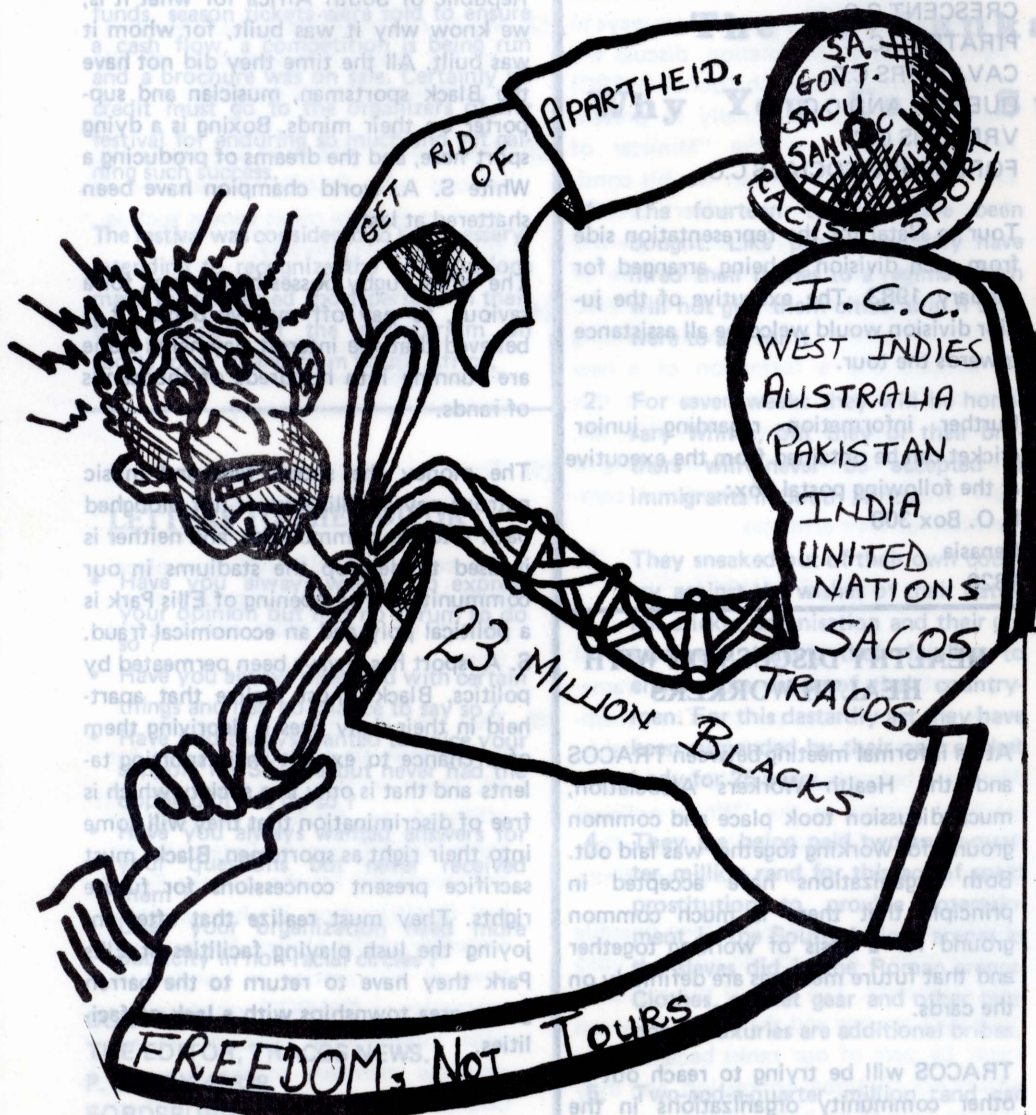
EDITORIAL
