were present in the office
because the people always come
in and out of the office
and I dont know their names.
I was handcuffed my arms
was behind my back and
my legs were also in fetters.
Somebody then put a band
around my arms and I was

checked my whole body was hurt when I received this check. I was also kicked on my groin and I was hit with fists over my body. I did not receive any open wounds as a result of this assault but had dotted ring marks around my arms where this bomb was put around my arms.

On the 82-01-13 I went to see the doctor and I report to him that I was assaulted by the rank police.

I will not be able to identify the people who come to fetch me at Nerwood and neither will I be able to identify the people who were present in the office before they covered my head with this bag before they started to assault me.

This was the only two occasions when I was assaulted that is on the 82-01-08 and 82-01-09.

I know and understand the contents of this declaration. I have no objection in taking
