General directions were given to would-be competitors in regard to how their essays might be built up and sources of information were recommended.

The essays may be written in Afrikaans or English, and must be the certified "unaided work" of the competitor. When received by Mr. Mears they become the property of the Society of the Friends of Africa with a view, if considered suitable, to their publication.

Non-European Progress Trust

This Trust was founded in 1943 by Mrs. E. P. Whitehead with a capital of £10,000. Its annual income is approximately £400.

The objects of the Trust are to help non-Europeans to help themselves. In pursuit of this objective it has mainly augmented the financial resources of non-Europeans by endeavouring to improve their educational standards. It has also assisted enterprises such as the African Maternity Home at Middledrift, crèches and nursery schools initiated by non-Europeans.

The Trustees are Advocate D. M. Buchanan, K.C. (Chairman), Mrs. E. P. Whitehead, W. G. A. Mears, H. Gwyn Ashworth, Mrs. M. Ballinger, M.P., and W. G. Ballinger (Hon. Secretary-Treasurer).

A full report of the Trust's activities will be published soon after 31st March, 1944, which will mark the end of the first full year of operation.

Conclusion

Shortage of paper and exigencies arising out of the war prevent even references to other activities of the office such as attendances at Conferences, invitations to address meetings and Congress in various parts of the country and numerous other projects ancillary to the work of the office.
