I have been asked by the Chairman of the Conference of Headmasters and Headmistresses in South Africa to convey to you' the following resolutions passed at their recent Conference in Cape Town.

- 1. "In view of the present state of violence and social disintegration in our country, and having regard to the needs of the country for extended teaching and health services, Conference respectfully requests Government to consider introducing community service for men as an option to the present national service in the S A Defence Force and, further, requests Government to introduce voluntary community service for women."

### LEAVING SOUTH AFRICA DEFENCELESS

### END CONSCRIPTION CAMPAIGN (ECC).

### Compiled by Women for South Africa.



The ECC spearheads an extremely dangerous political campaign, its purpose being to undermine, or seeking to undermine, the authority, safety and defence of the State.

Proposals for such an anti-conscription project first surfaced with the South African Council of Churches in 1974. In 1983, the ECC was formally launched at a public meeting in Cape Town addressed, among others, by the Rev Allan Boesak, a patron of the UDF, and by Mrs Sheena Duncan, former chairman of the Black Sash. In Durban, the ECC was also launched at a public meeting addressed, among others, by Advocate Zac Yacoob of the Natal Indian Congress.

Supporters of this movement include such political activists as Archbishop Desmond Tutu, Dr Beyers Naude, Archbishop Denis Hurley, Sir Richard Luyt, Dr Alex Borain and, more recently, Dr Van Zyl Slabbert.



The ECC is an integral part of the UDF -- a fact carefully concealed in the ECC propaganda campaigns. Certain branches of the ECC are officially affiliated to the UDF, and the organisation falls within the federal structure of the UDF.

The ECC is led by an executive committee, consisting of relatively young elected members. One should not be misled by this. The organisation's modus operandi clearly projects an image of thorough planning and organisation.

# Sub-committees such as the following focus on specific aspects of the organisation's activities:

- Media and culture group.
- b. Educational and development group.
- c. Contact and newsletter group.
- d. Church group.



Committee members are White, largely English-speaking, often female, predominantly of liberal, wealthy background. The ECC has about 51 member organisations in six of the UDF regions: Cape Town, Johannesburg, Durban, Pietermaritzburg, Port Elizabeth and Grahamstown. These member organisations cover church, political, human rights and women's groups: all of them well to the left of the political spectrum.

The organisation has at its disposal sufficient funds (presumably from UDF and church sources) enabling it to underwrite extensive and ongoing publicity campaings, both locally and internationally.

The organisation claims constant growth in numbers and expanding support from the broad public locally and internationally.

### PURPOSES OF THE ECC:

- 1.) To terminate the principle of National Service.
  - 2. To give the citizens of SA a choice of doing duty with the SADF or not.
- 3. To demand alternatives for National Service such as community projects.
- 4. To oppose the use of soldiers in maintaining order in Black townships.
- To portray the SADF as a "threat to freedom," and the "guardians of an unfair system."
- 6. To whiteant public support for the SADF.
- (7.) To discredit and weaken the SADF.
  - 8. To portray the SADF as the military protector of the Government.
- (9.) To discredit the school cadet system.
- 10. To discredit the Chaplaincy of the SADF.
- To provide propaganda support for the ANC/SACP Freedom Charter.
- 12. To propagandise conscientious objection among all race groups.
- 13. To create a public acceptance of pro-ANC/UDF propoganda.
- 14. To win sympathetic international support for their struggle, and thereby a matching increase in financial support.

### TARGET GROUPS.



## The ECC's main current target groups are:

- a. / Intended/future servicemen -- prime target group. The ECC seeks to persuade these particular persons to dodge the military draft.
  - i. School leavers
  - ii. Students
  - iii. Civilian force members
  - iv. National servicemen.

### b. <u>Influence Groups</u>.

These target groups comprise persons close to the primary target audience and are consequently concerned about the safety of those doing National Service.

- i. Parents and family
- ii. Wives and friends
- iii. Social group
- iv. The broad public

The objective of the ECC is for the target audiences to query National Service, to influence the primary target groups negatively and to persuade the State to change the National Service system.

- c. Influence Groups -- In Opposition to the State.
  - i. Student organisations
  - ii. Political organisations
  - iii. Religious organisations
  - iv. Human rights organisations

#### STRATEGY

## To achieve their objectives the ECC attempts to apply the following strategies.

- a. To denigrate and create suspicion of the SADF by allegations of:
  - i. Involvement in violence in the Black townships.
  - ii. "Immoral" strikes into neighbouring states.
  - iii. "Destabilisation" of neighbouring states.
  - iv. "Illegal occupation of SWA" and the claim that National Servicemen serve to enforce such alleged illegal occupation.
  - v. Being the military arm of the government, and by its actions promoting and maintaining racism and suppression.
  - vi. That it sustains and supports the conflict in SA.

## Promotion of alternatives to National Service.

- i. "Real National Service" in the form of community service. Every effort is made falsely to impress upon the target audience that the SADF's function is the maintenance of apartheid.
- ii. Promotion of pacifism.

## Assisting would-be draft dodgers to succeed legally in their objectives.

i. Legal aid.

c.

- ii. Publicising all possible ways and means to evade compulsory military service.
- d. General support of UDF policy.
  - i. "Reform cannot be successful -- the current order must be rejected."
  - ii. Criticism of security laws.
  - iii. Criticism of limitations on media coverage of violence in Black townships.
  - iv. Demands for an end to restrictions on certain political organisations.
  - v. Demands that political detainees be freed.

### PRESENT MODUS OPERANDI

In terms of the State of Emergency, the ECC has been restricted, with much of its leader element detained. A large part of its planned activity has also been restricted following police intervention.

We should not, however, conclude that this will persuade the ECC to surrender its campaign. There is already full-scale planning to publicise the message by other means. It is clear that the ECC will continue concentrating its activities at the cultural level to bring the message home to the public. Art, music, formal protest theatre and street theatre will be used more and more in the attempt to reach and influence the public. This is termed "resistance art." (Further details available from WFSA office).

### In conclusion.



- a. The ECC encourages the discrediting of South Africa's National Service system. The ECC shares the aims and objectives of the UDF and the ANC ans is therefore a very real threat to the stability of the country, and this threat must be met.
- b. The ECC follows a skilfully planned strategy. This is pursued with great professionalism. Organisation and infrastructure are both extensive and effective. Help and guidance from UDF affiliates, leftist politicians and church leaders is assured.
- c. It cannot be denied that the ECC has enjoyed certain success. On December 3, 1986, some 800 people attended an ECC meeting in Cape Town. Several secondary schools have already refused to participate in cadet activities.

As an organisation, the ECC has many weaknesses. Women and especially parents of National Servicemen should be thoroughly and objectively informed about the ECC, its activities and its true intent. They should also be informed on the importance and necessity for National Service.

### UNDERGROUND (SECRET) AGENDA.



Immediately the enemy (Marxism) goes underground, he operates on the principles of struggle and destruction. The ECC supports SWAPO and the ANC and seeks to persuade South Africa's youth to do likewise. The ECC claims these movements must be supported in order that the so-called "freedom struggle" of the ANC and SWAPO my succeed. These are the true objectives of the ECC.

## ABOVEGROUND AGENDA.

Immediately the enemy makes himself visible, he indulges in semantic double-talk and deceit, notably with words such as "peace" and "justice" Because these words have a certain Biblical connotation, the uninformed and gullible are easily misled. Christians in particular must be warned that the Marxist gives these words a very different meaning to that we ourselves apply. Years ago the communists hijacked the emotion-packed concept of "peace" to use for their own propaganda purposes. When they use the word, it actually reads: "Marxist struggle until victory." The word "fair" must also be read in this context. It was said in 1979 that "peace" would only exist when all countries were communist.

When the ECC calls for a "just peace," we must accordingly understand the context and true meaning of the call.

EXAMPLES OF ANTI-CONSCRIPTION CAMPAINGS.

#### UNITED STATES

Protest marches on campuses against the Vietnam War. Although students were exempted from military service, factors such as guilt manipulation, political animosity and sanctimonious selfrighteousness led to a rejection of conscription. It was maintained that the US had no right to be in Vietnam; that the war was unjustified and "immoral." The last years of the war were accompanied by a strident hippy sub-culture that propagated "peace" and "freedom" at any price.

### PORTUGAL

The two-year conscription that existed in the overseas provinces of Angola, Mozambique and Guinea Bissau was attacked and discredited by leftists and Marxists. Leftists lecturers both in Metropolitan Portugal and in the Portuguese overseas provinces disparaged the conscription obligations of future trainees. Graduates automatically gained officer status. The result was that junior officers entered the defence forces opposed to conscription. The eventual revolution in Portugal -- "the revolution of the captains" -- was led by junior officers.

### AUSTRALIA

During the Vietnam War a strong anti-military service campaign deterred the authorities from further involvement in the war. The "antis" went as far as to telephone abuse to families of those whose sons had been wounded or killed.

### WEST GERMANY

In the early Seventies a "peace movement" against military service linked with the hippy movement. This led to widespread subversion in the West German army and the authorities were shocked at the massive deterioration in morals and army discipline. Then came the discovery of the linkage between the so-called "peace movement" and the notorious Baader-Meinhof Gang. Since then any anti-conscription campaigns are viewed as unpatriotic and communist-inspired, and dealt with as such.

## ONSLAUGHT ON THE WHITE CONSCIENCE

The introduction of the so-called "Peace Kit," widely circulated by the ECC, says: "We can appeal to the young White soldiers, their wives, loved ones and families. They cannot win the fight, it is a waste to try, and the task is an unfair one." The school cadet system is also attacked.

## Techniques of Marxist psychological warfare

These are familiar Marxist techniques:

- a. Create the impression victory has already been gained.
- b. Make as much noise as possible, even if your numbers are small.
- c. Spread fear by intimidation -- this often paralyses people's will.
- d. Spread the lie long enough so that people eventually begin believing it.
- e. Flee from strength -- but attack the weak mercilessly.
- f. Undermine your enemy by morally destroying him, undermining his moral values and encouraging profligacy.
- g. Destroy his morale and self-confidence by constant, conditioning and denigration, accusations and appeals to his conscience, until he is confused, believes he is in the wrong and becomes too weak to resist.

This last is exactly what the enemy wants. By weakening our resolve and so our resistance it becomes that much easier for Marxists to win control of South Africa.

### THE ANSWER TO THE ECC

- Know your enemy. If we know their methods and their strategies we can
  offset and defeat them.
- 2. Remain confident in the justice of our defensive war. Christians are against war but if war is forced upon us then we must fight for the defence of our families and our country, and the protection of our beliefs and our civilisation.
