4. The Council, while striving to obtain sufficient grounds and facilities will fight any attempts by anyone to use grounds and/or facilities as a form of blackmail to force non-racial sports to affiliate to racially orientated National or Provincial bodies.

5. The Council aims to co-ordinate the efforts of various sports codes and to organise such services as may be needed an a consultative, inter-sport sode basis.

TRANSVAAL COUNCIL OF SPORT. MINUTES OF THE FIRST ANNUAL GENERAL MEETING HELD AT THE A.E.L. CENTRE, 8th. FLOOR, ON SUNDAY 21 MAY 1979. 1. Transvaal Cricket Board: Drs. R.Gopal and A.Asvat, Mr. A.Mangera. 2. Horse racing: Mr. M. Theba. 3. S. Transvaal Hockey Union' Mes. J. Julius and S. Julius. 4. S. Transvaal Tennis Union: Mr. M. Davy.
5. Transvaal Table Tennis : Messrs R. Luckay and C. Coovadia.
6. Transvaal Tennis Board : Mr. M. H. Docrat. Also present: Messrs A. Mather, B. Vally, Y. Kara, E.G. Bennett, A. Bham. MINUTES:-The Minutes of the Inaugural Meeting were read and adopted, proposed Mr. C. Coovadia, seconded Mr. R.F. Luckay. THE CHAIRMAN'S ADDRESS:-The Chairman pointed out in his address that the focus for the hon-racial struggle in sport had moved from overseas to South Africa where it belonged. He appealed to those who were active in sport to support people who were clear in their objectives. REPORT FROM SECRETARIAT:-The history of the formation of the Council was outlined in the report. The report went on to mention that the Transvaal Council had obtained membership of the South African Council of Sport together with the Western Province Council, the Natal Council and the Council in the Eastern Province. The following newsleters and pamphlets were prepared and distributed: 1. On Facilities and Coaching. 2. Formation of the Transvaal Cricket Board. 3. Normal cricket as played by the Varachia group, written by Br. Asvat. 4. Playing sport under permit. 5. How normal sport should be played(in conjunction with the W.P. 6. Multinational Sport (W.P. Council) 7. "Are you Practising Double Standards?" Issued by joint Councils of Sport. 8. "What is Happening in the Soccer Federation?" 9. "You are Permitted to Exist" on the permit system. The Report was accepted for discussion, Proposed Dr.A.Asvat, Seconded E. Bennett. DISCUSSION:_ 1. On discrimination in horse racing the meeting was informed that Mr. Theba had written to the Jockey Club and other bodies running racing. The Council had also approached sponsors of horse racing and had had replies that the sponsors were not in favour of discrimination. Mr. Theba had taken his fight up to the Provincial Council. 2. Tennis: Mr. M. Davy pointed out that provincial tennis units had . been informed at the annual meeting of the SALTU that it was not necessary for them to affiliate to provincial councils of sport as SALTU was affiliated to the South African Council. The Chairman pointed out that there was no clash of interests if provincial bodies affiliated to the provincial councils. The provincial councils were there to work at grass-roots level. This was work that could not be done by a national body. CORRESPONDENCE:-1. Letters of good wishes were received from the E. Province, W.P. 2. South African Council, Senior Schools and the Hockey Union.
A letter of apology was received from Mr.I. Gattoo. 3.A letter was received from Mr. E.Bennett accepting his election on to the Secretariat.

FINANCE:-

Table Tennis paid R50 in affiliation fees.

Women's Hockey promised to post their cheque.

Mr. Theba was medited with having donated a sum of R200 made up of his own contribution plus donations by his friends.

The Chairman thanked all those who had contributed to the Council on a regular basis. Certain individual sportsmen had been approached to make donations on a monthly basis and they had done so.

Mr. Bennett's election onto the Secretariat was confirmed. Mr.A. Gandabhai would also be Treasurer.

GENERAL BUSINESS:-

Mr. Y. Kara enquired whether TRACOS contemplated any plan of action in regard to the soccer matter.

The Chairman replied that SACOS had taken certain action on a national level and that TRACOS, as a provincial unit, would not take any action to over ride that taken by SACOS.

IN CONCLUSION, the Chairman thanked all delegates who had made an effort to be present at the meeting. He appealed for co-operation from all sportsmen in our struggle.

The Secretariat.

THE CHAIRMAN'S ADDRESS:-

It is almost exactly a year since this Council held its first Annual General Meeting. What has happened since then on the sports front? Have those who espouse the non-racial ideal in sport made any progress or have the forces that promote multi-nationalism, and therefore racialism, managed to get support for their ethnic policies?

The continued, and indeed intensified, isolation of South African sport is clear evidence that the world has not been fooled by the multi-national policy. The humiliating expulsion of the Transvaal rugby team from France was a significant occurrence in that it has shown racially orientated South African sportsmen unmistakeably that that granite bastion of racial sport in this country is not as "safe" as it was thought to be. Now that the national sport of those who believe in multi-nationalism, plural societies, ethnicity, or eiesoortige ontwikkeling has been touched there is consternation and every one concerned is "having a new look" at the best means to promote what the world and every decent South African hate sport and that is apartheid. The inevitable cancellation of the forthcoming rugby tour of France will be an event of the greatest significance in the history of South African sport.

Those who look forward to it for any signs of enlightenment in the South African sports policy and its implentation must be naive indeed. What it will show is that the racial sports bodies have not by a long chalk reached the end of their inventiveness when it comes to postponing the day of true non-racial sport in a truly non-racial South African society. We have seen the granting of concessions in the shape of international status permits, we have experienced offers of monetary bribes and there have been offers of a chance to compete internationally (rugby) and promises of improved facilities, all designed to lure the non-racial sportsman to the multi-national side. White South Africa refuses adamantly to change these laws which militate against the playing of non-racial sport. We refer to laws such as the Group Areas Act, the Liquor Act, the Separate Amen ties Act, etc. Unly one conclusion can be drawn from this and it is that the pressures which have been exerted on the racial sports bodies must not be allowed to flag. Experience has shown that concessions have only been made as a result of pressure and the time to intensify those pressures is now. Non-racial sportsmen must refuse to collaborate with those who preach multi-nationalism. They can only succeed if we "play ball". Without our co-operation it is not possible to give their policies life. Those who have not yet made their minds up as to where they want to be must be ruthlessly excised from the body of non-racial sport. The double standards resolution must be implemented, not in any vindictive spirit, but as a means of educating those who have been duped by the multi-nationalists. It is a clear right of every sportsman to decide where he wants to play BUT IT IS ALSO THE RIGHT OF THE NON=RAGMAL SPORTSMAN TO DECIDE WHO HE SHALL ALLOW TO PLAY WITH HIM. IT IS HIS RIGHT TO EXCLUDE THOSE WHO WANT TO GRAZE ON BOTH SIDES OF THE FENCE. THEY ARE OPPORTUNISTS AND THEIR PRESENCE IN OUR RANKS MILITATES AGAINST OUR STRUGGLE TO PLAY NON-RACIAL SPORT IN A HON-DISCRIMINATORY, DEMOCRATIC SOCIETY.

Non-racial sportsmen have just been alerted to another strategy being practised by those who wish to escape the heavy bombardment of national and inter-national sport against the fraud that is the multi-national sports policy. We are indebted to the Secretary of the South African Hockey Board who warns as follows:

"Numerous agents and "front" organisations are very busy in trying to deceive clubs and unions throughout the country in an organised manner. Some are canvassing for the names and addresses of club and union chairpersons and secretaries. Others are studying the weaknesses, problems and needs of sports organisations so that these issues can be readily exploited for ulterior purposes. Others are organising apparently harmless fun runs, cycle for fitness, outdoor adventure and other schemes under the Department of Sport with great newspaper and T.V. publicity." He starts off, in this connection, by mentioning the role of the Department of Sport in this campaign. He says:

"The Department of Sport has as its main function the protection of the dominant and privileged position of the rich, "white" enfranchised sportsmen at the expense of the rightless, poverty-stricken blacks. Money, material aid and the use of "white" facilities are being made available to lure and trap unsuspecting sports administrators. Once the bait is taken, then that sports organisation is under direct obligation to and in the clutches of these racist schemers!

He ends by advising sportsmen to be on their guard and states:
"Don't furnish strangers or suspicious people with names and addresses of officials. Don't be tricked by spurious offers that have other ulterior motives. Always refer important decisions to your club, union or preferably, the national body. This will forestall hasty or foolish decisions that will later be regretted."

This statement from Mr. Frank van der Horst, Secretary of the South African Hockey Board, is given great prominence in this address and has, iffact, been included after amendment of the address because we consider the sentiments expressed in the newsletter as of the utmost importance in demonstrating that the racial sports bodies have not given up hope of convincing South Africa and the world that they are entitled as a superior and separate group to the cream of everything in the country and that they are now at their most dangerous as they see the end of their world of privilege.

It is not amiss at this stage to remind non-racial sportsmen once again of the principles of non-racialism in sport:

- 1. All clubs should be unreservedly open. Members should ALL enjoy the same training, coaching and playing facilities. Spectator and social functions and facilities should be open. All clubs must have non-racial constitutions. There must be punitive clauses in the constitution to combat all signs of racialism in clubs.
- 2. Non-racialism must start at grass-roots level with the youngest sportsmen enjoying ALL facilities.
- 3. There must be only one non-racial national body for each code of sport. This national body must have full control of that particular code and administer sport irrespective of the ethnic or "racial" origin of members. This national body must represent South Africa (all of South Africa) at inter-national forums. There must be only one national team. All overseas teams will compete against non-racial sides at national, provincial and club level. There will obviously be no place for umbrella bodies.

Finally, we should remember at all times that what we are asking are rights and not privileges and that any concessions, overt or otherwise, should be shunned. Collaborators have not yet won a struggle, they merely strengthen and sustain the system they are supposed to be fighting.

REPORT FROM THE SECRETARIAT:-

Mr Chairman, Ladies and Gentlemen

We wish to present our report on the activities of the Council over the period: 21st. May 1978 to 30th. May 1979:

ADMINISTRATION: The affairs of the Council were administered by the officials mentioned elsewhere in this report. Mr. Ahmed Mather was co-opted onto the Council when it became evident that he was very keen to serve the Council. Mr. Edwin Bennett, unfortunately, could not serve the Council as well as he would have wished as he started a new course of study while holding down a permanent job.

Frequent committee meetings were held and the officials came together in the Council's office on Wednesday nights and on Saturdays, very often

for the wholle day.

SYMPOSIUM: -

A symposium was held on the 3rd. December 1978. The venue was a hall in Lenasia. Guest speakers were: Mr. Frank van der Horst, Vice

President of the South African Council of Sport, Mr. Paul David,

Natal Council of Sport and Mr. Morgan Naidoo, South African

Amateur Swimming Federation. Two hundred and fifty people attended the symposium.

SOUTH AFRICAN COUNCIL OF SPORT:-

The Transvaal Council of Sport hosted a most successful meeting of SACOS on the 14th. and 15th. October 1978. The meeting was held at the A.E.L. Centre in Fordsburg.

This Council maintains its very valuable membership of SACOS. It gives us much pleasure to report that Councils of Sport now exist in the following areas: Western Province, Natal, Eastern Province, Kimberley and Transvaal. Councils are being formed in the Border and Southern Cape regions.

The following members of the Council attended the meeting of SACOS held in Durban on the 10th. and 11th. of March 1979: R.Feldman, I.Gattoo, A.Adhov, A.Mather.

The following codes attended the meeting:
Athletics, Cricket, Darts, Mens Hockey, Womens Hockey, Swimming,
Rugby, Senior Schools, Table Tennis, Lawn Tennis, Weightlifting,
Golf, Eastern Province Council of Sport, Transvaal Council, Natal
Council, Western Province Council.

- a. discussion on lack of facilities, especially for athletics,
- b. cycling reported that there were no cycling tracks and that cycling was therefore taking place on public roads,
- c. cricket reported on the visit of the I.C.C. delegation who came to the country on the invitation of Mr. Varachia's cricket union. They met Cricket Board officials during the course of the B Section final of the Board which was played in Port Elizabeth.
- d. rugby promised to hold a benefit match for SACOS,
- e. the meeting decided that units must not make use of facilities at the ethnic universities. The Senior Schools Association was severely criticised for making use of the King's Park athletic track where a permit is required. It was also pointed out that Natal high schools made use of facilities at Westville.
- f. swimming reported that difficulties were being encountered in Durban where pools have been restricted to either so-called coloureds or indians. A fact finding mission from the international body was expected at the end of May., or March 1980. Swimming proposed that SACOS appoint a secretariat to assist Mr. M.N.Pather. They asked for the position of full-time, paid Secretary to be looked into.

PROGRESS REPORT ON TRANSVAAL SPORT: -

1. SCHOOL SPORT:-

The Transvaal High Schools' Sports Association, an affiliate of the Council now has twenty five member schools. A significant addition to their membership has been the acceptance of four schools which previously played their sport in black ethnic bodies.

- 2. ATHLETICS: An athletic union was formed last year. Three clubs were affiliated. Only three meets were held. Efforts are being made to interest schools. Discussions have been held with three potential clubs.
- 3. BOWLS:-The Westlea Bowling Club, after being repeatedly snubbed and embarrassed by "white" bowling clubs decided to withdraw from competition while retaining their affiliation of the "white" union. The women's section has now gone back to competing in "white" competitions.
- 4. BOXING: A strong body has been formed after a break-away from the multi-national body. The Council is working with the body in the

hope of getting them to affiliate.

- 5. CYCLING: A member of the Council, Mr. E. Bennett, organised meetings to form an organised body. There is no track and racing was going to take place on roads. Unfortunately interest waned when Mr. Bennett no longer found it possible to devote time to the venture.
- 6. CRICKET:- The Transvaal Cricket Board has a mambership of 18 clubs. The Board successfully hosted the S.A.Board's northern zone B section tournament in which the Senior Schools took part for the first time. Eight primary schools and six high schools took part in games under the patronage of the Board. The Transvaal Cricket Council (Varachia) recently attempted to "hi-jack" one of the Board's playing fields. The Board was steadfast and the attempt was aborted.
- 7. DARTS:- The Transvaal Darts Board, an affiliate of this Council, has a new member, the Western Transvaal Dart Association, with headquarters in Lenasia. The Board now has three affiliates viz Southern Transvaal, Eastern Transvaal and Western Transvaal.
- 8. GYMNASTICS: This code of sport was introduced at high school level during January this year when Western Province, an affiliate of the South African Senior Schools gave demonstrations over two days in Johannesburg. Senior Schools will introduce this code soon.
- 9. HOCKEY: Two unions exist to cater for women's hockey viz Southern Transvaal and Western Transvaal. There is no men's hockey. Senior Schools has taken a decision to introduce hockey for boys soon.
- 10. SWIMMING:- The Transvaal Amateur Swimming Union continues to be active. There are only two clubs but efforts are being made to form a club in Lenasia and one in Laudium. Progress is being stifled as a result of a lack of coaches. Members of TRACOS will organise the club in Lenasia. Transvaal participated in the recent SASWIF championships which were held in Paark and Worcester.
- 11. TABLE TENNIS: The association is a member of the Council. They continue to make progress. The South African Table Tennis Board has arranged for a coach from the U.K. to visit this country. He is due in Johannesburg in Agust/September and this Council is prepared to offer its services to the table tennis association if necessary to help them organise for the coach's visit. Meetings have been held between the high schools and the association in order to derive maximum benefit from the visit of the coach.

- 12. TENNIS:- The Southern Transvaal Lawn Tennis Union was granted observer status with the Council. But not one of the tennis bodies is affiliated to the Council. Tennis is in the process of being re-organised now that the SALTU and SANLTU have agreed to merge. It is hoped that the "new" bodies which will emerge will affiliate to the Council.
- 13. RUGBY: The Transvaal Independent Rugby Union, an affiliate of the SARU: is not a member of the Council.
- 14. VOLLEYBALL: A volleyball association was formed with the assistance of this Council. Unfortunately a lack of venues and waning enthusiasm led to the association becoming dormant. Now that Senior Schools has introduced volleyball as a code it is hoped that interest in the Transvaal will be revived.
- 15. SQUASH: This sport is being played at "white" clubs and at certain institutions. A lack of courts has meant that this province has not been able to form non-racial clubs. From reports it seems that second class citizens are allowed to play on certain courts if they are prepared to sign Mmembership" forms. This information is presumably then used to convince people of the non-racial(sic) nature of the squash clubs.
- 16. JUDO AND KARATE: The body controlling these sports was affiliated to the Council but they have, unfortunately, succumbed to multi-nationalism on the pretext that they need qualified people to grade their fighters.
- 17. HORSE RACING: The Council, under urging from its associate member, Mr. M. Theba, undertook an investigation into horse racing especially with regard to facilities and sponsorship. Various firms were written to and they responded by stating that they did not endorse or support racial discrimination. The racing clubs replied that they had petitioned the provincial council with regard to discrimination on race courses in the Transvaal. The Council was supplied with written evidence of the petitions.

In reply Simba-Quix replied:
"We wish to advise that we will be unable to sponsor you, but we are prepared to assist you in this connection by donating two(2) cases of 12 cents chips."

You will recall that the same organization "Saved" the S.A. Grand Prix when it sponsored that sport to the tune of R110,000.

"This, sports administrators felt was an insult and a boycott of Simba Products by schoolchildren started throughout the country."

To the ordinary scholar sport may seem to be just another part of school life. In the South African context this scannot be so as the ruling class has made sport part of the system of discrimination. But we have a duty towards ourselves and we should refuse to play or watch sport which is run under present conditions. To maintain our dignity and our self respect we must play and watch sport without permits & concessions as these are part of the apartheid system.

In the fight for true non-racial sport, SACOS has been in the forefront. Those who oppose SACOS show that they are completely out of touch with the people and the demands of the struggle. The "normal" sport protagonists are in fact working hand in hand with the government. They are trying to fool people into believing that the ultimate goals in our struggle has been achieved.

How can "normal sport be played in a society where crude injustices exist? How can conditions be normal when:

, you live in a group area set apart from the "chosen people"?

* your parents are prevented from doing certain jobs because of job reservations or they have to do equal work for less money?

* people are ejected from their homes purely on the grounds of colour and are forced to live on pavements?

you attend a separate, ethnic school with inferior buildings, equipment & facilities?

* you are prevented from developing fully as a sportsman from a young age because you do not have the facilities, and you are prevented from having regular competition with your fellow sportsman because they are of a different colour?

TRACOS appeals to you as the future sports stars and leaders to uphold your dignity and self respect and to contribute to the struggle NOW by upholding the principles of non-racialism. We can only have a better South Africa if we reject multi national sport — South Africa is ONE country consisting of ONE nation: The South African Nation! Your fellow students have shown in the recent past that they are prepared to die for their principles.
