Minutes of Executive Meeting held in the Railway Commission Board Room on Monday, 13th March, 1944 at 5.10 p.m.

PRESENT:

Mr. W.A. Carnegie (Chairman), Miss P. Gordon, Mrs. Campbell Ellis, Mrs. H. Doudney, Rev. R.H. Clarke, Dr. J.H.G. Robertson, Councillor J.H. Bailey, Messrs. H.E. Davies, R. Howman, R.D. Clegg, W.L. Makubalo, O. Somkence, S.H. Madeya and G.R. Agar (Hon. Secretary.)

APOLOGIES:

Apologies for non-attendance were received from Dr. E.H.B. West, Rev. P. Ibbotson, Messrs. H.R. Barbour, H.G. Payne, F.V. Johnstone, J.M. Greenfield A. Sanders and J. Stewart.

MINUTES:

Minutes of the meeting held on the 14th February were taken as read and confirmed.

The Chairman then presented Adv. H.E. Davies, the retiring honorary secretary, with a gold plated fountain pen on behalf of the members of the executive as an appreciation of his services to the Society. Mr. Davies in replying, stated he would continue to have the greatest interest in the work of the Society.

BUSINESS ARISING FROM MINUTES:

(a) Location Advisory Board: As no member of the Native Section had been elected, the Secretary was instructed to enquire from the Town Clerk as to whether one of the nominated members could be chosen from the Native Section of the Society.

(b) Eating House Bulawayo Location: A letter to the Council of the 8th March, 1944 by the Sub-Committee appointed, was read. It was decided that if necessary a Special Meeting of the Executive should be called to deal with any decision arrived at by the City Council at its meeting on the 14th March.

(c) Native Thom: A full report had been submitted by the Native Commissioner, Bulawayo to the Secretary for Native Affairs, further it was proposed to hold a function in the Stanley Hall during April and make a presentation of a chair.

(d) Hillside and Luveve Activities: Mr. Greenfield had promised to bring the matter before the Hillside Town Management Board on the 14th March. Councillor Bailey stressed the importance of making some provision in the Bye-Laws before incorporation took place. With regard to Luveve the matter was held over until Messrs. Elliott and Huxtable were able to be present.

This matter was referred to the Special Sub-Committee appointed on the 13th December, 1943.
