

SAVAGE SENTENCES IN JO'BURG COURT

JOHANNESBURG.

YOUNG AFRICANS AR-RESTED UNDER THE PASS LAWS ARE BEING SENTENCED TO LASHES IN THE NATIVE COMMISSIONER'S COURT HERE.

THIS IS THE LATEST SCAN-DAL OF THE PASS LAWS-WHICH THE GOVERNMENT IS SUPPOSED TO BE TRYING TO RELAX.

According to official sources the police have had instructions to 'go easy' with pass offenders. But teenagers are being sentenced to lashes for first offences—and such minor offences as being found without reference books.

NO CHANCE TO APPEAL

The youngsters come up in court in the morning and the lashes are administered in the afternoons. They have no chance to appeal against the sentences, should they want to. In most cases their parents do not know what has happened to their sons, and the police take no steps to notify them. There is no option of a fine for these youngsters.

On Tuesday 9th February, 13 Africans arrested under the pass laws were caned.

On Thursday 11th, New Age

found four more youngsters who'd been caned, and spoke to them as they came out of the punishment room.

If you wait outside the Native Commissioner's Court in Fordsburg any week afternoon between 3.30 and 4, you will be able to hear the swish of the cane, and the screams of the youngsters being beaten.

FORT HARE — CITADEL OF INDOCTRINATION

At the beginning of 1960, 30 students were refused readmission to the University College of Fort Hare. The Minister of Bantu Education said, when questioned by Mrs. Ballinger in Parliament, 'the readmission of these . . . students was not considered by me to be in the best interests of the College because of their activities in 1959.' When we asked the new Government-appointed Principal for reasons, he also said that they were excluding all those they feel will not co-operate in the implementation of the new Govt. policy. He said we had no right to demonstrate against the piece of legislation which turned Fort Hare into a Govt. institution. Our reply was that all the professors (including the Principal), lecturers, staffmembers and students took part in the demonstrations. He said it was just unfortunate that only a few were victimised.

To us it was evident that they were acting on information they get from sly spies and informers who are planted all over the College to spy on others. The injustice lies in that no trouble is taken to prove the accuracy of the information. The authorities 'smell out' the undesirable ele-

Mr. Phoofolo Explains His Expulsion From B.C.P.

This is a reply to the statement which appeared in the front page of New Age on January 12. 1961, headed: "BCP Deputy Leader Quits. Moves to form new party in Basutoland."

The secretary of the Basutoland Congress Party keeps on saying that Mr. Phoofolo went in for subversive activities but does not explain what those activities were. It is an undeniable truth that I disagreed with a party leader, but I never violated the constitution and politically I saw no cause for my expulsion, which in my opinion is unconstitutional. Appa-

rently if one canvasses for a candidate against his leader whom he is not satisfied with, he is called subversive and expelled.

The leader of the BCP promised to publish my subversive letter that caused my expulsion, but unfortunately or wisely he has not done so. Why? I hereby challenge him to prove to the world my subversive activities by printing my letter in the press.

The secretary says I tried to create a split in the Transvaal ANC, but he cannot quote one instance where I tried to do so, not even in the branch to which I belonged.

In any case, it does not seem that the BCP wants friendly relations with the ANC. If it did, why did these two organisations not work together in the Transvaal? Why did BCP pass a resolution that no member of BCP must belong to another organisation? What has happened to all the people from South Africa who were members of the ANC-Ellen Molapo, Nimrod Sejake, Mohlabi Mohapi, John Motloheloa, O. P. Phoofolo and 12 others? Is Mr. P. K. Leballo still a member of BCP? Were all subversive?

The BCP leadership is completely opposed to anyone who is rumoured to have been a member of the ANC in the Union, and many of them have been expelled. There are more politicians outside the BCP than inside, and the leadership is to blame.

I have never opposed BCP and its policy is perfect and shall always get my support, but the leadership is good bye. I promised the executive committee of BCP that to prove my loyalty to the party I will never join any political party at present existing in this country; but I shall not refuse a call if the people still demand my services in the BCP or any party which may have a policy similar to that of BCP.

MURDER IN THE CONGO

LAST year it was Felix Moumie, of the Kamerun, poisoned by the French terrorist organisation the Red Hand. This year it is Patrice Lumumba, done to death by the Kasavubu-Mobutu-Tshombe gang who serve Western interests in the Congo. In Algeria hundreds of thousands of people with black skins have been mown down by French bullets. Last year at Sharpeville and Langa, last week in Angola—everywhere in those parts of Africa which are not yet free the imperialists and white supremacists who pretend to be defending Western civilisation and saving Africa from Communism are engaged in their bloody trade of shooting down the true freedom fighters of the African people.

Africa is a glittering prize. For centuries the imperialists have looted its wealth and exploited its peoples without let or hindrance. The nations of the West have grown fat on their booty, while the colonial peoples have suffered and starved. After 500 years of White civilisation the African people of Angola remain the most poverty-stricken and illiterate on the Continent. In the Congo the number of professionally-trained Africans produced under the Belgian regime could be counted on the fingers of one hand. But the White man boss in Africa and overseas lived well on the proceeds of cheap African labour.

The West wants Africa backward and in chains. And now that Africa is beginning to stand on its own feet, the West

struggles desperately to hang on to its ill-gotten gains.

MURDER MOST FOUL

The murder of Patrice Lumumba is one of the foulest single acts perpetrated by the imperialists in their sordid history of plunder and oppression. Here was a man legally come to power as Prime Minister of the Congo according to the rules which the Belgians themselves had drawn up. He was the freely elected head of a freely elected Parliament. But because he dared to stand up for the rights of his people, and because he tried to make freedom in the Congo a reality and not a farce, the Belgians, their UNO allies and their African stooges Kasavubu, Mobutu and Tshombe joined hands to destroy him.

The elections were wiped out and Parliament was dismissed. Lumumba was arrested on charges which were never specified because his captors never dared bring him to trial. When it became obvious that the mass of the Congolese people stood by their deposed leader, he was handed over to the butcher Tshombe

and done to death.

Thus do the imperialists "defend Africa from Communism"
—using the same methods that Hitler used to "save Europe from Bolshevism." But there was a reckoning with Hitler, and there will be a reckoning with the imperialist butchers and their stooges in Africa.

The African people demand that the killers of Lumumba be brought to justice. The Kasavubu-Mobutu-Tshombe gang, who have all seized power illegally and by force, must be destroyed.

The Belgians must be driven from Congo soil.

Nor can the United Nations escape the blame. They were ordered to the Congo to restore the authority of Lumumba's Government against the encroachments of the Belgian counter-revolutionaries. But it is with UN permission that Belgians have been pouring back into the Congo to resume their reign of plunder. UN officers stood idly by while Lumumba was brutally assaulted at Elizabethville airport and later done to death in Tshombe's dungeons.

Now it is enough. The UN, dominated by the Western powers and especially by the United States, must be reformed to express the will of the world's peoples; and Hammarskjoeld, the bankers' stooge, must go. After his disgraceful performances in the Congo and in South Africa, he can never again enjoy the

confidence of the African people.

A BLOW AGAINST AFRICA

The murder of Lumumba is a blow struck against the dignity and self-respect of the peoples of all Africa. The independent African states must take the initiative in ensuring that the criminals responsible for this dastardly deed receive their just deserts. If Goering, Goebbels and Co. could be sentenced to death for war crimes at the end of the Nuremberg trial, then the imperialist gangsters and their stooges should hang for their part in the killing of Lumumba and the crimes which are still being perpetrated in their name in the Congo.

The peoples of Africa will not rest until this stain on their freedom has been wiped out. The continent-wide struggle against the imperialists and their stooges in Africa must be raised to new heights so that never again will the counter-revolutionaries be able to raise their hand against the people's leaders, and freedom,

once won, will be secure for all time.

DORSED THE REGIME THAT MURDERED HIM.



NO WORK EVEN FOR SCABS

ONLY 12 of the 115 scabs who were engaged by the Bay Passenger Transport Company still remain formally employed by the Company. The rest have been laid off.

On Saturday last week, a few hours before the Company took away its fleet of buses from the New Brighton depot to the depot in town, the scabs were called together and told to surrender everything belong-ing to the Company. They were then instructed to report at the depot at 9.30 the following morning (Sunday), when they found all the buses gone. From there they were conveyed to the Tramway offices in town in two buses driven by Coloured drivers who were given strong police pro-

At this meeting the manager commended the scabs for their bravery because they had turned out to help the company at the risk of their lives. Some of these workers had were earning up to £5 per week. promised to pay £7 a week.

SCABS LOSE JOBS The manager regretted, however,

that the directors were unable to continue paying them while the Company was not making any money. He then announced the Company's decision that those of them who were already trained would receive £1.10.0 per week, and the untrained £1 per week. These amounts would be paid only for as long as funds were available.

The Company would only keep 12 of them, four of whom were scabs drawn from the old staff. The rest were told that they could go and look for work elsewhere. Those who its workers.

continue to receive the dole of £1 per week while the Company still had the funds. They were sent away with a promise that when conditions became normal again they would have first preference. Further they were asked to go and persuade the people of New Brighton and Zakele to go back to the buses. Before the meeting ended the

scabs were given a list of phone numbers to ring in the event of anything untoward happening to them and their homes. They were given numbers for the fire brigade, the police at New Brighton, Zakele and Korsten, and the Chief and Assistant Chief Inspector.

Some of the scabs, who are now living in the township without jobs, are feeling very bitter. New Age learns that some of them re-applied at their old firms but were turned away as their position; had already been filled.

Dept. Of Indian Affairs Rejected

THE Government's announcement of the proposed creation of a Department of Indian Affairs has been categorically rejected by spokesmen of the Indian Congress in Natal and the Transvaal.

"The people will not accept this fraud," Dr. G. M. Naicker, President of the South African Indian Congress, told New Age.

'We have seen the workings of the Coloured Advisory Department and the Bantu Territorial Authorities and we have witnessed the chaos, insecurity and outright despotism for which these departments are responsible," he said.

PROUD RECORD

Warning the Indian people to be vigilant and calling for the total rejection of the proposed Board, Dr. Naicker said: "The Indian people have a proud record in so far as such Boards are concerned.

"When the Smuts Government wanted to establish an Indian Board to work the Asiatic Land Tenure Act (the predecessor of the Group Areas Act) they could not find a single Indian to accept the positions offered, even though members were offered salaries of £2,000 a year.

"Our demand is quite simple. We

ask for nothing less than universal adult suffrage on the same basis as that enjoyed by the White population.'

The Transvaal Indian Congress has similarly rejected the proposed Indian Affairs Department and warns strongly that the only way out for the Indian people is by the extension of democratic rights to all the peoples of South Africa, regardless of race.

CONDITIONAL ACCEPTANCE


Asked by New Age whom he would represent in the interview, Mr. Joosub said "leading commercial men of the Transvaal and

He would not say what proposals he would make to the Minister, but said the interview was to find out about the Government's plan. "We want to know how the Department will work out."

Mr. Joosub said he welcomed the establishment of an Asiatic Affairs Department if it would bring relief to the Indian people, but not if it did anything to strangulate them. His public statement in support of the Department was therefore one of conditional support.

(Continued from page 1) All the youngsters caned were arrested for failing to produce a reference book, under section 15 (1a)2 of Act 67 of 1952, that is, the Abolition of Passes Act.

ATTACKED BY TSOTSIS

Young Spewe Gadebe (wrongly written as Gatela in the court records) was employed by New Age as a street seller on Friday afternoon, three days before his arrest. While he was selling papers in the Western Areas he was waylaid by tsotsis and his reference book and money were taken from him. On his way home he was stopped by the police and asked to produce his reference book. When he could not do so he was arrested and lodged in the Langlaagte police cells.

When he appeared in court on Tuesday morning, Spewe says he told the magistrate he was employed and asked that a policeman accompany him to the office of his employer to prove this. The request was refused. With him in court were 12 other teenagers, none of them older than 20. All were sentenced to cuts.

EMPLOYERS GO FREE

The two young Swazis given cuts on Thursday afternoon had been brought to the Reef from their home in Piet Retief but their employer, who has a compound near Lenz, did not register them or have reference books taken out for them. When the police raided the compound the African workers were arrested, among them these two youngsters (one aged 18, and the other 20). The youths take the punishment while their employer gets off scot free!

One of the youngsters caned on Friday afternoon was 19-year-old Wellington Jaji whose mother traced him at the Native Commissioner's Court. When she saw the policeman go into the punishment room with the cane in his hand 'I couldn't stand it,' she said, and she walked away from the court.
