# CONSTITUTION.

YOUTH ACTION COMMITTEE.

L. NAME.

The name of the condities shall be the Youth Action Committee.

2. OBJECTS.

The objects of the committee within the framework of the policy of the Congress Novement.

- a. To provide the basis for permanent co-operation between the youth organisations mentioned in section a. of the Numbership clause.
- b. To initiate, with the agreement of member organisations, practical youth mar activites such as festivals, conferences and other activitie designed to build up the youth movements.
- c. To maintain contact and co-operation with the W.F.D.Y. on behalf of the affiliated organisations and the youth of South Africa.
- d. To encourage the co-operation of youth organisatic on the Provincial, regional and local levels.
- 3. MERBERSHIP.
  - a. The Youth Action Committee shall be composed of representatives from the following organisations:-

African National Congress Youth League. South African Indian Youth Congress. South African Congress of Democrats (Youth Section).

b. For the purpose of relations with the WFDY only representatives from organisations affiliated to WFDY and not members of the Committee shall be invited to sit on the committee as full voting 9 members.

c. The Constitute shall have the power to invite other organisations to send observers to its meetings whenever the constitute regards this as desirable. Unanimously grees to Ao fo.
