

HOPE FOR STREET KIDS

In December 1991, Duncan and Jenni Dyason read a magazine article that was to change the course of their lives.

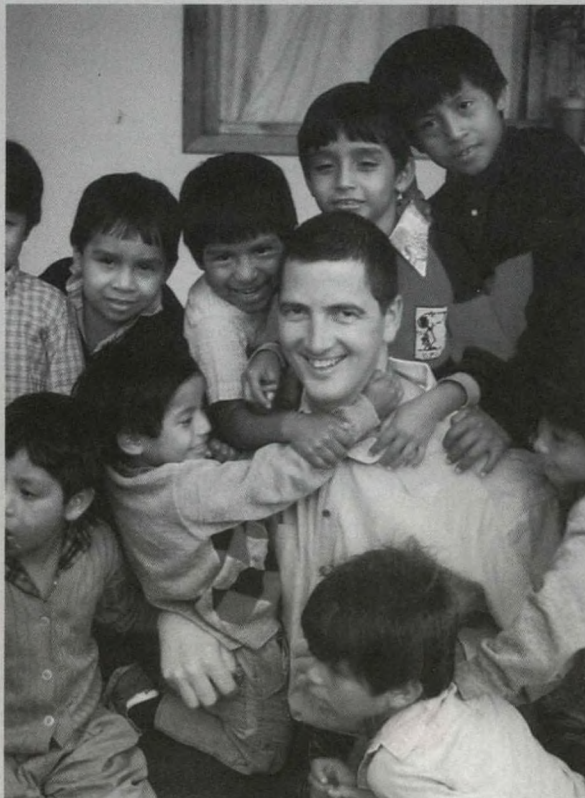
The article detailed Jubilee's action for Street Children and started a chain of events that has led Duncan (32), his wife Jenni (30) and their baby daughter Katelyn to leave their home here in England and go to Guatemala to care for abandoned children.

The Dyasons had already seen BBC TV's documentary "They Shoot Children Don't They?" about the plight of Street Children in Guatemala featuring the work of Bruce Harris.

Duncan first visited Guatemala last March. "You never get over meeting a street kid for the first time. The dirty face – no shoes – sores and cuts and bruises. The innocence has gone; there's a vacant look in their eyes. It's a painful experience, and it was painful to leave and come back to Britain." Duncan returned knowing he and Jenni were being called to act.

Although experienced at working with children in need, having spent the last 5 years working with young people from their base at St Leonards Church, Chesham Bois, Duncan admits you can never really prepare yourself for the sights on

The Dyason family moved to dangerous Guatemala City to care for abandoned children.

Guatemala's streets. "The moment that you catch a glimpse of a street kid and he smiles at you is heartrending" he said.

The Dyasons are working under the direction of Bruce Harris of Casa Alianza and will represent Jubilee Campaign during their mission. With an estimated 5000 abandoned children living on Guatemala's streets their work is vital. Casa Alianza rescue the children from the streets to rehabilitate them, eventually placing them in group homes where they can receive all the benefits of a family life.

Jenni explained "The kids don't trust adults. They get lots of short-term help, but we want to be committed. You can't build up trust from the kids in a short time."

Day to day life in Guatemala is dangerous with an 80% increase in violence against the children recently reported and continual threats against Casa Alianza staff. Despite the danger Duncan and Jenni knew they had to act, "The many children in Guatemala whose only home is the street, need help urgently," said Duncan.

UPDATE

PROTECTING CHILDRENS RIGHTS

FOREIGN OFFICE

The FO asked Jubilee for input prior to the Minister's statement to the United Nations. A resolution seeking change tabled by Britain at the UN and adopted in December 1992 is available on request from the Campaign office.

THREATS

Bruce Harris, Casa Alianza's Director, received threats and requested Jubilee's assistance. We alerted the media and at a meeting with the Guatemalan Ambassador and the Deputy Foreign Minister, a senior adviser to the President told Jubilee that Bruce would be given plainclothes bodyguards and an armoured limousine when he visited the country. Foreign Office Minister, Tristan Garel Jones MP sent our report to the British Ambassador in Guatemala and raised our concerns with the authorities. Mr Garel Jones said, "The Guatemalan Vice Minister of Foreign Affairs gave me an assurance that the Government would do what it could to ensure Mr Harris' safety."

ENDORSEMENT

Labour leader John Smith has added his voice to our campaign, joining Prime Minister John Major and Liberal Democrat leader, Paddy Ashdown: "The



offer of Street Children is an issue which deserves attention and action. I wholeheartedly support your worthwhile efforts to publicise their plight and also to alleviate their situation by providing practical assistance for emergency aid and educational and training projects."

PHILIPPINES

Our campaign was widely reported by the media and Fr Shay Cullen met representatives from Scotland Yard's newly formed National Criminal Intelligence Service and presented them with a copy of our report. Several MPs attended the campaign's launch in Parliament and promised action.

Fr Shay told us that the case against him was probably going to be dropped. He is currently working to bring a suspected murderer to trial. He has worked with a major law firm to bring a class civil suit against the US navy for promoting the circumstance of sex abuse against children and not taking action against it. Jubilee's report will be used as evidence to back up the charges.

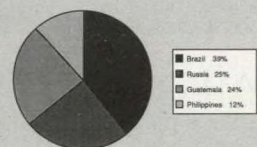

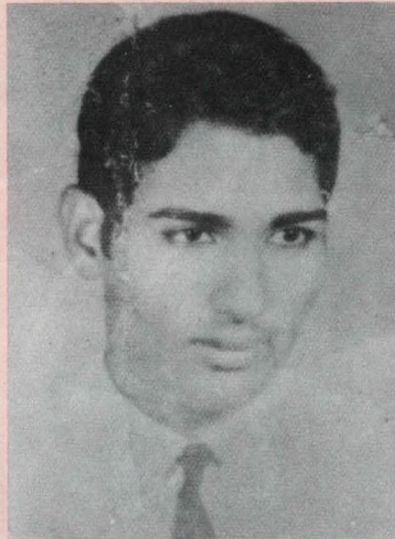

DEATH SENTENCE

Gul Masih, a 42 year old Christian in Pakistan was sentenced to death on 2 November 1992 for the crime of "blasphemy against the Prophet Mohammed", solely on the evidence of a Muslim neighbour. Under section 295(c) of the Pakistan penal code, this carries a mandatory death penalty. He currently waits on death row in Sargodha prison while an appeal is heard in the Lahore High Court. Gul Masih's case has been raised with MPs and the Foreign Office.

Gul Masih's case was included in a report prepared by Jubilee and handed to the British FO Minister Douglas Hogg prior to the British delegation's visit to the UN. The report has also been featured in the media and sent to key MPs and FO officials seeking their support. An "action pack" is currently being prepared.

Christians 'are being crucified by Muslims'

THE persecution of Christians in Islamic countries has reached new heights, ranging from mass crucifixions in Sudan to draconian new religious laws in Pakistan, according to a report published this week by a leading Christian human rights organisation.

The Jubilee Campaign, a lobby supported by more than 100 MPs, has supplied

Mr Hogg, Foreign Office Minister, with details of the "appalling suffering" of Christians in the Middle East, Africa and Malaysia.

□ In Sudan, says the report, the civil war has led to a "genocidal reign of terror" directed against the Christian south by the Islamic regime in Khartoum, with mounting evidence of the crucifixion of the male population of whole villages by government soldiers.

□ In Pakistan, the imposition of sharia (Islamic law) in 1991 has led to the first death sentence for "blasphemy against the Prophet".

Mr Gul Masih, a 42-year-old Christian, was convicted solely on the evidence of a Muslim neighbour. If his appeal fails and he is executed, says Jubilee, an important precedent will be set permitting the execution of Christians for their religious beliefs.

□ In Egypt, where 10 per cent of the population is Christian, the government is suspected of turning a blind eye to the burning of churches and the murder of Copts by gangs of Muslim extremists.

The report points out that, since President Mubarak came to power in 1981, not one church has been built while thousands of mosques have been completed.

□ In Saudi Arabia, where all Christian worship is illegal, the report claims persecution has increased since the Gulf war. "A number of Christian Iraqi prisoners of war have remained in detention and are reported to have suffered discrimination, beatings and torture in an attempt to persuade them to accept Islam," it says.

□ In Malaysia, churches have been forced to close as states have passed laws forbidding proselytising by non-Muslims. The Malaysian-language bible is strictly censored.

A Jubilee spokesman Mr Hogg received a det briefing before visiting current session of the United Nations Commission on Human Rights, which is preparing a confidential report on Sudan.

"We very much hope it will be made public," said the spokesman. "The level of killing there is absolutely horrendous."

CHINA: UPDATE

• CAMPAIGN BRIEF LORD HOWE

Jubilee were invited to brief Lord Howe on issues of concern in China before his official visit. Richard Wames handed him a 84 page dossier listing the names of Chinese Christians currently imprisoned. The Lord Mayor of Liverpool was also sent Jubilee's report prior to her official visit and asked to intercede on behalf of specific cases of concern. Twenty two Chinese cases have been adopted by MPs from all parties under Jubilee's Parliamentary Adoption Programme.

• HENAN 120

All 120 Chinese Christians arrested in Henan Province last September were released in December 1992, although most had to pay heavy fines. Church leaders who were arrested believe that outside pressure on the government was the primary reason people were released without charge. There has been no further persecution in the area since the mass arrests.

Dear Mr Ancer,

Thank you for your letter of 5 May 1993 which was passed on to the Research Department to answer. I am sorry for the delay in responding to your request, but I have been awaiting replies from several others to my queries in connection with your request to fund the festival you will be holding from 16-18 July 1993.

While your festival will cover a variety of topics that Amnesty International is interested in seeing addressed, we regret that we are not in a position to fund such events from this office. We have also investigated the possibilities of finding funding for your festival through both our Human Rights Education office and our contacts in the USA and UK, but I'm afraid none of them will be able to help either. This is not a reflection of the worthiness of this festival nor the topics that you will discuss. The problem we are having is that Amnesty International has very strict guidelines about the distribution of our scarce resources, and these only include relief payments to certain types of prisoners and ex-prisoners and their dependents or, in some cases, certain carefully-defined projects that are funded through our Swedish Section at their discretion. This team in the Research Department knows the value of your contribution to the struggle against apartheid, but we are simply not in a position to authorize any funding for you and our requests for funding through other offices has not been successful.

One of our colleagues in our US Section suggested that if you have not already done so, you might consider contacting the Africa Fund in New York. You could contact Executive Director Jennifer Davis or Adoti Akwei



The End Conscription Campaign was formed in 1983 as an anti militarization movement, specifically voicing its objection to conscription. There is little doubt that the South African Government used the system of 'whites-only' conscription to conscript white men into its army to defend and implement its policy of apartheid. The End Conscription Campaign was formed ten years ago in opposition to apartheid and campaigned against the system of Conscription. Young South African men who refused to serve in the South African Defence Force (SADF) faced 6 years in prison or were forced to flee the country. The ECC assisted young men faced with these decisions and campaigned against the role of the SADF in Namibia and Angola and its presence in African townships. Although the ECC is rooted in the white community it has nevertheless been accepted as an integral and significant part of the anti-apartheid movement.

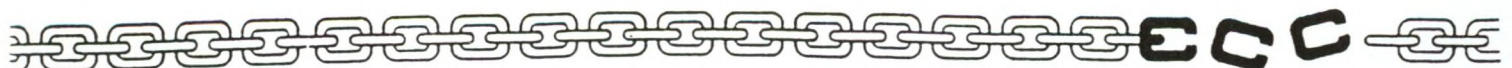
