

(Not Fet. Const.) See Memo on Det. Sgt. Helberg who reported the s-me meeting - Meeting No. 1 - 1648 and 1656 (V.9.).

This is a poor and very unreliable reconter who is also not an honest and truthful witness as was demonstrated in x examinations at the P.E. e.g. see P. 1663, 4, 5, 6, 1672, 3 where he denies emphatically that things which are contained in Helberg's note were ever said.

This witness states that at every meeting the use of force and violence is repudiated 1667(V.9) - that he was instructed by Helberg to listen at mestings for statements concerning the overthrow of the Government, the use of force and violence P. 1673 & 4 (V.9) (Denied by Helberg at 1680 (V.9).) and that his reason for not recording that speakers had at meeting No. 1 repudiated the use of force and violence was due to the fact that he did not write down everything that was said - see P. 1678.

This witness also stated that he recorded the "exact" words used by the speakers - See 1661 (V.9.) -This is obvious nonsence and untrue - (Refer to the witness' note of the speeches and see also the difference between his recording and Helberg's who also states he recorded the exact words.) The witness also stated that he understood the speakers very well and that he understands English well (P.1661 -V.9) but he retracts this obvious falsehood later at P. 1661 1662 (V.9.)



2 ye. any of these topics could have been discussed P. 1663, 1655, 1666, 1670, 1672, 1673 V.9.). The witness concedes that the use of force and violence was repudiated by speakers and volunteers the statement that this was done at every meeting 1667 (V.9.).
