A : NATIONAL EISTEDDFOD

- 1. The Third National Eisteddfod will be held at Kwa-Thema Civic Hall, Kwa-Thema, Springs, on Saturday, 4th July, 1964, commencing at 9.00 a.m.
- 2. Springs is some 29 miles east of Johannesburg. Those choirs travelling by train from outside the Transvaal should change at Germiston and take a local train to Springs.

 Buses will be available at Springs to take choirs to Kwa-Thema Civic Hall.
- As soon as the provincial competitions are over, the Provincial Secretary should advise Mr. I.E. Zwane, Zamani Community School, P.O. Kwa-Thema, Springs, of the total number of children and teachers attending the Eisteddfod, as well as of the time of arrival at Springs.
- 4. All choirs should sleep at Springs on the night of the 3rd to avoid any disappointments.
- 5. Arrangements have been made for a reception at the same hall on the night of the 4th July.
- 6. Each choir is required to pay a sum of R4.00. This stipulation applies to trios and duets as well.
- 7. Choir conductors are reminded that the maximum strength of a choir is 60 voices.
- 8. All National Eisteddfod trophies should be returned to the General Secretary, A.T.A.S.A., on or before June 1st, 1964.
- 9. Choirs proceeding to the National Eisteddfod will be those which shall have won in each song in each of the following sections:
 - (a) Senior Mixed Choirs
 - (b) Secondary Mixed Choirs
 - (c) Double Quartettes
 - (d) Ladies Trios
 - (e) Ladies Duets
 - (f) Teachers' Choirs
- 10. Admission to the Eisteddfod will be Rl.00 all round.

B : GENERAL

- (I) We have requested the Minister of Bantu Education to grant us an interview for the 5th June, 1964. At this interview the A.T.A.S.A. will discuss matters raised in a memorandum submitted early this year to the Honourable the Minister.
- (II) Radio Bantu have requested us to allow them to attend your provincial conferences for the purpose of explaining the Schools Broadcast. Please accept them.

 Constructive criticisms of the Schools' Radio Services should be sent to us before the 5th June, 1964.
- (III) The provincial affiliation fee of R50.00 should be sent to the Treasurer, Mr. X.L. Time, P.O. Zwelitsha, King William's Town, after the Provincial Conference.
