With reference to our telephone discussion last Friday, I am glad to be able to inform you that I have been recommended to a Physician in Kimberley. I am making arrangements for this Physician to examine Mr Sobukwe.

It will, however, be necessary for a Psychiatrist to fly from Johannesburg to examine Mr Sobukwe. The Psychiatrist is Dr D. Wynberg, of 304 Medical Arts Building, Jeppe Street, Johannesburg. His qualifications are B.A. (Rand), M.B. Ch.B. (Edin.), and D.P.M. (Rand).

The arrangement will be for Dr Nynberg to arrive in Kimberley by air at 9.30 a.m. on Saturday, June 28. A car, hired from a local firm, will meet him at the airport, and the driver can take him to Mr Sobukwe's home, fetch him for lunch, otc Dr Wynberg will leave Kimberley on the 5.45 p.m. flight.

As discussed, it would be much appreciated if a permit could be issued to Dr Wynberg to enable him to enter Galeshowe Village during the above times. It would obviously be far more satisfactory for him to be able to examine Mr Sobukwe at his home.

Could the necessary permit be sent either to me or direct to Dr Mynberg as soon as possible?
