DECISIONS OF THE EXTRA-ORDINARY MEETING

OF THE CENTRAL COMMITTEE HELD IN DAR ES SALAAM

FROM APRIL 30 TO MAY 1, 1979

The Central Committee of the Pan Africanist Congress of Azania, meeting in an Extra-Ordinary Session on April 30 and May 1, 1979, at External Headquarters, Dar es Salaam, Tanzania;

After receiving reports on the state of health of the Chairman of the Central Committee, Comrade FOTLAKO K. LEBALLO, as well as a recommendation by the Chairman's doctors that he should with immediate effect cut down his work load and go for further medical treatment;

Decided, after due deliberations to:

1. Join with the Chairman in his decision to follow the advice of his doctors;
2. Appoint a PRESIDENTIAL COUNCIL of three members of the Central Committee charged with the responsibility of fulfilling the Chairman's duties.

The Presidential Council is the organ of the Central Committee of the PAC charged with the responsibility of carrying out the duties of the Chairman in his absence:

- (a) It shall be composed of three (3) members of the Central Committee;
- (b) A member of the Presidential Council will preside over meetings of the Central Committee on a rotational basis;
- (c) The Presidential Council will maintain regular contact and communication with the Chairman of the Central Committee;
- (d) The members of the Presidential Council are:
  - (i) WUSUMZI L. WAKE; Administrative Secretary;
  - (ii) DAVID M SIBEKO, Director of Foreign Affairs; and
  - (iii) ELIAS L. NTLOEDIBE, Director of Publicity and Information.

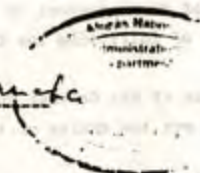
