Advertiser's, it will come out before Tuesday if the chief can make some means to make a wire on Monday or Tuesday to be ready by Tuesday evening to appear in the report together with Mr. Machin's & 2. and others. You will also realise that in Mr. Boyce's speech he did not forget to tell the ~~the~~ ^{Yoronere} ~~for~~ ^(I can't make this) Boyce's speech and Tugane, so that both of them should do something square, please send something by wire on Tuesday or Monday.

You should have long heard all about this if it was not because of Boyce's notes, by making trouble for me saying that I should take the collection and give it to Mr. Barrett of Native affairs. In this devilish scheme, he was supported by Mr. Barrett. They went to Black people of Lobenstein and go Greenpoint. to be sure that they cheat me and turn the minds of Black-people away from me and three weeks of sleepless nights and unnecessary expense want the Black-people to write to me.
