Kuper & Co., and that it would be possible to obtain part of the premises of the Clarendon Hotel for a rental of £25 per month. It was suggested that the whole building should be acquired. Mrs. E. Norgarb agreed to accompany the chairman to interview the agents.



It was therefore suggested that application be made to the Council for suitable land which it might have available on which Club premises could be erected which would serve after the cessation of hostilities as a permanent community Centre for the Coloured community of the City. It was also suggested that the Department of Defence be approached with a reis

view to obtaining not only a substantial grant to assist in establishing the Club but also grants in respect of equipment and building material and a monthly grant to assist in the maintenance and administration of the Club. In this connection it was pointed out that volun-tary services for the running of the Club could not be SiClub. expected and that payment of such services would form part of the maintenance costs of the Club. In so far as the buildings were concerned, it was suggested that Professor Pearce of the Department of Architecture of the University of the Witwatersrand be approached with a view to obtaining the co-operation of his students in the matter of drawing up plans which would be suitable not only for the Club itself but for an attractive and permanent community Centre for the Coloured Community after the war. RESOLVED

- (a) That the Council be approached with a view to obtaining suitable land on which Club premises could be erected and which would serve after the cessation of hostilities as a permanent Centre for the coloured community of the City.
- (b) That the Department of Defence be approached with a view to obtaining a grant to assist in establishing the Club, an equipment grant and a monthly grant to assist in the maintenance and administration of the Club.
- (c) That the Department of Architecture of the University of the Witwatersrand be approached with a view to obtaining assistance in the drawing up of plans for the Club.

 - Municipal Non-European and Native Affairs Department;
 - Municipal Social Welfare Department; Joint Council of Coloureds and Europeans; African Peoples' Organisation; Garment Workers' Union;

 - S.A.W.A.S. Command 10; Y.M.C.A. Non-European War' Work Council; O.C. Coloured Troops; Officers and Coloured Ex-Servicemen's Association;
 - Coloured Committee, parallel to the European . Defence Liaison Committee.
- (b) The committee shall have the power to co-opt not more
- (c) The quorum for meetings of this committee shall be not less than one third of the members of the committee.
- 4. FINANCE.
 - The secretary treasurer shall receive all monies (1)paid to the club.
 - All contributions to the club shall be paid into a separate bank account, kept in the registered (11) name of the club.
- All cheques payable to the club must be signed by (111) at least two of the following officers.
 - Chairman;
 - Vice Chairman;

 - (iv) The books of the committee shall be audited annually by an accredited auditor.

VI. FINANCES.

Miss Creighton-Jones informed the committee that the City Council had given the club a grant of £30 per month for the ensuing inarcial year, and that £10.10.0 had been received from the Gifts and Comforts Fund for Coloured Soldiers. About forty letters asking for donations had been sent out and up to date one cheque for £10. 2.0 had been received from Mr. F.A. Unger. The Chairman said that Mrs. G.B. Twycross had kindly consented to convene the street collection for the Cape

Corps Club on 1st. July. Mrs. Twycross said that about 2,000 appeals had been sent out and that these had been donated by Mr. G.B. Twycross. The Chairman expressed the appreciation of the committee of this generous gift.

Col. Morris suggested that various canteens should be approached and asked for donations towards the club out of their profits.


