Whereas by treaty, grant, sufference, and other lawful means his Majesty the King has power and jurisdiction within the limits of the Bechuanaland Protectorate:

And whereas the Rhodesia Railways Ltd has applied for a grantof a certain portion of land known as "the Railway Strip" situate in the area known as the Barolong Farmsin the Bechuanaland Protectorate;

And whereas it is expedient that the said land should be vested in his Majestyand that his Majesty's High Commissioner for South Africa should be empowered to make a grant threof to the Rhodesia Railways Ltd their successors or assigns;

Now, therefore his Majesty, by vartue and in excercise of the powers by the Foreign Jurisdiction Act, 1890, or otherwise in his Majesty vested, is pleased by and with the advice of his Privy Council to order, and it is hereby ordered as foldows;

- 1. The portion of land known as the Railway Strip in extent 154 morgen and 69 square roods situate in the area known as the Barolong Farms in the Bechuanaland Protectorate, bounded on the north by Glaisdale, on the south by Ramathabama's Kuil, and on the east and west by the Barolong Farms, as more fully appears from the sub-divisional diagram signed by the Resident Commissioner of the Bechuanaland Protectorate, and deposited with the Registrar of Deedeof the Protectorate, is hereby to be vested in his Majesty.

- 2. The High Commissioner/is hereby empowered to grant the said land to to the Rhodesia Railways Ltd on such terms and conditions, and subject tosuch provisions as to reversion of the said land to the Crown in the event of the railway ceasing to be operated thereon, as he shall think fit, provided that such grant shall not be made until the High Commissioner is satisfied that the Rhodesia Railways Liimted has erected a suitable fenceon the east and west sides of the said Strip.
- 3. This order may be cited as " The Bechuanaland Proftetatete (Railway Lands) Order-in-Council, 1922.
 - 4. His Majesty may at any time addto, alter or amend this Order.
