Op 1982.02.05 omstreeks 01h45 het Sersant Agenbag aan my in die Aanklagtekantoor rapporteer dat 'n gevangene Dr. Neil Aggett Sel nommer 3004/12 homself in die selle opgehang het.

Ek het Sersant Agenbag na die selle vergesel en gevind dat die persoon reeds dood was. Daar was geen polsslag in die liggaam nie en die liggaam was nog warm. Die liggaam het teen die tralies van die sel gehang aan 'n stuk materiaal.

Ek het onmiddellik Lt. Kol. Scholtz van die Veiligheidspolisie in kennis gestel. long?

Na die aankoms van die offisiere van die Veiligheidspolisie het ek die duplikaat sleutel aan Sersant Agenbag oorhandig wie die sel oopgesluit het sodat daar met die ondersoek begin kon word.

Ek het nie 'n dokter in kennis gestel nie aangesien ek nie die opdragte van die Veiligheidspolisie ken nie.

Ek was en is nog steeds oortuig dat Dr. Aggett oorlede was toe ek hom vir die laaste keer gesien het.
