Dear Divisional Pathfinder,

I attach hereto copy of a statement, which I handed to the Press on the 4th instant, for your record.

For your information and guidance I enclose copy of a letter from a Cabinet Minister which has been handed to me by the recipient. It will give you, I think, a correct interpretation of the Government policy. The letter is not marked confidential but I think we should not be responsible for publication in any form.

It may be well to remind ourselves that the decision to send Pathfinders to the Jamboree was based upon a meeting of the S.A. Scout Council in February 1930 that Pathfinders are entitled to take part in International Scout Jamborees.

The matter is one of the greatest importance to the Movement and will have to be considered very carefully and with the utmost discretion at the next meeting of the Pathfinder Headquarters Council.
