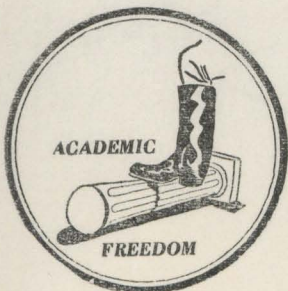
I do not know the Chief's address and am very loath anyway to send matter to him by post, so would be grateful if you could arrange for the enclosed letter to be handed on to him.
