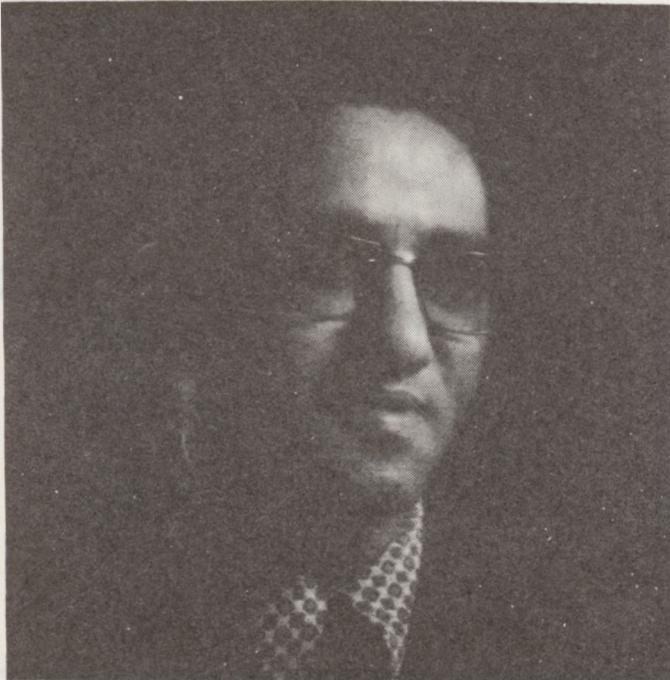

Truth has the uncanny ability to surface at the most unexpected time and expose its shining armour to the cause of justice, when all seems lost and forlorn; and often destroys the ill-laid plans of mice and men. Events in the soccer world, such as the World Cup in Spain and the still-born soccer tour of South Africa, has reminded us that sport is an intergral part of the national pride of nations and that despite faked floral outer coverings, the discoloured and dirty linen underneath our apartheid socio-political system, cannot fool all the people all the time. The dictum that we cannot have equal sport in an abnormal society remains real.

The rebel tours : cricket, soccer and others show clearly that the healthy spirit of competition and gamesmanship is viciously soiled with undercover agents, monstrous fees, akin to bribery; and even mopping up operations by the dreaded security police to look for scapegoats for the failed policies of the apartheid state, leaves little doubt that no amount of blusterings can erase the fact that in this country politics and sport have been intimately wedded.

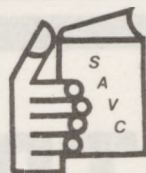
The heartening return of Lenasia's cricketers to the non-racial fold has evoked blinding rage from white quaters : sportspersons, officials and the now clearly biased white English Press strengthens our case that our cause is a just one. Wild and wooly allegations that political threats of violence, ofcourse untested and substantiated, caused these cricketers to return to their natural home, is as absurd as the arguments that the cancellation of the soccer tour was senseless self-injury to black soccer. In effect our sports-persons are increasingly begining to realise that multiracial and

multi-national sports has made no impact on the prejudices, and practices, inherent in our racist order. It might have helped to salve certain consciences within the sporting arena, but where are its positive effects in the day-to-day economic and political realities of our colour conscious and racially inequitous society? Ever so often, events and instances, makes us suspicious and create the impression that commitment to multiracial, let alone non-racial principles is but skin deep. The jaundiced blood of racism courses intensely in many veins that profess to be colour-blind.

Take the case of cricket : not long after the death of Rashid Varachia, the Cricket Council organised the profitless Gooch & Company debacle; and already this season at administrative level the TCC have given boot the only other "Indian" representative on the Council, thus reverting to an all-white administration. The rejection by the ICC to consider South African membership appears to have for the time being removed the need for window-dressing at the top. Yet editorials in the English Press have the temerity to say that by opting not to play with the TCC is segregation and one sportswriter, in addition to making false claims of political intimidation and victimisation, calls this the "death of an ideal, an act against non-racialism. We say with our heads high and dignity intact that the voluntary return of our sports-persons to the fold of the non-racial code reflects the frustrations and disappointments felt by those who believed that through sports contact meaningful change in attitudes and practices would follow in other spheres. Strange are the ways of the so-called "white liberal press", they term objectivity and reality, when we question their motives in creating special and extra editions on racial basis; but when we point out that by such ploys news becomes segregated, unbalanced and panders to self-censorship by the media, we are labelled as radicals and not worthy of news. Yet, when our sports-persons return to the roots of reality and honesty, they level charges of segregated sports and backward steps. Surely, an unmitigated example of double standards and forked tongues. Often, editors have commented, that the function of newspapers is to present events, facts and "objective" comments; and that it is not their function to lead people. Yet, their reaction to our opinions and leadership, leaves us convinced that they are brutally angered when we refuse to be led by our norms and directions. We might be deprived, denied an oppressed, but our basic humanity remains intact; and as victims of discrimination we are the best people to judge whether the steps taken in the direction of mixed sports fulfills the criteria of non-racialism and a just society.

In conclusion I am proud to have been associated with the Lenasia Football Association and their faith in the cause of a non-discriminatory and a normal society is an important instrument in bringing about meaningful change and it cannot function in isolation from the grass-roots demands and expectations of the masses. Finally a welcome back to all those who have returned to the bosom of non-racialism and help to swell the ideals of a free and just mandate.

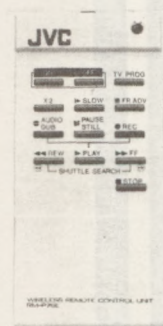
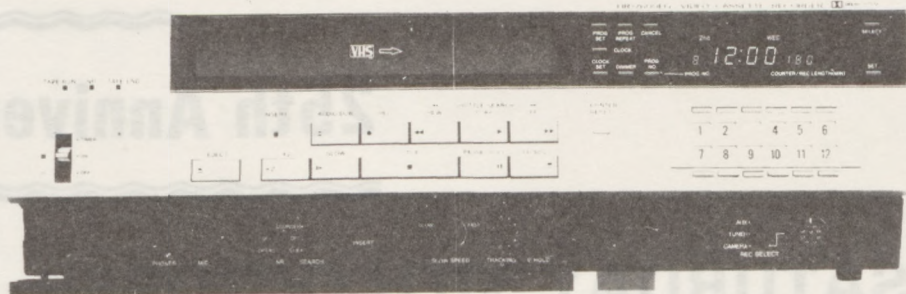

In 1960 the Indian families from the Sophiatown/Newclare complex were moved to Lenasia. Members of the former Martindale City F.C., who moved with their families, established the Daffodils F.C. in Lenasia and affiliated to the W.D.I.F.A.

Mr. Gibson Pillay was elected chairman of the club and that same year he was also elected chairman of W.D.I.F.A. With the assistance of messrs Isaac Nerpath, Ramesh Sunker, Norman Napier, Sewa (Harry) Singh, Smalal Chunka Singh and the late Mr. Abdul Karbelkar, he steered the club to many achievements.

Daffodils won the league and knock-out championships in 1962. In 1965 they were league runner-up.

Towards the mid-sixties a younger set of officials took over. Men like Messrs Mr. Baby Singh, G. Hendricks, J. Singh, S. Singh, S.Khan, A. Lall, R. Sunker, and A. Subjee administered the club and ensured that it continued its membership with the L.F.A.

In 1970 Mr. B.S. 'Baby' Singh was appointed as an H.L.V.P. of the Association and in 1973 Mr. A. Lall was elected as the Association's President.

In 1981 Daffodils won the Super League Championship. This was achieved largely as a result of Mr. K. Poonsamy (Uncle Sammy), the club's manager, and messrs B. Subjee, B. Thomas, R. Subjee, and R. Morgan.

The Daffodils F.C. takes this opportunity of extending its congratulations to the officials of the L.F.A. for their effort in bringing about the commemoration of the Silver Jubilee.

games ever watched by soccer fans, where Swaraj won by the odd goal. Even today people reminisce about that match.

In 1967 the Swaraj Club annexed the Atlantis Dynamic Soccer Festival, in Benoni. Here too, one of the Swaraj players, Liks Padayachy, won the "Best Player" award.

Some of the most stirring performances of the Swaraj Club were: A 3 - 2 victory over the celebrated Orlando Pirates at the Lenasia Stadium in 1972 a 3 - 1 win against Moroka Swallows Big XV at Nirvana Grounds in 1973 and defeats by Kaiser Chiefs and Orlando Pirates in the same year.

1974 Saw Swaraj in the Fed League, boasting with names such as Buick Mkwati, Smily Moosa, Dan Twala, Pro Ariel and our "local boys". With this affiliation and with the reality of seeing the mighty bulls (Swaraj/Bells/Dynamos) in action brought about real professionalism in the teams. The Transvaal and Lenasia was in for a real soccer feast.

The Admin Staff of the club been what they always were dedicated and goal seeking never left any stone unturned. Here great credit must go to Mr Billa Singh.

In 1974 Swaraj finished fifth, 1975 they ended in joint fourth and in 1976 occupied 3rd spot only to be pipped by goal average for second spot.

Then it happened - 1977 - starting the season off badly suddenly the Admin staff brought in Alex Forbes and players like Jimmy Joubert, Cheese Manna, Victor Kowa & others & with a game in hand we won the Fed league. What a culmination to a very wonderful season

after only its 4th year in Fed.

Well done Swaraj: The Admin Staff, players supporters & well-wishes.

A special thanks to our local players some of them who played without receiving any remuneration to them the club expresses appreciation and thanks.

1978 Saw Swaraj in financial difficulties and ultimately selling franchise and this saw the slide of professional football in Lenasia - the other clubs also found it hard to make ends meet and soon found that the sacrifice as too taxing.

Professionalism came to an Abrupt End in Lenasia.

1982 Saw "Swaraj United" emerged seeking affiliation to the Fed. After representation the name "Swaraj" re-appeared in the Feds records.

We want to wish "Swaraj United" all the Best in the "First" year and hope that Courage, Discipline & Dedication will be the winners in seeing them through their struggle to keep the "Fed" going strongly in Lenasia.

At present the Swaraj Club has 8 divisions affiliated to the L F A.

We want to thank the L F A for giving us the opportunity and space to make this article possible.

We want to wish them Well for their forthcoming tournament and a very Happy 25TH ANNIVERSARY.

A BRIEF BACKGROUND TO THE SWARAJ CLUB

The Swaraj Club was formed by a bunch of young dedicated men, in 1949 in Sophiatown, now the white suburb of Triomf.

Our first affiliation was to the Witwatersrand Indian football Association where we progressed along the ranks to the most senior division. In the Wits I F A we won many of the competitions and were always amongst the finishers.

When the Indians of Sophiatown were removed to Lenasia in 1959 we were forced to join the Western Districts Indian football Association. In the W D I F A we finished tops, taking all the honours and by wide margins.

Because of the poor competition in in the W D I F A we decided to play "freelance" and withdrew from the W D I F A in 1962. We played "free-lance" until 1970 when we affiliated to the Transvaal Professional Soccer League.

While playing "free-lance" we used the Lenasia Indian High School Grounds as our "home" ground. In August 1966 we were reported for playing non-racial soccer and were under the constant surveillance of the police.

This ban was defied and we continued to play non-racial soccer for two more years. Eventually the High School Ground was taken away.



We then developed the present Nirvana Grounds. But to retain it we had to belong to a "recognised" unit. There being no unit to cater for our needs and at the same time, retain our grounds, we then affiliated to the T P S L in 1970.

In 1973 we sought and were granted affiliation to the first division of the S A Soccer federation Professional League.

The Swaraj Club were the sponsors of the annual Lenasia Soccer Tournament. This tournament was inaugurated 1965. It was the first Tournament in the Transvaal, if not the Republic, to be staged on a Saturday and Sunday.

Swaraj were once joint-holders and seven times beaten finalists in the Lenasia Soccer Tournament. This

Tournament had many memorable occasions.

The Swaraj Club was growing from strength to strength and were always invited to participate in tournaments. The club participated in many tournaments.

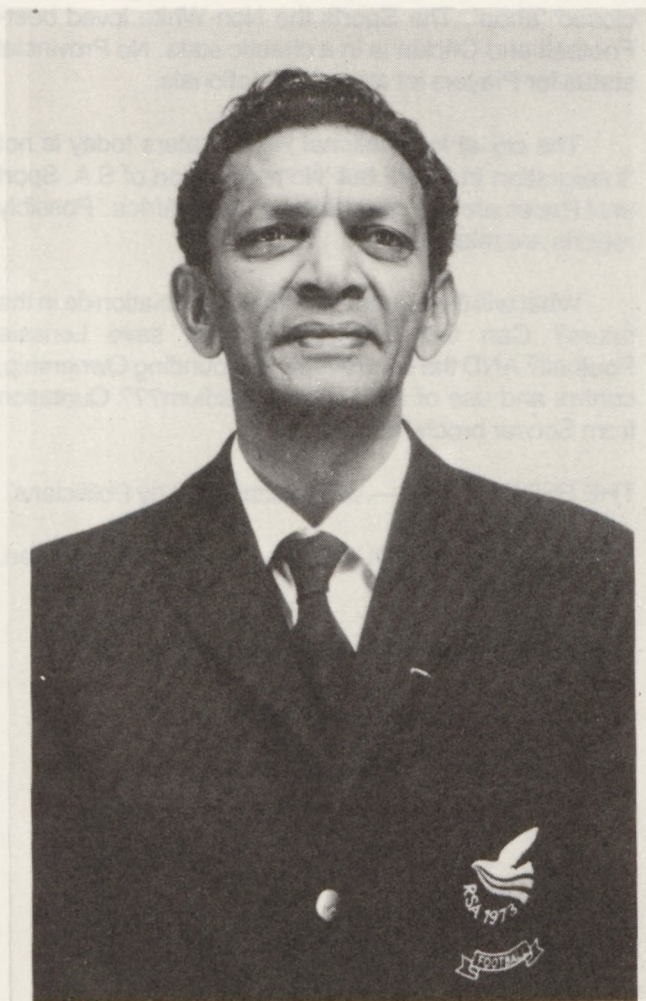
We annexed the 1962 Piet Retief tournament, defeating Witbak Black Aces in the finals which was played in semi-darkness.

In 1963 Swaraj contested the West Rand Soccer Tournament finals, losing to Young Dynamos by the odd goal in 3. In that tournament, our player Nyna Moodley was judged the "Best Player", Virgil Padiachee also received this award in a later tournament.

The Swaraj versus Grupo Desportivo de Cabral match in the last W R S T in 1964 was one of the best

Congratulations L.F.A. Officials, Councillors and Players, on your 25th Anniversary.

It is known that the L.F.A.—formerly the Western Districts Indian F.A.—was born in the turbulent and trying times for many of Johannesburg's Indian Families.

The first few families were housed in the 'old' Lenz Military Camp in late 1955, and towards the end of 1956 the first six Houses were built and occupied in the Lenasia Township, by Indians who had either foresight and enterprise, or, were sick and tired of the unscrupulous Indian Landlords.

Hardship, and harassment by political agitators, were experienced. Today most of the early pioneers are their own Landlords.

The Residents of Lenasia in 1957, formed the W.D.I.F.A. and thus provided much needed entertainment for their Community and Health Recreation for their youth and seniors. (A PROGRESSIVE MOVE.)

The W.D.I.F.A. sought Affiliation with the Transvaal I.F.A. and did so by REQUESTING the formidable Witwatersrand Indian F.A. ('Wits') with its knowledgeable and powerful Officialdom, to sponsor the W.D.I.F.A. at the T.I.F.A.

After a joint discussion the W.D.I.F.A. were told that it should become a SUBSIDIARY to the 'WITS'.

The Battle was on. THE W.D.I.F.A. WERE NOT PREPARED TO BE SUBSERVIENT TO ANYONE. Their Officials were well conversant with the Constitution of the T.I.F.A. and the S.A.I.F.A.

The East and Far East Rand I.F.A. were asked to sponsor the W.D.I.F.A. They did so and W.D.I.F.A. was unanimously accepted by T.I.F.A. THE W.D.I.F.A. WERE NOT STOOGES FOR ANYONE, and had powerful friends too.

The W.D.I.F.A. 'MADE' its own ground outside the 'Camp', and further growth used the Lenasia High School grounds, but soon encountered difficulties with the Authorities on the use of School property.

Application was made to the Lenasia Rate-payers & Residents for the use of the Grounds earmarked in the Sports Complex in the Township.

Two Grounds were available, ONE TURFED later. This was only the SECOND TURF MADE AVAILABLE TO INDIAN SPORTSMEN IN THE TVL. The first was in Pretoria in 1948.

ANOTHER ACHIEVEMENT. The WDIFA had MEN WITH THE ABILITY, FORESIGHT AND 'GUTS'.

Soccer was booming. The S.A. Soccer Federation had been formed, AND S.A. International Matches were played. The 'Racialist' S.A. Coloured, African and Indian Associations were the participants, and many a thrilling match was witnessed, surely, THESE WERE THE GOLDEN YEARS' OF NON-WHITE SOCCER.

The SASF now wanted 'Intergrated' Soccer, Associations & Clubs, and the disbanding of all 'Racial Bodies'. A Tall Order. The reluctance of the National and Provincial Associations was very evident.

At the formation of the SASF the African F.A. was accepted - in preference to the Bantu F.A. The Bantu F.A., with whom the Tvl. Indian and Coloured had strong ties, retaliated by linking up with the White - F.A.S.A. and were provided with Coaching and sponsorship and prospered Football and financial wise--while Indian and Coloured struggled to survive.

Thanks largely to the Department of Indian Affairs, S.A.F.A. and the men at the head of affairs locally, for providing the Sporting Fraternity with an enclosed Stadium with two Grounds, Grandstand seating 2000 spectators, Dressing and Shower-rooms and Electricity.

The achievements of the L.F.A. Officials & Players was stupendous when considering what was done, starting from scratch, in 10 years. THE LFA HAD THE LEADERSHIP AND DETERMINATION TO DO THINGS.

Has the LFA kept up with its growth by producing **NEW CAPABLE & CONCIENTIOUS ADMINISTRATORS** to cope with the new demands?

Has **THE PLAYERS ABILITY** grown with the growth of the LFA?

Has the LFA **PROVIDED QUALIFIED/CERTIFICATED COACHES** for its **PLAYERS**?

The L.F.A. has some sound sponsoirship. At certain levels there are paid individuals doing administrative work, therefore there is no lack of Finance.

The administrative work should be good, and the Playing standard should automatically be better, as Officials will have more time to delve into **PROVIDING COACHING OF PLAYERS AND REFEREES.**

Big Bank Balances are good but are of no use if not profitably used. What better way of spending Football Money **THAN PAYING FOR EXPERT COACHING OF THE PLAYERS WHO BRING THE SPECTATORS WHO WILL BRING IN THE BUCKS?**

Years age Administrators and Players were told

that 'Integration' in Sport will give Non-White players International status and Matches, Today the National 'Racial' Associations are in 'Cold storage' or have closed 'ahop'. The Sports the Non-White loved best-Football and Cricket is in a chaotic state. No Provincial status for Players let alone Internationals.

The cry at International Headquarters today is not 'Intergration in Sport' but 'No recognition of S.A. Sport until Races are equally treated in South Africa.' Possibly reports are misread.

What will the Lenasia Football Association do in the future? Can the L.F.A. solve and save Lenasia Football? **AND** the controversy surrounding Ownership, control and use of the Lenasia Stadium??? Quotation from Soccer brochure:—

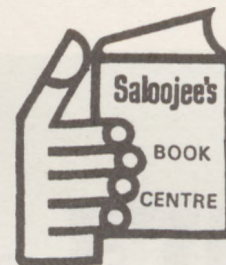
