BANTU EDUCATION: WHAT IT IS.

DO YOU WISH TO KNOW THE AIMS OF BANTU EDUCATION? READ WHAT ITS ARCHITECTS SAY ABOUT IT.

1. Dr. Verwoerd says: "The aim of Bantu Education is to teach the African child from infancy to know that it is not the equal of the white man."
2. Dr. Eiselen says: The education that is given to the African today enables him to compare his civilisation with superior civilisations and thereafter to despise his own traditions.
3. Other Boer politician says: "History and Geography are of no use to the African and they should therefore be removed from the syllabus."

SO

1. Qualified teachers are being eliminated and STD V1 girls employed in their place.
2. There are to be no examinations; the children will be pushed forward until they reach STD 11.
3. Sub STDs A and B attend school for 2½ hours only instead of 5 hours.
4. History and Geography have been removed from the syllabus and will be taught after the children have passed STD 11.
5. African children will learn about their own tradition only and not about greater civilisations.
6. A child who fails STD 11 will only be readmitted at the pleasure of the school inspector. If the inspector is unwilling to readmit it, then it must remain on the streets or go to farms to work for the farmers.
7. Children whose parents are poor and cannot afford to buy all the school books, will be sent away to make room for the child of the rich parent.
8. All male teachers will be eliminated from the schools and women employed in their place.
