

End Conscription Campaign Diary 1989

ECC Diaries have been produced for the last two years. Unfortunately, the 1987 diary was seized by the police while it was at the printers. However, the 1988 diary was successfully produced after appropriate security measures were introduced.

Aims:

- * raise ECC's profile
- * raise money for ECC

Content

The diary will reflect key days in the struggle against SADF militarisation as well as the various days of SADF aggression. It will also include the significant dates in the South African Liberation Struggle.

The introduction will explain the nature of ECC as well as its programme of action for 1989. Facts and figures relating to militarisation will also be included as will suitable graphics and photographs.

Distribution

The diary will be commercially distributed as well as by ECC branches and through ECC networks.

Timing

The diary will be ready for distribution by the beginning of October.

Budget

As stated on the budget the diary will be sold for R3 per copy. However, from past experience the income is slow and often only comes in in the middle of the year.

The amount of R23 520 requested is the initial capital outlay and an amount so high will not be required in the future, as incoming money from sales of the diary will be pooled to finance the following years diary.

Dear Friend

The End Conscription Committee (E.C.C.) is a broad front of organisations which have come together to oppose compulsory conscription into the South African Defence Force. The campaign is being waged nationally and aims to raise awareness of the militarisation of our society and to unite and mobilise as broad a sector of the population as possible. A brief history of the campaign is enclosed.

Young people are most directly affected by conscription. They are often antagonistic to the S.A.D.F. and its role in defending Apartheid. They are therefore potentially open to the message of E.C.C.

E.C.C. has decided to prioritise the International Youth Year campaign in 1985. In particular it is aiming to give a strong anti-conscription content to the "peace" theme. E.C.C. is taking up the I.Y.Y. campaign in two ways: firstly, through the organisation of the youth constituency against conscription and secondly, by participating in other I.Y.Y. structures. Presently E.C.C. is represented on the I.Y.Y. committees of both the United Democratic Front and the South African Council of Churches. The Western Cape E.C.C.'s plans for Youth Year are enclosed.

We would greatly appreciate any assistance you might give us, in particular any resources. Anything received from you will be circulated to our branches in Johannesburg and Durban.

We are also currently trying to raise finances through overseas agencies. Once again, any assistance which you could give would be appreciated. A budget application is attached.

We look forward to working with you in the I.Y.Y. campaign and in the worldwide struggle against Apartheid.
