BUILDING

The Hospital is situated in the Mafeking Stad, Native Reserve, on a site granted by the Native Affairs Department. It was erected in 1929. It is housed in a building 20' x 100' with verandahs facing North and West. It contains a Consultation room, Theatre, Nurses' quarters, Bathroom, two wards for men and two for women. There is no separate kitchen or laundry. The work is being done in the domestic department of the Mission. There is no electric light. Water supply is excellent and abundant. The building is insured against fire.

Medical Superintendant Dr. Josef Roos. Sister Cyrilla Reiter (Acting Matron), Sister Adelgunde Glonegger, Nurse Elizabeth Jafta.

MEDICAL.

Indoor patients 60 male, 55 female, total 115, with 2350 days of treatment; average number of patients per day 6.4.

Outdoor patients 247 treated at their homes, 2053 calling at the Hospital with a total of 3332 consultations.

Miscellaneous: Deaths at the Hospital 5; subsequent to treatment 12; Maternity cases 8; Denomination of patients 9.4 % R.C.; 90.6 % non-Catholic. Applicants from the Protectorate 218. Minor operations 41.

FINANCIAL.

Indoor patients' charge per day Adults 1/-, Children 6d. Free medicine issued 357 cases; days of free treatment of indoor patients ca 600.
