Leresche of the Swiss Mission last week and as Mrs. E. O. Leake makes a special request to me to allow the use of the Hall to the Swiss Mission I feel that this application should not be refused. On the whole, since the building is used as a creche during the week it would be better not to use it for Sunday services but the plan can be tried for six months in the hope that the Municipality may by that time be able to allot land to the Churches not provided for.

It is possible that next year it will be taken over as a Domestic Centre for Wayfarers, but even then it is unlikely that it could be used for Church on Sundays.

I have two other Churches which applied before you for the Sunday use of the Hall so that even if it could be so used I should have to give them first chance so I am afraid I can hold out no hopes to you.

I am sorry for I realise how difficult it must be for you to have no place of worship, but as Mr. Leake gave the hall for the use of the Scouts and Wayfarers and I have to administer it for them.
