

In July 1984 the unarmed community of Tumahole peacefully demonstrated their inability to pay high rents. The response of this government was violent.

In September 1984 the peace-loving people of the Vaal Triangle arpressed their inability to pay high rents. They met with violence from the South African police.

In February 1985 when the community of Grossroads demonstrated their oppe osition to forced removal to Khayali= tsha, 18 people were brutally moved down by the police.

The continued detention of sixteen of our people is no suggestion of change, it is a clear indication of this government to suppress legi= mate opposition to its brutal system and justifying it with what it calls treason. Their continued incarceration and that of other poli= tical detainees, e.g. Cde Bushy Maape (UDF N.Cape Secretary), shall not deter us from continuing our struggle for freedom and justice. We think P.W. Botha and his colleagues deserve to be charged with treason. By throttling attempts to liberate ourselves is an act of treason in itself.
